### **ALTERNATIVES TO EMERGENCY DEPARTMENTS (EDS)**

- Designed for people experiencing mental health and substance use crises.
- Set the goal of reducing police involvement and enhancing access to urgent community-based supports.
- Have been implemented in collaboration with Designated Agencies (DAs), the Burlington Police Department (BPD), and various other healthcare providers.
- Serve Vermonters in need of a crisis response regardless of age, diagnosis, or insurance coverage.



### SUSTAINABILITY FUNDING PLAN FOR ALTERNATIVES TO EDS

- Federal funding runs through March 31, 2025.
- The House's One-Time General Fund Appropriation of \$482,789 is intended to backfill the previously projected beginning in SFY25 Q4 (or April 1 June 30).
- AHS believes that federal funding is likely to be extended and would be sufficient to cover all of FY 25.
- Grantees are required to have a sustainability plan, which may include transitioning to Medicaid-billable services or other sources if they intend on continuing beyond the initial pilot and the program operates successfully.

## DA/SSA HOUSE APPROPRIATIONS: \$1.1m FOR CRISIS MANAGEMENT

- The House Passed Budget contained a Global Commitment investment of \$1.1M to DA/SSAs for "crisis management."
- The General Assembly's intent to use it for crisis management or the continuum of care is not immediately clear to DMH how this could be operationalized.
- It is also not clear that the intent would be eligible for Global Commitment funding.

#### **OVERVIEW OF ALTERNATIVES TO EDS**

- 1. **BPD CARES Program**: This initiative under BPD and DMH started in June 2023, focusing on Crisis, Assessment, Response, and Engagement Services. It faced initial recruitment challenges but is progressing towards service delivery with a clinical supervisor and the recruitment of clinicians and nurses for teamed services, anticipating full operation by June 2024.
- 2. Washington County Mental Health Services Access Hub: A living-room model program operational since October 2023, offering a welcoming environment for urgent mental health support from Monday to Thursday. It shows success in diverting individuals from EDs and law enforcement to community-based services.
- 3. Counseling Service of Addison County Interlude Program: Another living-room model, providing care since January 2023 and reaching full service in July. It operates weekdays, assisting individuals with acute mental health symptoms through short-term follow-up and wrapped service care.
- 4. Northeast Kingdom Human Services Front Porch Program: Set to start in April 2024, this program will offer comprehensive crisis service delivery in a living-room model, aiming for full operational status by October 2024.
- 5. Howard Center Mental Health Urgent Care Program: In final negotiation stages, this program aims to begin between May 1 and May 15, 2024, focusing on urgent mental health care through collaborative efforts in Burlington.



#### YOUTH-FOCUSED ALTERNATIVES TO EDS

- United Counseling Services Psychiatric Urgent Care for Kids (PUCK) Program: Offers intensive day-treatment for youth, involving clinical assessment and skill-building, operational Monday to Friday and serving youth aged 0-18.
- **Health Care and Rehabilitation Services Youth Stabilization Program (YSP)**: A high-intensity outpatient program in Brattleboro providing intensive support to help youth stay in their natural environments, offering a range of therapeutic services.
- Lamoille County Mental Health Emergent Psychiatric Intervention for Children (EPIC) Program: Similar to PUCK, providing intensive day-treatment and support for youth aged 6-18, focusing on developing coping skills and comprehensive treatment plans.
