# FY 23 Budget Adjustment Act: ESSER Language

#### What is the request?

New language added to Act 185 (the FY 23 Budget Bill) to give the AOE the ability to reconcile programs appropriated by the Legislature since 2021 and repurpose them to other or new programs that align with the priorities already identified by the Legislature.



#### **Proposed Language**

Sec. XX 2022 Acts and Resolves No. 185, Sec. E.501.1 is added to read: Sec. E.501.1 EDUCATION RECOVERY AND REVITALIZATION

(a) The Agency of Education may adjust any of the allocations concerning ESSER II and ARP ESSER state set aside funds made in Acts 9, 67, 72, and 74 of 2021 and Acts 28, 83, 112, 166 and 185 of 2022 during the final reconciliation process to ensure the entirety of the federal awards are expended. The Agency of Education shall provide a final reconciliation report to the Joint Fiscal Committee on the reallocation of these funds in October 2023 and October 2024.



# Proposed Language (continued)

EXPLANATION: Through a series of legislative actions, all ESSER II and ARP ESSER state set aside funds have been fully allocated. As grant programs, contracts and administrative costs are reconciled, the Agency of Education requires additional flexibility to ensure that all funds can be expended by the end of the funding periods.



# Proposed Language (continued)

- Requires transparent reporting by AOE to JFC in October 2023 and 2024.
- Gives the AOE the ability to measure impact and invest in what is working.
- Prevents reversion of funds to federal government.
- Early estimates of \$3 million (this is dependent on multiple contracts that have not been finalized)



# Status Update on ESSER II and ARP ESSER Set Aside Initiatives (January 30, 2023)

8 live grant programs. Two of those are through Vermont Afterschool using ESSER II funds (end 9/30/2023).

12 live or planned contracts. All using ARP ESSER funds (end 9/30/2024).

All ESSER II funds are fully budgeted.

All but \$365,000 in ARP ESSER funds are fully budgeted.








