11	(a) Creation. There is created the State Board of Education Compensation
12	and Staffing Study Committee to examine, evaluate, and report on the
13	compensation and staffing needs of the State Board of Education.
14	(b) Membership. The Committee shall be composed of the following
15	members:
16	(1) one current member of the House of Representatives, who shall be
17	appointed by the Speaker of the House;
18	(2) one current member of the Senate, who shall be appointed by the
19	Committee on Committees;
20	(3) the Secretary of Education or designee, who shall serve as co-chair;

1	(4) the Chair of the State Board of Education or designee, who shall
2	serve as co-chair;
3	(5) the Executive Director of Racial Equity or designee;

7	or designee;
8	(8) the Executive Director of the Vermont School Boards Association or

12	(c) Powers and duties. The Committee shall evaluate the compensation and
13	staffing structure of the State Board of Education, including the following
14	issues:

11	(h) Appropriation. The sum of \$ 1.00 is appropriated to the Agency of
12	Education from the General Fund in fiscal year 2024 for per diem
13	compensation and reimbursement of expenses for members of the Committee.

15	Sec. 2. CURRICULUM AUDIT; REPORT
16	(a) Curriculum audit. All Vermont children are entitled to substantially
17	equal educational opportunities. In order to better understand the breadth of
18	course offerings and curriculum differences across the State, the Agency of
19	Education shall contract with an independent third party to conduct and report
20	on a curriculum audit of at least four supervisory unions or supervisory
21	districts, all of which shall have a high percentage of students who are

1	approved for free and reduced-price school meals. On or before January 15,
2	2024, the Agency shall submit a copy of the report to the House and Senate
3	Committees on Education.
4	(b) Appropriation. The sum of \$200,000.00 is appropriated from the
5	General Fund to the Agency of Education in fiscal year 2024 for the purpose of
6	contracting with an independent third party to conduct a curriculum audit as
7	described in subsection (a) of this section.
8	Sec. 3. PROFICIENCY-BASED LEARNING; STUDY COMMITTEE
9	(a) Creation. There is created the Proficiency-Based Learning Study
10	Committee to study proficiency-based learning and proficiency-based
11	graduation requirements as they are used in Vermont, as required by the
12	Agency of Education, Education Quality Standards (CVR 22-000-003), and to
13	make recommendations for whether proficiency-based learning is the most
14	effective way to ensure Vermont students attain rigorous standards in high-
15	quality programs or whether there are other systems of instruction, assessment,
16	grading, and academic reporting that would better serve Vermont students.
17	(b) Membership. The Committee shall be composed of the following
18	members:
19	(1) the Secretary of Education or designee;
20	(2) the Chair of the State Board of Education or designee;

1	(3) the Executive Director of the Vermont Principals' Association or
2	designee;
3	(4) the Executive Director of the Vermont Superintendents Association
4	or designee;
5	(5) the Executive Director of the Vermont School Boards Association or

4	written report to House and Senate Committees on Education with its findings

6	(f) Meetings.

1	In order to increase high-quality prekindergarten education opportunities for
2	students that live in school districts on the Vermont border, the Agency of
3	Education shall evaluate public and private prekindergarten education
4	standards and regulations in New Hampshire, Massachusetts, and New York
5	and determine if those standards and regulations are substantially aligned with
6	the Vermont Early Learning Standards. The Agency shall also evaluate other
7	Vermont prequalification standards that may prevent a public or private
8	prekindergarten education program in these states from prequalification in
9	Vermont and determine if state regulations and oversight in those areas are
10	also substantially aligned with Vermont regulations. On or before January 15,
11	2024, the Agency shall issue a written report to the Senate and House

11	(E) Staff. The Working Group may study staffing levels at Vermont
12	libraries, whether staffing levels are sufficient to meet community needs,

15	development and training of library staff.
16	(d) Public input. As part of the study and report, the Working Group shall
17	solicit feedback from the general public and library users around the State.

1	(e) Data to be used. The data used in the analysis of library services and
2	operations may be from 2019, prior to the COVID-19 pandemic.
3	Postpandemic data may also be used to assess the status of library services and
4	operations.
5	(f) Consultation with the Board of Libraries. The Working Group may
6	solicit feedback from the Board of Libraries.
7	(g) Assistance. The Working Group shall have the administrative,
8	technical, and legal assistance of the Department of Libraries.
9	(h) Report. On or before November 1, 2023, the Working Group shall
10	submit a report to the House and Senate Committees on Education. The report

19	Sec. 7. REGIONAL STUDENT DRIVER EDUCATION CLINICS; PILOT

1	(a) Pilot program. On or before December 15, 2023, the Agency of
2	Education and the Department of Motor Vehicles, in partnership with
3	interested school districts, shall establish a regional pilot student driver clinic
4	program to provide the required minimum 6 hours of behind-the-wheel
5	instruction by a certified driver education instructor as required by State Board
6	of Education rule.
7	(1) The Agency and Department shall appoint one or more certified
8	driver education instructors who shall assist in the development of the model
9	program.
10	(2) The pilot program shall be designed to be implemented on a regional
11	level, with an adequate number of programs provided to meet the reasonably
12	anticipated needs of all public and approved independent schools participating
13	in the pilot program. The Agency and Department shall partner with
14	participating school districts to define regions.
15	(3) The pilot program shall meet all legal requirements of student driver
16	education and training programs.
17	(4) The Agency and Department shall adopt policies, procedures, and
18	guidelines necessary to implement the pilot program.
19	(b) Implementation. Regional pilot programs developed in accordance
20	with the model program created under subsection (a) of this section shall begin
21	offering student driver clinics on or before July 15, 2024.

1	(c) Appropriation. Notwithstanding 16 V.S.A. § 4125(d), the sum of
2	\$200,000.00 is appropriated from the Education Fund to the Agency of
3	Education in fiscal year 2024 for the purpose of developing a model regional
4	student driver clinic program. Prior to using the funds appropriated under this
5	subsection, the Agency shall consult with the Vermont State Highway Safety
6	Office on whether the student driver clinic program created pursuant to this
7	section is eligible for federal highway safety grant funds.
