1	TO THE HONORABLE SENATE:
2	The Committee on Education to which was referred Senate Bill No. 303
3	entitled "An act relating to supporting Vermont's young readers" respectfully
4	reports that it has considered the same and recommends that the bill be
5	amended by striking out all after the enacting clause and inserting in lieu
6	thereof the following:
7	* * * Literacy * * *
8	Sec. 1. FINDINGS
9	The General Assembly finds that:
10	(1) Literacy, particularly in early grades, is critical for success in future
11	education, work, and life.
12	(2) Roughly half of Vermont students are still at or below proficiency.
13	(3) Research in recent years is clear. We know how to teach reading in
14	a proven, evidence-based manner. Yet outdated practices linger in classrooms
15	and in educator preparation programs.
16	Sec. 2. 16 V.S.A. § 1710 is added to read:
17	§ 1710. MANDATORY COMPLETION OF LITERACY MODULES
18	(a) On or before January 1, 2026, all professionally licensed Vermont
19	educators, as defined in subdivision 1691a(3) of this chapter, employed in a
20	Vermont school shall complete a program of professional learning on

1	evidence-based literacy instruction developed and offered or approved by the
2	Vermont Agency of Education.
3	(b) After January 1, 2025, all newly licensed Vermont educators employed
4	in a Vermont school shall complete a program of professional learning on
5	evidenced-based literacy instruction developed and offered or approved by the
6	Agency before the end of the educator's second year of teaching.
7	(c) Vermont public and approved independent schools that employ
8	professionally licensed Vermont educators shall collect and maintain on file a
9	record of completion of the literacy professional learning required under this
10	section. The Agency shall provide a format for recordkeeping, including use
11	of the State licensing system as appropriate.
12	(d) Educators shall provide evidence of completion of the literacy
13	professional learning required under this section upon the educator's next
14	license renewal.
15	Sec. 3. LITERACY PROFESSIONAL LEARNING REQUIREMENTS;
16	AGENCY OF EDUCATION LIST
17	On or before September 1, 2024, the Agency of Education shall develop
18	and distribute a list of literacy professional learning requirements specific to
19	each licensing endorsement.

1	Sec. 4. RESULTS ORIENTED PROGRAM APPROVAL
2	(a) On or before July 1, 2025, the Agency of Education shall submit
3	recommendations to the Vermont Standards Board for Professional Educators
4	on how to strengthen educator preparation programs' teaching of evidence-
5	based literacy practices. The Agency shall also simultaneously communicate
6	its recommendations to Vermont's educator preparation programs.
7	(b) On or before July 1, 2026, the Vermont Standards Board for
8	Professional Educators shall consider the Agency's recommendations pursuant
9	to subsection (a) of this section and, as appropriate, update the educator
10	preparation requirements in Agency of Education, Licensing of Educators and
11	the Preparation of Educational Professionals (5000) (CVR 022-000-010).
12	(c) As part of its review under subsection (a) of this section, the Agency
13	shall make recommendations to the Vermont Standards Board for Professional
14	Educators regarding whether an additional mandatory examination is needed to
15	assess candidates for educator licensure skills in mathematics and English
16	language arts fundamentals, as well as candidates' understanding of the
17	importance of evidence-based approaches to literacy and numeracy, beyond
18	the requirements in Agency of Education, Licensing of Educators and the
19	Preparation of Educational Professionals (5000) (CVR 022-000-010) in effect
20	during the period of the Agency's review.

2	§ 2903a. ADVISORY COUNCIL ON LITERACY
3	(a) Creation. There is created the Advisory Council on Literacy. The
4	Council shall advise the Agency of Education, the State Board of Education,
5	and the General Assembly on how to improve proficiency outcomes in literacy
6	for students in prekindergarten through grade 12 and how to sustain those
7	outcomes.
8	(b) Membership. The Council shall be composed of the following $\frac{16}{18}$
9	members:
10	(1) eight members who shall serve as ex officio members:
11	(A) the Secretary of Education or designee;
12	(B) a member of the Standards Board for Professional Educators who
13	is knowledgeable in licensing requirements for teaching literacy, appointed by
14	the Standards Board;
15	(C) the Executive Director of the Vermont Superintendents
16	Association or designee;
17	(D) the Executive Director of the Vermont School Boards
18	Association or designee;

10	(B) three teachers, appointed by the Vermont-National Education	
11	Association who teach literacy, one of whom shall be a special education	
12	literacy teacher and two of whom shall teach literacy to students in

15	proficiency or supported others who have struggled with literacy proficiency,

7	(d) Powers and duties. The Council shall advise the Agency Secretary of	
8	Education, the State Board of Education, and the General Assembly on how to

11	(1) advise the Agency of Education Secretary on how to:	
12	(A) update section 2903 of this title;	
13	(B) implement the statewide literacy plan required by section 2903 of	
14	this title and whether, based on its implementation, changes should be made to

13	CHAPTER 135. VERMONT IMAGINATION LIBRARY	
14	§ 4201. VERMONT IMAGINATION LIBRARY; PILOT; CREATION	
15	(a) Duties of Agency. The Agency of Education shall:	
16	(1) coordinate with Dolly Parton's Imagination Library (DPIL) to ensure	
17	statewide access to the Vermont Imagination Library program;	
18	(2) manage the daily operations of the Vermont Imagination Library	
19	program and provide oversight of the Imagination Library Special Fund,	
20	including establishing library-based programs in each county, communicating	

1	with and coordinating any volunteers at local and school libraries, and
2	advancing and strengthening the program to ensure enrollment growth;
3	(3) develop, promote, and coordinate a public awareness program

I	(f) Failure to appropriate funds. If the General Assembly does not

12	(2) Repeal of pilot. Every three years, the Agency shall include in its

16	(a) There is established the Imagination Library Special Fund, which shall

18	funding for the Vermont Imagination Library shall be deposited and credited to	
19	this Fund. This Fund shall be available to the Agency to administer the	
20	Vermont Imagination Library pursuant to section 4201 of this chapter. Monies	

1	in the Fund shall be used solely for purposes of the Fund and for necessary
2	costs incurred in administering the Fund.
3	(b) The Agency may accept gifts, donations, and grants from any source,
4	public or private, to be dedicated for deposit into the Fund.

6	The sum of \$100,000.00 is appropriated from the General Fund to the
7	Imagination Library Special Fund in fiscal year 2025 for the purpose of
8	establishing the Vermont Imagination Library.
9	Sec. 9. REPEAL
10	16 V.S.A. chapter 135 shall be repealed on July 1, 2027.

13	This act shall take effect on passage.
