## Dear Chair Hardy:

Thank you for your email about H.482 and inquiring whether and how the bill relates to Department of Public Safety work in progress.

I am a Policy and Training Consultant with the Department of Public Safety (DPS) and I am replying to your email on behalf of DPS.

DPS is involved in ongoing work that overlaps with H.482. Specifically, we are preparing reports requested by the legislature pursuant to  $\underline{2022 \text{ Act } 161}$  (S.250) and  $\underline{2022 \text{ Act } 106}$  (H.635)

There is nothing in H.482 that conflicts with our ongoing work or preliminary recommendations. However, any additional legislative directive would be redundant to the work already well underway, the results of which the legislature will receive in a few months.

Thank you for inviting DPS to testify. At this time, DPS does not think live witness testimony is necessary.

Below you will find additional information about the Department's work on 2022 Act 161 (S.250) and 2022 Act 106 (H.635).

## **2022 Act 161** (S.250)

<u>2022 Act 161</u>, section 1a (S.250) requires the Department of Public Safety to submit a report on or before November 1, 2023, to the House and Senate Committees on Government Operations and the Judiciary, and the Executive Director of Racial Equity, concerning the ability of law enforcement agencies to collect data during law enforcement encounters.

The report is required to specify the following:

- 1. The data currently collected, including law enforcement's capabilities and methods of collection;
- 2. Any suggested data collection criteria;
- 3. Any impediments to collecting data;
- 4. Proposed remedies to resolve any impediments; and
- 5. A recommended definition of "law enforcement encounter."

Last summer, the Department of Public Safety convened a working group to assist in the preparation of the report. Those invited to participate included:

The work group has met regularly since July 2022. The work group has also consulted with academicians, a law enforcement agency chief, the National Policing Institute, and the research director at Colorado's Department of Public Safety.

The work group has had extensive and rich discussions about the challenges and drawbacks of collecting race and gender data (whether actual or perceived) and has arrived at some preliminary recommendations in this regard. The work group has also agreed to some preliminary recommendations about roadside data collection criteria.

## **2022** Act **106** (H.635)

<u>2022 Act 106</u> (H.635) requires the Executive Director of Racial Equity, the Commissioner of Motor Vehicles, and the Commissioner of Public Safety to jointly examine all motor vehicle violations for the purpose of making recommendations on whether or not statutes should be repealed, modified, or limited to secondary enforcement. The Executive Director and Commissioners jointly provided an interim report to the House and Senate Committees on Judiciary and on Transportation on January 15, 2023. A final written report is due to the committees on or before October 1, 2023.

A complete review of motor vehicle violations has been conducted and future recommendations submitted will focus on traffic statute, gender neutral language, and community engagement opportunities.

The Department of Public Safety convened a working group on June 17, 2022, to facilitate the review of motor vehicle violations in preparation of the required report. The working group has met bi-weekly to provide recommendations on Title 23 motor vehicle violations to repeal, modify, or limit to secondary enforcement. The Judicial Bureau Waiver Penalties guided the review of all statutes. The working group has identified 35 recommendations for consideration. Members invited to participated included:
