- (2) The Commission shall, on or before January October 15, 2026, make a draft of the final report publicly available and provide copies of the draft to interested parties from the populations and communities identified pursuant to subdivision 902(b)(1) of this chapter and other interested parties. The Commission shall provide the interested parties and members of the public with not less than 60 days to review the draft and provide comments on it. 10	bodily injury to themselves or others or damage to the property of themselves
11	or another person; and
12	(B) is made to law enforcement authorities or another person that is
13	reasonably able to prevent or lessen the threat.
14	(2) The disclosure is based on a reasonable suspicion of abuse or neglect
15	of a child or vulnerable adult and a report is made in accordance with the
16	provisions of 33 V.S.A. § 4914 or 6903 or to comply with another law.
17	(e) The Commission shall ensure that all participants in a group session are
18	provided with notice of the provisions of this section, including any rights and
19	obligations of participants that are established pursuant to this section.
20	(f) As used in this section, "group session" means any meeting of a group
21	established pursuant to subdivision 906(b)(13) of this chapter for purposes of

1	the participants sharing or discussing their experiences and providing mutual
2	support. "Group session" does not include any gathering of the participants in
3	a group established pursuant to subdivision 906(b)(13) of this chapter that
