7	quorum, and actions of the Panel may be authorized by a majority of the
8	members present and voting at a meeting of the Panel.
9	(f) Members of the Panel who are not otherwise compensated by the State
10	shall be entitled to per diem compensation and reimbursement of expenses
11	pursuant to 32 V.S.A. § 1010 for not more than 20 meetings during fiscal year
