relying on location data otherwise contained in the ALI database shall provide
this data with calls or transmissions for the sole purpose of enabling the

6	(a) Program established. There is established the Continuing Local
7	Economic Damage Grant Program to provide support to municipalities that
8	were impacted by the August 2023 or December 2023 flooding events, or both,
9	and are located in counties that are eligible for Federal Emergency
10	Management Agency (FEMA) Public Assistance funds under federal disaster
11	declarations. It is the intent of the General Assembly that the Continuing
12	Local Economic Damage Grants be distributed to municipalities throughout
13	the State to address the secondary economic impacts of the August and
14	December 2023 flooding events.
15	(b) Appropriation. In fiscal year 2025, the amount of \$200,000.00 is
16	appropriated from the General Fund to the Agency of Administration for the
17	Continuing Local Economic Damage Grant Program.
18	(c) Administration; grant awards. The Agency of Administration shall
19	administer the Program, which shall award grants in the following manner:

1	(1) \$75,000.00 to each municipality that as of March 1, 2024 had
2	\$5,000,000.00 or more in estimated reported damages to public infrastructure
3	relating to the August 2023 or December 2023 flooding events, or both;
4	(2) \$50,000.00 to each municipality that as of March 1, 2024 had
5	\$2,000,000.00 or more but less than \$5,000,000.00 in estimated reported
6	damages to public infrastructure relating to the August 2023 or December 2023
7	flooding events, or both;
8	(3) \$30,000.00 to each municipality that as of March 1, 2024 had
9	\$1,000,000.00 or more but less than \$2,000,000.00 in estimated reported
10	damages to public infrastructure relating to the August 2023 or December 2023
11	flooding events, or both;
12	(4) \$20,000.00 to each municipality that as of March 1, 2024 had
13	\$250,000.00 or more but less than \$1,000,000.00 in estimated reported
14	damages to public infrastructure relating to the August 2023 or December 2023
15	flooding events, or both; and
16	(5) \$10,000.00 to each municipality that as of March 1, 2024 had
17	\$100,000.00 or more but less than \$250,000.00 in estimated reported damages
18	to public infrastructure relating to the August 2023 or December 2023 flooding
19	events, or both

1	(d) Restrictions on recipients' use of grant funds. Monies from grants
2	awarded through the Program shall not be expended by the recipient on
3	FEMA-related projects.
4	(e) To the extent that the funds appropriated in subsection (b) of this
5	section have not been granted by June 30, 2025, the funds shall revert to the
6	General Fund and be transferred to the Emergency Relief and Assistance Fund
7	<u>(21555).</u>
8	Sec. 37. EMERGENCY RELIEF AND ASSISTANCE FUND
9	FOR RECOVERY FROM THE AUGUST AND DECEMBER 2023
10	FLOODS; TRANSFER
11	(a) Notwithstanding any other provisions of law to the contrary,
12	\$830,000.00 shall be transferred from the General Fund to the Emergency
13	Relief and Assistance Fund (21555).
14	(b) Notwithstanding Sec. 1.4.3 of the Rules for State Matching Funds
15	Under the Federal Public Assistance Program, in fiscal year 2025, the
16	Secretary of Administration may provide funding from the Emergency Relief
17	and Assistance Fund that was transferred pursuant to subsection (a) of
18	this section to subgrantees prior to the completion of a project. In fiscal year
19	2025, up to 70 percent of the State funding match on the nonfederal share of
20	an approved project for municipalities that were impacted by the August and
21	December 2023 flooding events in counties that are eligible for Federal

1	Emergency Management Agency Public Assistance funds under federal
2	disaster declarations may be advanced at the request of a municipality.
3	(c) Notwithstanding Sec. 1.4.1 of the Rules for State Matching Funds
4	Under the Federal Public Assistance Program, the Secretary of Administration
5	shall increase the standard State funding match on the nonfederal share of an
6	approved project to the highest percentage possible given available funding for
7	municipalities in counties that were impacted by the August and December
8	2023 flooding events and are eligible for Federal Emergency Management
9	Agency Public Assistance funds under federal disaster declarations.
