


\*Managed and implemented by Vermont Emergency Management Hazard Mitigation Grant Program (HMGP) (\$75 million anticipated)


#### Program Purpose:

Improving landscape and community resilience and reducing the future public safety and water quality impacts of climate-related flood hazards in Vermont.

\$5,000,000 ARPA allocation in FY2022

\$8,000,000 General Fund allocation in FY2023

\$15,000,000 ARPA allocation in FY2023




### Eligible Projects

- Flood-vulnerable structure and buyout projects
- Vacant at-risk parcel buyout/conservation
- Natural resource projects to improve floodplain access/function
- Project scoping, planning, education and outreach initiatives



### Flood Resilient Communities Fund Selected Projects

\$18.9 million obligated as of December 2023 (out of \$19.6 million in program funds)



#### **Obligated Projects:**

- 35 individual property buyouts
- 12 floodplain restoration and planting projects
- 1 infrastructure/community flood reduction project
- 12 scoping/planning projects

\$835,008.50 obligated to planning & scoping

\$1,114,654.42 obligated to infrastructure upsizing

\$3,383,447.54 obligated to floodplain restoration & plantings

\$13,304,805.40 obligated to property buyouts


### Inundation vs. Erosion Flooding:
