7	chapter 57 to determine the appropriate form of regulation for the profession.	
8	For purposes of this review, and in accordance with 26 V.S.A. § 3105(b), the	
9	General Assembly finds that it is necessary for the State to regulate doulas.	
10	(b) On or before January 8, 2025, the Office of Professional Regulation	
11	shall report the results of the review required by subsection (a) of this section
