## VCP Network Responsive to Community Needs

- Home visiting nurses identify high rates of families experiencing postpartum depression
- Call on the local DA to help with this community issue
- Program begins with one home visiting perinatal mental health clinician
- Agency expands program to push upstream and intervene early
- Agency creates HEART to HEART (Abenaki peer expansion)





### Supporting:

- Better birth outcomes
- Mitigating risk/impact of perinatal depression and related disorders
- Early relational health
- Parent/child attachment and bonding which supports child development
- Connection to basic needs
- Culturally congruent care
- All Vermonters including the most vulnerable




# Universal Doula Supports for Franklin/Grand Isle

(Northwestern Counseling & Support Services – Parent Child Center)

- 3 perinatal doulas
- Overnight doula high risk families
- Perinatal MH clinicians
- Rounds at the local hospital
- SDOH supports
- Groups
- Perinatal grief/loss supports
- Abenaki peer to peer program



# Quick Outcomes FY23



### 126 families referred

#### 101 families served

99% screened for postpartum depression (Edinburgh Postnatal Scale)

95% of families improved after being in the program (Edinburgh Postnatal Scale)

"I wish this program was accessible in all of Vermont." – HEART participant

"I really appreciate this program and the help I was afforded. I'm so thankful it exists." – HEART participant



# **Funding and Limitations**

### <u>Funding</u>

- Parent Child Center funding
- Integrating Family Services (clinicians only)
- STAMPP (professional development and supplies only)
- Health Equity Grant (VDH)

#### **Barriers**

- Most program components are non-billable creating a sustainability concern for the program
- Unable to add labor/delivery component of the program
- Unable to expand services



## **VCP** Request

- Please support this vital service by limiting provisions that prevent doulas from providing needed preventative and early intervention care
- Please ensure that barriers are removed to allow the greatest access possible for these vital services (e.g., language access)
- Bill language that supports community-based providers in continuing to provide and sustain services for the most vulnerable populations (e.g., equitable reimbursement rates, reimbursement for labor/delivery support)
