Pursuant to 3 V.S.A. § 3090(e), please find attached summaries of appeals filed with the HSB for calendar years 2020, 2021 and 2022. In addition, we report the following general information:

While the attached information is only partially responsive to the requirements of the statute, this represents the limits of our reporting capability based on a legacy database we had been using since around 1990. However, with the support of the Agency of Human Services and Agency of Digital Services, we transitioned to a new case management system as of October 23, 2020, and have provided more detailed reporting for CY2021 and CY 2022.

Please note that the numbers for 2021 and 2022 include 3SquaresVT "Intentional Program Violation" hearing requests from the Department for Children and Families, cases that the Board's

hearing officers hear by arrangement with the Department and that are not covered by the Board's jurisdictional statute. In addition, the outcomes reported for CY2021 and CY2022 include only what we would consider "substantive" outcomes, typically either a Board order or some other resolution (short of a Board order) which was understood to be in favor of one of the parties.<sup>1</sup>


