




Within Developed Areas of State Parks Outside Developed Areas of State Parks Clean Water – ANR Lands




VALUE OF STRUCTURES (JUST STRUCTURES)




SQUARE FOOTAGE OF STRUCTURES (JUST STRUCTURES)







- Ditch relief culverts
- Ditch disconnection culverts
- Armoring culvert outlets
- Correctly sizing structures
- Re-crowning & grading the road surface & shoulders
- Installing new road surface material
