THERE is no evidence that regarding the stalking, false imprisonment, home invasion, serial abuse, beating, and rape, of Kali May Peer's mother, Grace Michele Peer, which was duly reported to Thetford Police, Vermont State Police, and Orange County State's Attorney, from 1/2014 to 5/2014, that Law Enforcement ever

1. **Assessed whether Kali was physically present.**
2. **Assessed whether Kali was physically harmed.**
3. **Minimized the impact and repercussions to Kali.**
4. **Empowered Kali in the process.**
5. **Maintained Kali's safety; or**
6. **Maintained batterer accountability.**

1. In 2014 Kali was 14 years old.
2. In 2017 Kali had the first of 5 or more (to date) involuntary hospitalizations, 5 or more at Greater Binghamton Health Center, NY & 1 briefly in VT, for schizoaffective disorder prompted by cptsd (complex post-traumatic stress disorder).
3. Since 2017 Kali has called 911 over 2 dozen times.
4. The 911 calls are always the same: "My mother is being held prisoner and being beaten and raped."

5. When not hospitalized or in out-patient transition, heavily medicated, Kali, in the

psychotic throes of her trauma, often finds herself homeless, on the streets, reliving the assaults of 2014 of Thetford Vermont.

6. Kali's trauma is a profound testimony that, at the scene(s) of violence in 2014, she was

1. On 01/30/14 Grace Michele Peer, Kali's mother, was assaulted (VSP incident report #

14B300209) by an individual who entered the home of the Peers at will, without the consent of the Peers, and had been entering the home since 1/4/14, if not earlier. That morning, after assaulting Grace Michele, the individual, by force of threat of harm, demanded Kali get in his vehicle. This coercion by this individual of Kali had been going on for some time.

2. This individual was involved in the assault of Grace Michele on 1/4/14, or thereabout, as

documented in the Wolcott report with photographic exhibits.

3. This individual was a notorious member of the Thetford Community.

4. Law Enforcement's response to the report of Grace Michele Peer's assault on 1/30/14

required Thetford Academy, where Kali was a student, to "shelter in place".

5. On 01/30/14, VSP Troopers Schulze and Brennan were negligent in not enacting

VERMONT'S MODEL PROTOCOL of "Law Enforcement Response to Children at the Scene of a Domestic Violence Incident".

6. The individual perpetrating these violent acts was NOT a member of the Peer

7. This individual, involved in the assault of Grace Michele on 1/4/14, or thereabout,

gained entry to the Peer household by violence and threat of violence to the Peers. 8. On 01/30/14 Grace Michele was still recovering from the assault of 1/4/14 see

9. **These** photographs **were** taken by **Kali May Peer** of her mother **Grace Michele**. 10. **VSP TROOPERS Shultze and Brennan** were grossly negligent in not doing a thorough

investigation.

11. **VSP TROOPERS Shultze and Brennan's failure to investigate** allowed the violence

against the Peers to go on for 5 months until they fled the State of Vermont for their own safety.

12. Such an investigation would have revealed **Grace Michele's injuries from the assault of**

01/30/14 but also the injuries of 1/4/14. See PHOTOGRAPHS.

13. Such an investigation would have revealed that the perpetrator was, by force of threat of

harm, compelling Kali to get in his vehicle on multiple occasions.

14. Such an investigation would have revealed that **Thetford Police Officer Rogers knew of**

the assault of Grace Michele on 1/4/14, or thereabout.

15. Such an investigation would have revealed that **Officer Rogers knowingly failed to report**

the assault of 1/4/14.

16. Such an investigation would have revealed that **Officer Rogers knowingly created a**

document whose narrative of the assault of 1/4/14 was false.

17. Such an investigation would have revealed that **Officer Rogers attempted to coerce**

Grace Michele to sign such a document.

18. In 2017 after the passage of **ACT 56 20 VSA 2401 (effective July 1, 2018)**

James Wolcott spoke with Richard Gautier, executive director of the Vermont Criminal Justice Training Council, regarding the false statements Thetford Police Officer Stuart Rogers made on 5/31/14 to VSP Trooper Ostrout (#14B301008) regarding the violent assault(s) of Grace Michele Peer by Ronald Sweet (& Brian Postler) on or about 1/4/14. Richard Gautier was very clear (quote): Lying to a Law Enforcement Officer is a crime. 19. Officer Rogers conduct was willful and malicious; his gross negligence allowed

the violence against the Peers to go on for 5 months, until they fled the State for their lives.

20. The notion that this was "domestic" violence is grossly inaccurate. This was stalking,

home invasion, false imprisonment; the violence occurred at various times and at various places.

21. Kali Peer witnessed this violence on multiple occasions, and has reported being

assaulted herself; but to date, has not been able to talk about it.

22. The failure of Law Enforcement to investigate and report is a violation of the Peers' civil

rights. They were denied due process; ie; their day in court.

23. On July 2, 2014, Maggie Cassidy of the Valley News reported that "..emails, which were

provided on Monday at the Valley News' request, show that Thetford has responded to roughly 250 complaints or 'law incidents' since the start of the year, and 'of those 250, (about) 114 of them are incomplete, most of them have nothing written in them, some as old as January of this year.'

24. The assault(s) of the Peers began on 1/4/14.

25. Michael Evans Chief of the Thetford Police Department was informed of the above

matter in detail on 8/24/20

26. Chief Evans was contacted by Drew Bloom of VCJTC on August 24, 2020..

27. Chief Evans did not and has not responded.

28. Officer Rogers remains on duty as a Police Officer of the Town of Thetford to this day.
