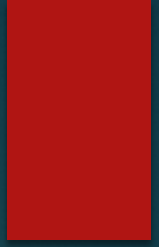

Opening remarks



Section 1

- ▶ 2 impacts
 - ▶ Expanded access to youthful offender
 - ▶ Option of criminal process provides necessary tools to address public safety promptly-does not foreclose youthful offender options going forward
 - ▶ Administration's proposals improve the bill
 - ▶ Each of the offenses in the list require a full toolbox of options-not a one size fits all approach
 - ▶ Can take months to address even extremely dangerous situations and serious charges-serious crimes filed as delinquencies
 - ▶ Violations of conditions of release set by the criminal court should be addressed by the criminal court
 - ▶ Our experience-Gage Street

I [redacted] give the following statement to Off. Swick whom I know to be a Bennington Police Department Officer. I make this statement on my own free will and accord without threat or promise to me, knowing that this statement can be used for or against me in a court of law.

In the middle of October Kass and "Laka" Odalys Velez showed up uninvited fighting needing a place to go for a little bit. They approached my mom, [redacted] and asked to come in for a couple hours to get away from cops. They then asked to stay for one night until they went back to Springfield Mass. The next day they never ended up leaving even tho they were asked to. After a week every time they were told to leave they would threaten my mother and intimidate the both of us. They then brought more people known to be Christian, Lucky Bob, North End Blichy and a few others from Springfield to stay with them. Over the

course of the last couple of weeks I have witnessed multiple sales of drugs by Christian, Kass, and Lucky Bob, as well as Odalys Velez. Christian has a gun with a dussie bottle sticker that he keeps on him at all time fully loaded that was also used to intimidate both me and my mother. Odalys Velez had a fully automatic Glock that she kept hidden under the mattress of the room she put her stuff in which is my brothers room. The fully automatic gun has been pointed at me with comments of how they are not afraid to use it and they are "bad ass" by Odalys. I was scared for mine and my mothers lives. I was brought into Odalys in my brothers room by Kass at 2:30 in the morning when the incident with the gun happened. From that time on they were told multiple times to leave and would either threaten

my mom or just ignore what they were being told. They put cameras around our house and in our house so they know what we were doing and saying at all times. They made us stay in our bedrooms at all times. I had to keep food and drinks in my room because I wasn't allowed down ~~the~~ my stairs. They would order take out every night but not feed us even tho they eat all of our food. They made me feel like a hostage in my own house. I was scared to death and that they would kill me. Brittney Onorato (my cousin) stayed with me for a couple of nights until they threatened her with their guns and to beat her up if she didn't leave. They used all of our heat leaving us in a cold house with no food and not paying for any utilities or food. At all times they would leave someone there that was apart

Sections 2 and 3

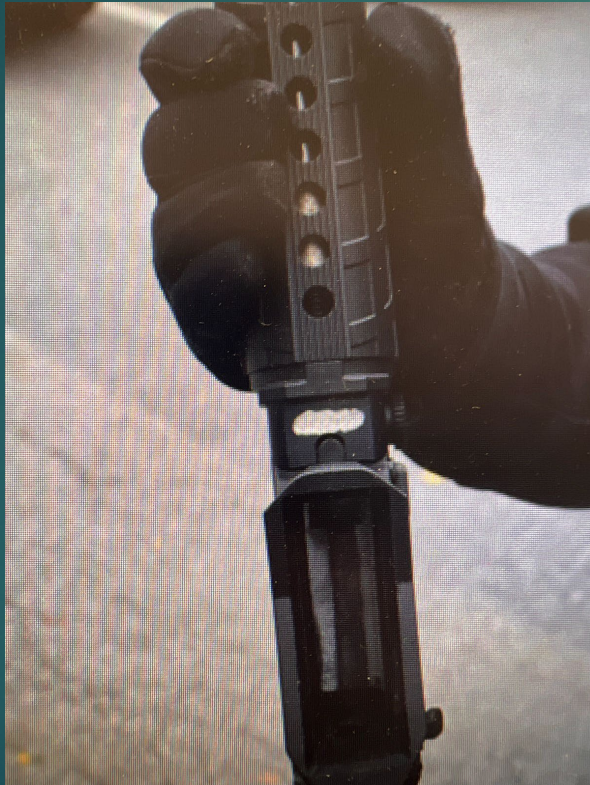
- ▶ What S.4, Section 2 addresses is criminal negligence
- ▶ Landlords have other tools besides eviction
 - ▶ Security cameras, property managers, lease provisions, law enforcement reports
- ▶ A person who does not have cause to know despite making reasonable efforts to ensure a safe property is not acting recklessly
- ▶ A landlord who ignores their properties to avoid responsibility or ignores information that should cause one to act is negligent, not an innocent third party
- ▶ The concerns you have heard can be addressed by including affirmative defenses

Section 5

- ▶ Straw purchasing contributes to human trafficking
- ▶ Provides an entry to contact with services
- ▶ Accessory before the fact-need not charge the purchaser

Section 7

- ▶ Only allows prosecutors to request a hold without bail
 - ▶ Substantial process attaches-judge decides
 - ▶ The hunter with the rifle in his truck or the kid with a box cutter in his pocket from work are not at risk
 - ▶ Judgment not left at the door
