2	Senator Hardy moves that the bill be amended as follows:
3	First: By striking out Secs. 40–43, implementation of Department of Motor
4	Vehicles modernization project; driver services, and inserting in lieu thereof
5	the following:
6	Sec. 40. IMPLEMENTATION OF DEPARTMENT OF MOTOR VEHICLES
7	MODERNIZATION PROJECT; GENERAL ASSEMBLY
8	OVERSIGHT
9	(a) Findings. The General Assembly finds that:
10	(1) The Department of Motor Vehicles provides services to almost all
11	Vermonters, including, in fiscal year 2022, engaging in more than a million
12	transactions, with almost half of all transactions being conducted online.
13	(2) The Department is in the middle of the DMV Core System
14	Modernization project, with an estimated launch date for the vehicle services
15	module in November 2023 and with the driver services module expected to
16	launch approximately 18 months after it commences in February 2024.
17	(3) As part of its design and implementation of the vehicle services
18	module, the Department has discovered that one of the barriers to modernizing
19	Department operations is certain outdated statutes. In order to best modernize
20	and optimize Department processes for the future during the months-long
21	module design and development process, the Commissioner of Motor Vehicles

1	has had to make business decisions that conflict with current statutes while the
2	General Assembly was adjourned, prior to an opportunity to seek amendments
3	to those statutes through the legislative process.
4	(4) The driver services module of the DMV Core System Modernization
5	project will design and implement processes to: issue and maintain driver's
6	licenses and other credentials; support fraud detection and investigation;
7	administer hearings; and administer, manage, and report driver restrictions,
8	convictions, and other information related to driver improvement.
9	(5) Driver services processes are regulated by statute in 23 V.S.A.
10	chapters 1, 3, 5, 9, 11, 24, 25, and 39, as well as more than 15 rules adopted
11	pursuant to authority under Title 23.
12	(6) It is anticipated that in designing and implementing the driver
13	services module, the Commissioner will need to make additional business
14	decisions that conflict with current statutes in order to modernize and optimize
15	Department processes to best serve Vermonters.
16	(7) Of the modernization projects in which the State is currently
17	engaged, the DMV Core System Modernization Project will likely have the
18	most significant impact on existing statutory language, but it is anticipated that
19	other modernization projects, such as the one that the Department of Labor will
20	undertake related to unemployment insurance, will raise similar tensions

1	between promoting efficiencies as part of modernization and contending with
2	outdated statutory provisions.
3	(8) A collaborative partnership between the Department and the General
4	Assembly throughout the driver services module, monitored during legislative
5	adjournment by the Joint Transportation Oversight Committee, the Joint Fiscal
6	Committee, and the House and Senate Committees on Transportation, provides
7	the best opportunity to save money, promote transparency, streamline the
8	process of amending statute to optimize potential efficiencies for Vermonters,
9	and serve as a model for collaboration between branches of State government
10	in future modernization projects.
11	(b) Reports.
12	(1) The Commissioner of Motor Vehicles shall provide two written
13	reports on the design and implementation of the driver services module of the
14	DMV Core System Modernization project to the Joint Transportation
15	Oversight Committee, the Joint Fiscal Committee, and the House and Senate
16	Committees on Transportation. The first shall be due on or before July 1, 2024
17	and the second shall be due on or before December 1, 2024.
18	(2) To the extent practicable, at the time each written report is filed, the
19	Department shall include recommendations on which provisions of statute and
20	rule the Department anticipates will need to be amended or repealed in order to

1	best modernize and optimize Department processes related to the provision of
2	driver services.
3	(c) Joint meetings. The Commissioner of Motor Vehicles shall provide
4	updates on the implementation of the driver services module of the DMV Core
5	System Modernization project by testifying at two joint meetings of the House
6	and Senate Committees on Transportation. The first joint meeting shall be
7	held on or before January 31, 2025 and the second joint meeting shall be held
8	on or before April 30, 2025.
9	(d) General Assembly oversight. To the extent practicable, the Joint
10	Transportation Oversight Committee, the Joint Fiscal Committee, and the
11	House and Senate Committees on Transportation shall promptly express any
12	concerns to the Department regarding any Department recommendations
13	contained in any written report or testimony provided pursuant to subsections
14	(b) and (c) of this section
