6	(a) A health care facility other than a hospital shall not develop or have
7	developed on its behalf a new health care project without issuance of a
8	certificate of need by the Board. For purposes of this subsection, a "new
9	health care project" includes means any of the following:
10	(1) The construction, development, purchase, renovation, or other
11	establishment of a health care facility, or any capital expenditure by or on
12	behalf of a health care facility, for which the capital cost exceeds
13	\$1,500,000.00 <u>\$10,000,000.00</u> .
14	(2) A change from one licensing period to the next in the number of
15	licensed beds of a health care facility through addition or conversion, or
16	through relocation from one physical facility or site to another.
17	(3) The offering of any home health service, or the transfer or
18	conveyance of more than a 50 percent ownership interest in a health care
19	facility other than a hospital or nursing home.
20	(4) The purchase, lease, or other comparable arrangement of a single
21	piece of diagnostic and therapeutic equipment for which the cost, or in the case

1	purposes of this subdivision, the purchase or lease of one or more articles of
2	diagnostic or therapeutic equipment that are necessarily interdependent in the
3	performance of their ordinary functions or that would constitute any health

5	by the Board, shall be considered together in calculating the amount of an
6	expenditure. The Board's determination of functional interdependence of
7	items of equipment under this subdivision shall have the effect of a final
8	decision and is subject to appeal under section 9381 of this title.

21	behalf of a hospital, for which the capital cost exceeds \$3,000,000.00.

2	piece of diagnostic and therapeutic equipment for which the cost, or in the case
3	of a donation the value, is in excess of \$1,500,000.00. For purposes of this

6	of their ordinary functions or that would constitute any health care facility
7	included under subdivision 9432(8)(B) of this title, as determined by the

1	(c) In the case of a project that requires a certificate of need under this
2	section, expenditures for which are anticipated to be in excess of
3	\$30,000,000.00 <u>\$50,000,000.00</u> , the applicant first shall secure a conceptual
4	development phase certificate of need, in accordance with the standards and
5	procedures established in this subchapter, that permits the applicant to make
6	expenditures for architectural services, engineering design services, or any
7	other planning services, as defined by the Board, needed in connection with the
8	project. Upon completion of the conceptual development phase of the project,
9	and before offering or further developing the project, the applicant shall secure
10	a final certificate of need in accordance with the standards and procedures
11	established in this subchapter. Applicants shall not be subject to sanctions for
12	failure to comply with the provisions of this subsection if such failure is solely
13	the result of good faith reliance on verified project cost estimates issued by
14	qualified persons, which cost estimates would have led a reasonable person to
15	conclude the project was not anticipated to be in excess of $30,000,000.00$
16	$\underline{\$50,000,000.00}$ and therefore not subject to this subsection. The provisions of
17	this subsection notwithstanding, expenditures may be made in preparation for
18	obtaining a conceptual development phase certificate of need, which
19	expenditures shall not exceed \$1,500,000.00 for non hospitals or
20	\$3,000,000.00 for hospitals <u>\$10,000,000.00</u> .

1	(d) If the Board determines that a person required to obtain a certificate of
2	need under this subchapter has separated a single project into components in
3	order to avoid cost thresholds or other requirements under this subchapter, the
4	person shall be required to submit an application for a certificate of need for
5	the entire project, and the Board may proceed under section 9445 of this title.
6	The Board's determination under this subsection shall have the effect of a final
7	decision and is subject to appeal under section 9381 of this title.
8	(e) The Board may periodically adjust the monetary jurisdictional
9	thresholds contained in this section. In doing so, the Board shall reflect the
10	same categories of health care facilities, services, and programs recognized in
11	this section. Any adjustment by the Board shall not exceed an amount
12	calculated using the cumulative Consumer Price Index rate of inflation.

10	(j) Excluded from this subchapter are the offering of a health care service,

14	State of Vermont; provided, however, that the State agency sponsoring the
15	project or awarding the contract or grant shall inform the Green Mountain Care
16	Board prior to commencing the project or within 30 days following the
17	execution of the contract or grant.
18	Sec. 3. EFFECTIVE DATE
19	This act shall take effect on passage and shall apply to all new health care
20	projects initiated on or after that date. For applications for a certificate of need
21	that are already in process on the date of passage of this act for which one or

- 1 more persons have been granted interested party status, the jurisdictional
- 2 thresholds and exclusions in place at the time the application was filed shall
- 3 <u>continue to apply until a final decision is made on the application.</u> For
- 4 <u>applications for a certificate of need that are already in process on the date of</u>
- 5 passage of this act for which no person has been granted interested party status,
- 6 <u>the applicant may withdraw the application in accordance with Board rules.</u>
