7	Statement of purpose of bill as introduced: This bill proposes to make several
8	technical corrections to fish and wildlife statutes. The bill would strike two
9	definitions from the general definitions section of fish and wildlife statutes.
10	The bill also would make technical changes to the uniform point system
11	statute, including increasing the point penalty for snaring animals. The bill
12	would also provide that certain use of public waters violations would be
13	judicial bureau offenses.

6	hunter with paraplegia or who is certified by a physician to be unable to pursue
7	game because of permanent severe physical disability, if he or she the licensed
8	hunter obtains a permit as provided in this subsection. The Commissioner on
9	receipt of satisfactory proof of the disability of an applicant may issue a permit
10	under this subsection. This permit shall be attached to the license and shall
11	remain in effect until the death of the holder, unless the Commissioner has
