1	(g) Gender identity. The State Registrar may correct or amend a death
2	certificate to reflect the deceased person's gender identity at the time of death,
3	upon application by:
4	(1) the certifying licensed health care professional, medical examiner,
5	hospital, or nursing home; or
6	(2) the spouse, child, grandchild, parent, sibling, grandparent, or
7	guardian of the deceased person.
8	(h) Rules. Pursuant to 3 V.S.A. chapter 25, the Department shall adopt
9	rules as necessary for the purposes of implementing, administering, or
10	enforcing the correction or amendment of death certificates pursuant to
11	subsection (g) of this section. The rules adopted pursuant to this subsection
12	shall include:
13	(1) a list of the documents that may be accepted as prima facie evidence
14	of the deceased person's gender identity, including any relevant information
15	contained in an advanced directive;

2	INTENT
3	It is the intent of the General Assembly that the Department of Health,
4	exercising rulemaking authority pursuant to this act, shall adopt a
5	comprehensive procedure for a health care professional or surviving family
6	member to attest to the gender identity of a deceased person. The procedure
7	shall ensure that any conflicting requests for the correction or amendment of
8	the gender identity on a death certificate are resolved through the consideration
9	and review of appropriate evidence.

11	This act shall take effect on July 1, 2025.
