2 An act relating to technical corrections to fish and wildlife statutes

3 The Senate proposes to the House to amend the bill as follows:

4 First: In Sec. 1, 10 V.S.A. § 4502, in subsection (b), in subdivision (2), by
5 striking out subdivision (SS) in its entirety and inserting in lieu thereof a new
6 subdivision (SS) to read as follows:

7 (SS) ~~Appendix § 37, section 9.0. Feeding deer~~ [Repealed.]

8 Second: In Sec. 1, 10 V.S.A. § 4502, in subsection (b), in subdivision (3),
9 by striking out subdivision (O) in its entirety and inserting in lieu thereof a new
10 subdivision (O) to read as follows:

11 (O) Appendix § 7, sections 4.0, 4.1, 4.2, 5.3, 6.1, 6.2, 6.3(b), 6.3(d),
12 6.3(e), 7.1, 7.2, 7.3, and 7.4, and 8.2. ~~Bear, unauthorized taking management~~
13 rule

14 Third: In Sec. 1, 10 V.S.A. § 4502, in subsection (b), in subdivision (3), by
15 striking out subdivision (P) in its entirety and inserting in lieu thereof a new
16 subdivision (P) to read as follows:

17 (P) Appendix § 22, sections 4.1, 4.2, 4.3, 4.4, 5.1, 5.2, 5.4, 6.4, and
18 6.5. ~~Turkey season, excluding: requirements for youth turkey hunting season;~~
19 ~~and size of shot used or possessed~~ seasons

1 Fourth: In Sec. 1, 10 V.S.A. § 4502, in subsection (b), in subdivision (3),
2 by striking out subdivision (U) in its entirety and inserting in lieu thereof a new
3 subdivision (U) to read as follows:

4 (U) Appendix § 37, sections 5.1, 6.1, 6.2, 7.1, 7.2, 7.4, 8.1, 8.2, 8.4,
5 9.1, 9.2, 9.4, 9.5, 12.2, and 14. Deer management rule, ~~excluding requirements~~
6 ~~for youth deer hunting weekend; requirements for novice season; limitations~~
7 ~~on feeding of deer; reporting big game; and section 11.0, ban of urine and~~
8 ~~other natural lures~~

9 Fifth: In Sec. 4, 1999 Acts and Resolves No. 1, Sec. 87a, by striking out
10 subdivision (A)(ii)(II) in its entirety and inserting in lieu thereof a new
11 subdivision (A)(ii)(II) to read as follows:

12 (II) Plan and Involve the Community. Involve Vermont
13 citizens and municipalities ~~in~~ when developing and updating ~~every 10 years~~
14 a the long-term comprehensive plan for management of portions of the lands
15 which are transferred to it.

16 Sixth: In Sec. 3, 10 V.S.A. § 4255 (license fees), by inserting a new
17 subsection to be subsection (p) to read as follows:

18 (p) The Commissioner may assess the following fees for the use of
19 Department of Fish and Wildlife lands and facilities. All fees or charges
20 collected for the use of Department of Fish and Wildlife lands and facilities
21 shall be deposited in the Fish and Wildlife Fund:
