An act relating to the regulation of forestry under Act 250

It is hereby enacted by the General Assembly of the State of Vermont:

Sec. 1. 10 V.S.A. § 6001 is amended to read:

§ 6001. DEFINITIONS

As used in this chapter:

* * *

(3)(A) “Development” means each of the following:

* * *

(C) For the purposes of determining jurisdiction under subdivision

~~(3)(A)~~ of this ~~section~~ subdivision (3), the following shall apply:

* * *

(vi) Forestry as referenced in subdivision (D) of this subdivision

(3) does not include conversion of land for nonexempt uses, such as for a commercial or industrial purpose constituting development as defined in this chapter.

(F) When development is proposed to occur on a parcel or tract of

land that is devoted to logging and forestry, only those portions of the parcel or the tract that support the development shall be subject to regulation under this chapter. Permits issued under this chapter shall not impose conditions on other

1 portions of the parcel or tract of land that do not support the development or
2 necessary mitigation areas and that restrict or conflict with the Acceptable
3 Management Practices for Maintaining Water Quality on Logging Jobs in
4 Vermont.

6 (44) “Wood products manufacturer” means a manufacturer that
7 aggregates wood products from forestry operations and adds value through
8 processing or marketing in the wood products supply chain or directly to
9 consumers through retail sales. “Wood products manufacturer” includes
10 sawmills; veneer mills; pulp mills; pellet mills; and producers of firewood,
11 woodchips, mulch, and fuel wood; ~~and log and pulp concentration yards.~~
12 “Wood products manufacturer” does not include facilities that purchase,
13 market, and resell finished goods, such as wood furniture, wood pellets, and
14 milled lumber, without first receiving wood products from forestry operations.

17 § 6081. PERMITS REQUIRED; EXEMPTIONS

19 (ee) No permit or permit amendment is required for logging and forestry
20 below the elevation of 2,500 feet that will not conflict with or violate any
21 condition of a permit issued pursuant to this chapter. Permits shall include a

1 statement that logging and forestry activities consistent with this subsection
2 and below the elevation of 2,500 feet are exempt from amendment jurisdiction.

4 This act shall take effect on July 1, 2026.
