7 § 7601. DEFINITIONS

8 As used in this chapter:

9 (1) "Court" means the Criminal Division of the Superior Court.

10 (2) "Criminal history record" means all information documenting an
11 individual's contact with the criminal justice system, including data regarding
12 identification, arrest or citation, arraignment, judicial disposition, custody, and
13 supervision.

14 (3) ~~"Predicate offense" means a criminal offense that can be used to~~
15 ~~enhance a sentence levied for a later conviction and includes operating a~~
16 ~~vehicle under the influence of alcohol or other substance in violation of~~

18 ~~and stalking in violation of section 1062 of this title. "Predicate offense" shall~~
19 ~~not include misdemeanor possession of cannabis, a disorderly conduct offense~~
20 ~~under section 1026 of this title, or possession of a controlled substance in~~
21 ~~violation of 18 V.S.A. § 4230(a), 4231(a), 4232(a), 4233(a), 4234(a), 4234a(a),~~
22 ~~4234b(a), 4235(b), or 4235a(a) "Criminal justice purposes" means the~~

1 investigation, apprehension, detention, adjudication, or correction of persons
2 suspected, charged, or convicted of criminal offenses. “Criminal justice
3 purposes” also includes criminal identification activities; the collection,
4 storage, and dissemination of criminal history records; and screening for
5 criminal justice employment.

3 ~~(a)(1) A person may file a petition with the court requesting expungement~~
4 ~~or sealing of the criminal history record related to the conviction if:~~

5 ~~(A) the person was convicted of a qualifying crime or qualifying~~
6 ~~crimes arising out of the same incident or occurrence;~~

7 ~~(B) the person was convicted of an offense for which the underlying~~
8 ~~conduct is no longer prohibited by law or designated as a criminal offense;~~

9 ~~(C) pursuant to the conditions set forth in subsection (g) of this~~
10 ~~section, the person was convicted of a violation of 23 V.S.A. § 1201(a) or~~
11 ~~§ 1091 related to operating under the influence of alcohol or other substance,~~

20 (1) A person may file a petition with the court requesting expungement
21 of a criminal history record related to a conviction if the person was convicted

1 of an offense for which the underlying conduct is no longer prohibited by law
2 or designated as a criminal offense.

3 (2) A person may file a petition with the court requesting sealing of a
4 criminal history record related to a conviction if the person was convicted of a
5 qualifying crime or qualifying crimes arising out of the same incident or
6 occurrence.

7 (3) Whichever office prosecuted the offense resulting in the conviction,
8 the State's Attorney or Attorney General, shall be the respondent in the matter
9 unless the prosecuting office authorizes the other to act as the respondent.

10 (4) The court shall grant the petition without hearing if the petitioner
11 and the respondent stipulate to the granting of the petition. The respondent
12 shall file the stipulation with the court, and the court shall issue the petitioner
13 an order of sealing and provide notice of the order to all Vermont State entities
14 provided by the petitioner and all entities required to receive notice pursuant to
15 subsection 7607(a) of this title.

16 (5) This section shall not apply to an individual who is the holder of a
17 commercial driver's license or commercial driver's permit pursuant to 23
18 V.S.A. chapter 39 seeking to seal a record of a conviction for a misdemeanor
19 or felony offense committed in a motor vehicle as defined in 23 V.S.A. § 4.

20 (b) Offenses that are no longer prohibited by law. For petitions filed
21 pursuant to subdivision (a)(1) of this section, the court shall grant the petition

1 and order that the criminal history record be expunged if the following
2 conditions are met:

3 (1) The petitioner has completed any sentence or supervision for the
4 offense.

5 (2) Any restitution and surcharges ordered by the court have been paid
6 in full, provided that payment of surcharges shall not be required if the
7 surcharges have been waived by the court pursuant to section 7282 of this title.

8 (c) Qualifying misdemeanors. For petitions filed to seal a qualifying
9 misdemeanor pursuant to subdivision (a)(2) of this section, the court shall
10 grant the petition and order that the criminal history record be sealed if the
11 following conditions are met:

12 (1) At least three years have elapsed since the date on which the person
13 completed the terms and conditions of the sentence.

14 (2) Any restitution and surcharges ordered by the court for any crime of
15 which the person has been convicted has been paid in full, provided that
16 payment of surcharges shall not be required if the surcharges have been waived
17 by the court pursuant to section 7282 of this title.

18 (3) The respondent has failed to show that sealing would be contrary to
19 the interests of justice.

20 (d) Qualifying felony offenses. For petitions filed to seal a qualifying
21 felony pursuant to subdivision (a)(2) of this section, the court shall grant the

1 petition and order that the criminal history record be sealed if the following
2 conditions are met:

3 (1) At least seven years have elapsed since the date on which the person
4 completed the terms and conditions of the sentence.

5 (2) Any restitution and surcharges ordered by the court for any crime of
6 which the person has been convicted has been paid in full, provided that
7 payment of surcharges shall not be required if the surcharges have been waived
8 by the court pursuant to section 7282 of this title.

9 (3) The respondent has failed to show that sealing would be contrary to
10 the interests of justice.

11 (e) Qualifying DUI misdemeanor. For petitions filed to seal a qualifying
12 DUI misdemeanor pursuant to subdivision (a)(2) of this section, the court shall
13 grant the petition and order that the criminal history record be sealed if the
14 following conditions are met:

15 (1) At least 10 years have elapsed since the date on which the person
16 completed the terms and conditions of the sentence.

17 (2) Any restitution and surcharges ordered by the court for any crime of
18 which the person has been convicted has been paid in full, provided that
19 payment of surcharges shall not be required if the surcharges have been waived
20 by the court pursuant to section 7282 of this title.

1 (3) The person is not the holder of a commercial driver's license or
2 commercial driver's permit pursuant to 23 V.S.A. chapter 39.

3 (4) The respondent has failed to show that sealing would be contrary to
4 the interests of justice.

5 (f) Fish and wildlife offenses. Sealing a criminal history record related to a
6 fish and wildlife offense shall not void any fish and wildlife license suspension
7 or revocation imposed pursuant to the accumulation of points related to the
8 sealed offense. Points accumulated by a person shall remain on the person's
9 license and, if applicable, completion of the remedial course shall be required
10 as set forth in 10 V.S.A. § 4502.

11 § 7603. ~~EXPUNGEMENT AND~~ SEALING OF RECORD, NO
12 CONVICTION; PROCEDURE

13 (a) Unless either party objects in the interests of justice, the court shall
14 issue an order sealing the criminal history record related to the citation or arrest
15 of a person:

16 (1) within 60 days after the final disposition of the case if:

17 (A) the court does not make a determination of probable cause at the
18 time of arraignment; ~~or~~

19 (B) the charge is dismissed before trial with or without prejudice; or

20 (C) the defendant is acquitted of the charges; or

1 (2) at any time if the prosecuting attorney and the defendant stipulate
2 that the court may grant the petition to seal the record.

3 (b) If a party objects to sealing ~~or expunging~~ a record pursuant to this
4 section, the court shall schedule a hearing to determine if sealing ~~or expunging~~
5 the record serves the interests of justice. The defendant and the prosecuting
6 attorney shall be the only parties in the matter.

7 (c), (d) [Repealed.]

8 (e) ~~Unless either party objects in the interests of justice, the court shall~~
9 ~~issue an order expunging a criminal history record related to the citation or~~
10 ~~arrest of a person:~~

10 § 7604. NEW CHARGE

11 If a person is ~~charged with a criminal offense after he or she has filed a~~
12 ~~petition for expungement pursuant to this chapter~~ has a criminal charge
13 pending at the time the petition for sealing or expungement is before the court,
