7	Statement of purpose of bill as introduced: This bill proposes to establish
8	Vermont Digital Addictions Awareness Day in order to educate the public
9	regarding addictions to digital services and the resulting consequences. The
10	observance would also serve as an incentive, in combination with free State
11	park admission, to encourage families to use this day to explore the outdoors
12	and visit a State park or Vermont historic site.
13	An act relating to establishing Vermont Digital Addictions Awareness Day
14	It is hereby enacted by the General Assembly of the State of Vermont:
15	Sec. 1. LEGISLATIVE INTENT
16	Digital addictions, whether mild or severe, are increasingly prevalent in
17	modern society, especially among the younger population. Mindless scrolling
18	on a digital device or overuse of video games stifles creativity, productivity,
19	and motivation and often leads to dependence on engaging in digital activities.
20	The establishment of the Vermont Digital Addictions Awareness Day is

1	intended to raise public awareness of the problem and hopefully encourage
2	families and individuals to explore the outdoors and to visit Vermont State
3	parks and historic sites.

15	harvesting of timber or removal of minerals or other resources from such lands
16	notwithstanding 32 V.S.A. § 603.

18	(5) On Digital Addictions Awareness Day, as established in accordance
19	with 1 V.S.A. § 378, the Commissioner of Forests, Parks and Recreation,
20	pursuant to the fee setting authority of the Commissioner set forth in

subdivision (1) of this subsection, shall waive the one-day entry fee to State

1	parks for families and individuals. Dependent upon the finances of the
2	Department of Forests, Parks and Recreation, the Commissioner may limit this
3	waiver to residents of the State of Vermont.
