10	(a) Expanding legal services. In fiscal year 2026, there is appropriated the
11	sum of \$300,000.00 from the General Fund to the Department of Economic
12	Development for the purpose of supporting the Vermont Law and Graduate
13	School's public education offerings and free legal support to small businesses
14	through its Vermont Small Business Law Center, which include:
15	(1) individual and group educational trainings and consultations;
16	(2) an ongoing webinar series on legal basics for startups; and
17	(3) an attorney referral program.
18	(b) Professionals of color network. In fiscal year 2026, there is
19	appropriated the sum of \$350,000.00 from the General Fund to the Department
20	of Economic Development for the purpose of continuing the support of the
21	Vermont Professionals of Color Network in its critical workforce and business

1	development services it provides to BIPOC business communities and to
2	support the expansion of its business technical assistance services, which

5	(c) Business advising. In fiscal year 2026, there is appropriated the sum of
6	\$688,889.00 from the General Fund to the Vermont Small Business
7	Development Center for the purpose of supporting the continuation of its work
8	in helping Vermonters start, acquire, and grow businesses. The funds shall
9	also be used to increase business advising and educational workshops to meet
10	increasing demands of entrepreneurs and small business owners post
11	pandemic. This increase of \$300,000.00 from the Governor's suggested
12	budget will allow the Center to serve an additional 200 Vermont entrepreneurs
13	and business owners through no-fee, one-to-one advising to help them start
14	businesses, add and retain jobs, increase sales, export products, and prepare
15	their ownership succession plan to transfer ownership for the business to
16	continue to operate in Vermont.
17	(d) Creation of resource guide. In fiscal year 2026, in addition to any other
18	funds appropriated to the Vermont Sustainable Jobs Fund Program, there is
19	appropriated \$100,000.00 from the General Fund to the Program for purpose of
20	creating a definitive business resource guide directed towards small businesses.
21	The funds shall support the creation of a magazine-style annual guide featuring

1	profiles of Vermont business service organizations, an interactive website that
2	serves as the digital home for the guide's content, and an artificial intelligence
3	platform that complements the website by including events, grants, programs,
4	and educational content. The guide, website, and artificial intelligence

6	completed on or before December 1, 2026.
7	(e) Microbusiness support. In fiscal year 2026, there is appropriated
8	\$581,000.00 from the General Fund to the Office of Economic Opportunity for
9	the purpose of supporting the Vermont Community Action Partnership's
10	microbusiness development program.
11	(f) Small business owner coaching services. In fiscal year 2026, there is
12	appropriated \$120,000.00 from the General Fund to the Vermont Small
13	Business Development Center for the purpose of providing executive business
14	skills training and coaching support to owners of small businesses with 20 or
15	fewer employees and that are at the growth stage of their business
16	development. The Center shall contract with the Vermont Sustainable Jobs
17	Fund Program and the Vermont Manufacturing Extension Center to deliver the
18	skills training and coaching services over a 12-to-18-month period, with a
19	defined scope of work developed in collaboration with each business owner
20	served. The services shall include the following topics:

1	(1) developing a sales and marketing strategy to the business' access to
2	markets;
3	(2) improving business core operations;
4	(3) conducting strategic planning;
5	(4) supporting the training needs of the business management team;
6	(5) supporting succession planning, if needed; and
7	(6) providing other important development next steps to advance the
8	business.
9	Sec. 3. VERMONT ARTS COUNCIL; VERMONT FILM AND CREATIVE
10	MEDIA INDUSTRY INITIATIVE
11	(a) Base funding increase. In fiscal year 2026, there is appropriated the
12	sum of \$1,071,800.00 from the General Fund to the Vermont Arts Council,
13	which includes an annual increase of \$68,737.00. This increase would match
14	the estimated federal contribution which is required in order to receive the
15	entire amount from the federal government.
16	(b) Building database. In fiscal year 2026, there is appropriated the sum of
17	\$120,000.00 from the General Fund to the Vermont Arts Council for the
18	purpose of supporting and growing the Vermont film and creative media
19	community and industry, including academic, educational, creative,
20	commercial, and exhibition resources. The funds shall be used to:

1	(1) build and maintain an online database of film and creative media that

7	Sec. 4. OUTDOOR RECREATION BUSINESSES; APPROPRIATION
8	In fiscal year 2026, there is appropriated the sum of \$250,000.00 from the
9	General Fund to the Department of Forests, Parks and Recreation to support
10	the Vermont Outdoor Business Alliance's Climate and Circularity Outdoor
11	Business Program, which provides sustainability and innovation technical
12	assistance to Vermont's outdoor sector for business planning and adaptations
13	leading to stability in the face of climate change, the shift to a circular
14	economy, and increased responsiveness to consumer behavior and outdoor
15	visitation trends. Funds appropriated shall be used for:
16	(1) providing technical assistance to outdoor businesses;
17	(2) managing small group workshops and one-on-one consultations; and
18	(3) coordinating industry events that will assist businesses on financial
19	planning and appropriate adaptations.

2	In fiscal year 2026, there is appropriated the sum of \$350,000.00 from the

11	and General Affairs with an update on its work pursuant to subsection (c) of
12	this section. On or before November 1, 2026, the Task Force shall submit a
13	final written report to the House Committee on Commerce and Economic
14	Development and the Senate Committee on Economic Development, Housing
15	and General Affairs with its findings and any recommendations for legislative
16	action.
17	(f) Meetings.
18	(1) The Secretary of Commerce and Community Development shall call

8	trade and State sovereignty.
9	(4) As provided for in 9 V.S.A. chapter 111A, the Commission shall
10	consider and develop formal recommendations with respect to how the State
11	should best respond to challenges and opportunities posed by a particular
12	International Agreement.
13	(5) The Commission shall be consulted when a trade commission
14	pursuant to 9 V.S.A. chapter 111B is proposed to be established by the General
15	Assembly and shall provide a recommendation as to whether the trade
16	commission shall be established.
