Whereas, the story of Keeler's Bay Variety Store (KBV) is intimately intertwined with the lives of Gail and Mark Horne, who, in 1974, took a leisurely drive across the Champlain Islands and discovered a small grocery store in South Hero, which they subsequently purchased, and

Whereas, under their visionary leadership, KBV evolved into a full-service general store, featuring a bakery, a beer cave stocked with craft beers, the largest 802Spirits store in the Champlain Islands, an in-store butchery, and motor vehicle gasoline sales, and this friendly community retailer earned a reputation for superb customer service, and

Whereas, at the 2000 Vermont Grocers' Association Convention, KBV was honored as the Grocer of the Year and, separately, the Lake Champlain Islands Economic Development Corporation awarded KBV its 2017 Business of the Year designation, and

Whereas, on Saturday, September 21, 2024, KBV and the Horne family marked their joint 50th-anniversary milestone with a unique version of the store's annual Customer Appreciation Day, and in celebration, a variety of commemorative memorabilia was offered for sale, and

Whereas, KBV has a proud association with community support service groups and contributes to local nonprofit organizations, and

Whereas, the store, whose ownership team now includes the Horne's daughter, Wendy, has earned the moniker, "The Heart of the Island," which was also the name of a limited edition semicentennial ale that the Kraemer & Kin Brewery created to celebrate this special anniversary, *now therefore be it*

Whereas, in 2023, Ken Cadow's busy life added an exciting new dimension with the publication of his first young adult novel, *Gather*, the story of Ian, an impoverished rural Vermont 10th grader who assumes adult family responsibilities while also adopting a stray dog named Gather, and

Whereas, the novel immediately garnered critical and popular acclaim, including designation as a 2023 Vermont Book Award finalist in the children's literature category; being named a 2024 Michael L. Printz Honor Book; and most recently winning the prestigious 2024 Kirkus Prize for young readers' literature, all astounding accolades for a first-time author, and

Whereas, the Vermont Humanities council has selected *Gather* as the organization's 2024–2025 Vermont Reads book, to be read and discussed across the State of Vermont in well over 100 different communities, and

Whereas, Gather has inspired thousands of Vermonters of all ages to take action in support of housing and food security, substance abuse recovery, and youth empowerment, and

Whereas, Ken Cadow is a valued resident of the town of Norwich, and he has contributed to the betterment of the town through his associations with the

Norwich Public Library and Marion Cross Elementary School, *now therefore be it*

House concurrent resolution recognizing March 2025 as National Senior Nutrition Program Month in Vermont

Whereas, approximately 28 percent of Vermont's population is 60 years of age or older, and according to the Vermont Foodbank, the threat of hunger confronts 12 percent of older Vermonters, and

Whereas, on March 22, 1972, President Richard Nixon signed Public Law 92-258, an amendment to the Older Americans Act of 1965, that established the national Senior Nutrition Program for older Americans, and

Whereas, the impetus for the national Senior Nutrition Program was the recognition that persons in this age group may not eat adequately due to a lack of finances, an inability to prepare nourishing meals, limited mobility, and feelings of loneliness, and

Whereas, in Vermont, the national Senior Nutrition Program is administered through the State Unit on Aging at the Department of Disabilities, Aging, and Independent Living and the area agencies on aging, and

Whereas, Meals on Wheels is a key element of the national Senior Nutrition Program through its provision of nutritious meals, safety checks, and friendly visits to those at risk of hunger and isolation, and

Whereas, in 2024, 42 Meals on Wheels providers delivered 986,662 nutritious home-delivered meals to thousands of older Vermonters, greatly improving their daily physical and emotional lives, and

Whereas, Meals on Wheels is an important component of Age Strong VT, a 10-year program designed to make Vermont "a great place for all ages and stages of life," and

Whereas, each March, the federal Administration for Community Living celebrates the establishment of the national Senior Nutrition Program, and the theme for 2025 is "A Place at the Table," "[recognizing] the importance of local nutrition programs and the meals being served across the country," *now therefore be it*

Resolved by the Senate and House of Representatives:

That the General Assembly recognizes March 2025 as National Senior Nutrition Program Month in Vermont, *and be it further*

Resolved: That the Secretary of State be directed to send a copy of this resolution to the Department of Disabilities, Aging, and Independent Living and the Vermont Association of Senior Centers and Meal Providers.

Offered by All Members of the House

House concurrent resolution in memory of former Representative Curt McCormack of Burlington

Whereas, Curt McCormack was a passionate environmental advocate who worked diligently to reduce sources of air pollution and encourage Vermonters' transportation choices in a direction eschewing cars and airplanes, and

Whereas, a licensed electrician by profession, Curt McCormack's desire to serve his fellow citizens in the legislative arena, and contribute an enduring beneficial impact on both environmental and transportation policy, twice sparked him to stand for a seat in the General Assembly, and

Whereas, in 1982, he won election to the House of Representatives as a member from Rutland City, and during this first legislative foray, which extended to late 1995, he chaired the House committee with environmental jurisdiction and was a national pioneer in leading a State effort to limit the use of chlorofluorocarbons, and

Whereas, he departed from the General Assembly to serve as the Vermont Bicycle-Pedestrian Coordinator at the Department of Transportation, a role that enabled him to implement facilities for human-powered transportation, and

Whereas, in 2012, having relocated to Burlington, Curt McCormack won election from the city's downtown-Old North End district, starting a new fiveterm legislative tenure that featured his service as the unusually carless House Committee on Transportation Chair; coincided with the extension to Burlington of the Ethan Allen Express Amtrak rail service, which he was instrumental in establishing years earlier; and included his election as a University of Vermont trustee, and

Whereas, he was a Peace Corps volunteer, who established a recycling facility in Joal, Senegal; a cyclist, who bicycled extensively in North America and Europe; a painter; and a music fan, whose diverse melodic pleasures ranged from Bob Dylan to opera, and

Whereas, Curt McCormack died of cancer on September 16, 2024 at 72 years of age, and his survivors include his partner, Lisa Scofield, and his children, grandchildren, and siblings, including former Senator Richard McCormack, *now therefore be it*

Resolved by the Senate and House of Representatives:

That the General Assembly extends its sincere condolences to the family of former Representative Curt McCormack of Burlington, *and be it further*
