House concurrent resolution congratulating the Brattleboro Food Co-op on its 50th anniversary and extending best future wishes

Whereas, the Brattleboro Food Co-op was the brainchild of, among others, Lee Crowley, Jack Fredericks, Cliff Adler, Lynn Levine, Carl Hirth, Peter Stolle, Billy Fitzgerald, and Alex Gyori, and their initiative to start a small buying club has evolved into a community-owned cooperative food emporium, and

Whereas, the organizers' dream became a reality on February 20, 1975 when the Brattleboro Food Co-op opened to the public in a small garage located at 40 High Street in Brattleboro, a cramped facility measuring approximately 150–200 square feet, and

Whereas, the opening day's sales tallied \$600.00, a meager sum in comparison with the latest year's gross sales of nearly \$25.5 million, and

Whereas, in 1988, the Brattleboro Food Co-op moved into a structure at the rear of the current parking lot, and in 2012, the current beautiful four-floor building, which is a hub of activity at 2 Main Street in downtown Brattleboro, began serving the public, and

Whereas, renovated through a collaboration with the Windham & Windsor Housing Trust (the Trust) and Housing Vermont, the four-floor facility features a 14,580 square foot first-floor natural foods market with a deli, the Whetstone Café, which often welcomes live music; the organization's offices; a commissary kitchen; a cooking classroom; a conference room; a second-floor community room that is available for rental; and 24 Trust-owned apartments that occupy the top floors, and

Whereas, the Brattleboro Food Co-op contains the following departments: beer and wine; catering; cheese; deli, with Brattleboro's largest selection of

eat-in and take-out food offerings; grocery; bulk food; meat and seafood; produce and floral, which supports local farmers and offers floral and plant choices year-round; and health and wellness, selling holistic products, and

Whereas, the Brattleboro Food Co-op is proud of its half-century serving Windham County residents, now therefore be it

House concurrent resolution recognizing May 2025 as Progressive Supranuclear Palsy Awareness Month in Vermont

Whereas, according to the National Institute of Neurological Disorders and Stroke, progressive supranuclear palsy (PSP) is a rare onset progressive neurological disorder that affects numerous essential physical and mental functions, and

Whereas, an estimated 20,000 Americans have been diagnosed with this disorder, and the specific symptoms are individually unique, and

Whereas, PSP's symptoms usually appear at 60 years of age or older, although in some cases earlier, and they can result in an individual becoming depressed, forgetful, and irritable and cause an individual to have sleeping challenges, and

Whereas, individuals with PSP can experience severe quality-of-life issues, and contracting this disorder can necessitate complex care requirements that negatively impact family relationships and the lives of caregivers, and

Whereas, although outwardly similar to Parkinson's disease, PSP is a distinct disorder that is part of the group of disorders known collectively as atypical parkinsonism, and

Whereas, at present, there is neither a cure nor even a modifying treatment, and although some symptoms may be managed with medication and care, the lack of understanding about the disease has often led to misdiagnosis, and this lack of medical knowledge hinders both intervention efforts and clinical trials, and

Whereas, the recognition of May 2025 as Progressive Supranuclear Palsy Awareness Month will create greater public and health care community awareness of PSP, highlight the continuing effort to find a cure, and provide comfort to the families whose lives have been drastically altered, now therefore be it

That the General Assembly recognizes May 2025 as Progressive Supranuclear Palsy Awareness Month in Vermont, *and be it further*

House concurrent resolution commemorating the 250th anniversary of Ethan Allen's planning, in Bennington in 1775, of the successful Vermont initiation of the American War of Independence and the associated expedition to Ticonderoga

Whereas, during the 1770s, the volunteer militia members of the New Hampshire Grants, living north of the province of Massachusetts in the frontier areas between the Connecticut River and Lake Champlain, were known as the Green Mountain Boys, and

Whereas, the Green Mountain Boys were located within striking distance of the two artillery-rich British forts, Crown Point and Ticonderoga, both perched on the western shore of Lake Champlain, and

Whereas, in early May 1775, Ethan Allen, who lived in Bennington, directed his fellow Green Mountain Boys at the Catamount Tavern, the militia's de facto headquarters, to bring their flintlock muskets north, in a discrete manner; to recruit more Green Mountain Boys along the way; and to rendezvous in Castleton, where they would be given further instructions, and

Whereas, the plan was finalized at Castleton and the Green Mountain Boys' execution of it resulted in the successful seizure of the British-held forts and the liberation of 78 cannons at Ticonderoga and 111 cannons at Crown Point, and these forays into British fortifications were seen as the first patriot triumphs in the American War of Independence from Great Britain, and

Whereas, these epic military operations and legendary feats forever enhanced the reputation of the Green Mountain Boys and contributed to the successful American drive to win independence from Great Britain, and

Whereas, in May 2025, Vermonters are commemorating the early role of the gallant and heroic men of the New Hampshire Grants in the fight for American independence, the prelude to Vermont's admission as our nation's 14th state, and

Whereas, in Bennington County, the commemoration of the "Expedition to Ticonderoga: Ethan Allen, the Green Mountain Boys, and America's First Victory," includes public events celebrating these brave deeds of 1775, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly commemorates the 250th anniversary of Ethan Allen's planning, in Bennington in 1775, of the successful Vermont initiation of the American War of Independence and the associated expedition to Ticonderoga, *and be it further*

Whereas, manufacturing is a vital pillar of Vermont's economy, strengthening both rural and urban communities, supplying globally recognized businesses, and driving innovation across diverse industries, ensuring the State's economic resilience and competitiveness, and

Whereas, Vermont's manufacturing industry generates close to \$3 billion, an economic impact representing over 8 percent of the State's GDP, and

Whereas, manufacturing businesses constitute approximately 10.5 percent of Vermont's private sector workforce, supporting 30,000 jobs, and

Whereas, Vermont's manufacturing jobs typically offer wages above the State's average, providing workers with greater economic mobility; and supporting and promoting manufacturing jobs with competitive wages is essential to attracting and retaining talent while fostering long-term economic stability and growth in Vermont, and

Whereas, manufacturers in our State contribute significantly to promoting strategic relationships between the State and neighboring regions, including New England, New York, Canada, and the broader local and global economy, now therefore be it

Resolved the Senate and House of Representatives:

That the General Assembly celebrates the role of the manufacturing industry in the Vermont economy and designates April 2, 2025 as Manufacturing Day at the State House, *and be it further*

Whereas, the percentage of Vermont high school students pursuing postsecondary education has declined significantly in recent years, and

Whereas, an important antidote to this trend is the Early College Program (ECP) that enables high school students simultaneously to complete their senior year and freshman year of college, and

Whereas, the enactment of 2013 Acts and Resolves No. 77, "An act... encouraging flexible pathways to secondary school completion," updated Vermont's long history of offering alternative methods to achieve high school graduation, and this act was designed to improve postsecondary readiness and enrollment, and

Whereas, the ECP established in Act 77 represents approximately 0.4 percent of the expenditures from the Education Fund, and it is intended to encourage postsecondary education enrollment among students who might not otherwise consider this option, and

Whereas, demonstrable gains have occurred during the past three years in the equitable admission of students into the ECP at the Community College of Vermont, including a 250 percent increase in the enrollment of students with low income, and

Whereas, Vermont associate degree graduates are among the most likely in the country to realize a positive return on their investment, a figure that stands at 79 percent according to the Strada Education Foundation, and

Whereas, the ECP has a major influence in directing the personal postsecondary education and career aspirations of the State's students, and it prospectively strengthens the future Vermont workforce, and

Whereas, today, April 2, 2025, ECP enrollees who are studying at the Community College of Vermont are visiting the State House, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly designates April 2, 2025 as Early College Day at the State House, *and be it further*

Resolved: That the Secretary of State be directed to send a copy of this resolution to the president of the Community College of Vermont and the Secretary of Education.
