#### H.C.R. 95

Offered by Representative Noyes of Wolcott

House concurrent resolution designating April 24, 2025 as Vermont Children's Alliance Day at the State House

*Whereas*, in Vermont, there are 13 Child Advocacy Centers (CACs) focusing on the challenges and solutions to the continuing prevalence of child abuse in our State, and

*Whereas*, these important organizations provide critical support and representational services to children whose needs can be acute and who rely on the centers to assist in transforming their lives from ones that may be harsh to a potentially more promising future, and

*Whereas*, a CAC provides "forensic interviews, a safe meeting space, victim advocacy, and coordinated care to children that report sexual and physical abuse," and

*Whereas*, "the vision of the Vermont Children's Alliance (VCA) [the CACs' membership organization] is to empower Vermont's CACs to provide equal and reliable access to support, treatment, justice, and healing for every child," and

*Whereas*, this vision is encompassed in the organization's mission "to foster the growth of the CAC movement by providing statewide support and resources, promoting awareness of child abuse and its impact on our communities," and

*Whereas*, today, April 24, 2025, representatives of the VCA and its member CACs are visiting the State House to educate legislators on the importance of addressing the continuing problems associated with the abuse of our youngest Vermonters, *now therefore be it* 

### **Resolved by the Senate and House of Representatives:**

That the General Assembly designates April 24, 2025 as Vermont Children's Alliance Day at the State House, *and be it further*

*Whereas*, Head Coach Jason Gray and assistant coaches Alex Emerson, Andy Martin, and Owen Deffner were ideal advisers throughout the 2024– 2025 season, *now therefore be it*

Offered by Committee on Corrections and Institutions

House concurrent resolution congratulating the Southern State Correctional Facility's debate team on its National Prison Debate League victory over Wake Forest University

*Whereas*, in an innovative project that Commissioner of Corrections Nicholas Deml described as "show[ing] the transformative power of education," the Southern State Correctional Facility (SSCF), in association with the National Prison Debate League (NPDL), conducted a semester-long, three-college-credit course instructing the enrollees on the art of collegiate debate, and

*Whereas*, the NPDL "connects incarcerated individuals with collegiate debate programs, sharpening critical thinking[,]...spurring creativity[,] reduc[ing] recidivism[,] and, ultimately, reshap[ing] lives," and

*Whereas*, as the exciting course highlight, six of the SSCF students engaged in a virtually transmitted debate against a student team from Wake Forest University in Winston-Salem, North Carolina, and

*Whereas*, the topic of the debate was the Norwegian Model of Corrections, "which emphasizes rehabilitation and personal agency," and each team consulted experts in preparation for the debate, and

*Whereas*, upon the debate's completion, a panel of independent judges scored all aspects of each team's performance and declared the SSCF team the winner, an outstanding accolade for this correctional facility team, and

*Whereas*, this well-deserved victory is attributed both to the SSCF debaters' dedication and studiousness and to the NPDL's intensive four-month curriculum "focused on civic engagement, empowerment, conflict resolution, research skills, and peer leadership," and

*Whereas*, the course's success reflects NPDL Executive Director Daniel Throop's observation that "there are no inferior minds, only unequal opportunities," *now therefore be it*

# H.C.R. 103

Offered by Representatives Burke of Brattleboro, Goodnow of Brattleboro, and Kornheiser of Brattleboro

Offered by Senators Harrison and Hashim

House concurrent resolution commemorating the establishment of the Austine School for the Deaf collection and exhibit at the Vermont Historical Society Library in Barre *Whereas*, in the 19th century, Brevet Colonel William Austine of Brattleboro donated \$50,000.00 for the construction of a hospital in the community, and

*Whereas*, because a hospital already existed in Brattleboro, after the Colonel's death, his estate executor arranged for the legal redesignation of the gift for the purpose of establishing a school for the blind and deaf, and

*Whereas*, the General Assembly, in 1904 Acts and Resolves No. 276, incorporated "The Austine Sanitarium," and it amended the legislation in 1908 Acts and Resolves No. 319 to give the new organization flexibility in designating a name, and

*Whereas*, finally, in 1910 Acts and Resolves No. 74, the General Assembly appropriated \$50,000.00 "for the purpose of erecting a suitable building or plant for the use of said corporation, upon the land owned by it in Brattleboro, Vermont" subject to it being used for a school for the deaf, and

*Whereas*, the Austine School for the Deaf opened in the fall of 1912 with 16 students and at the first commencement in 1914, both Alexander Graham Bell and Helen Keller were speakers, and

*Whereas*, operation of the Austine School for the Deaf continued until 2014, and the school's historic documentation and artifacts are located at the Winston Prouty Center in Brattleboro under the curatorial supervision of the Austine School for the Deaf Museum Board, Donna Marie Auditore-Pyne, President, and

*Whereas*, in order to afford greater prominence to the history and role of the Austine School for the Deaf, a select collection of the oldest artifacts has been transferred for exhibition to the Vermont Historical Society Library in Barre, and a dedication ceremony, at which State officials spoke, occurred on October 26, 2024, *now therefore be it*

That the General Assembly commemorates the establishment of the Austine School for the Deaf collection and exhibit at the Vermont Historical Society Library in Barre, *and be it further* 

**Resolved:** That the Secretary of State be directed to send a copy of this resolution to the immediate past chair of the Austine School for the Deaf Museum Board and the Vermont Historical Society.

#### H.C.R. 104

Offered by Committee on Human Services

House concurrent resolution recognizing May 2025 as National Foster Care Month in Vermont

*Whereas*, according to the U.S. Child Welfare Information Gateway, there are over 365,000 children and youth in foster care, and "77 percent of eligible youth in foster care, ages 14–21 years old, left care without receiving the federally funded services necessary to prepare them for adulthood and independent living," and

*Whereas*, the Department for Children and Families reports that as of April 1, 2025, 868 Vermont children were in foster care, there were 820 licensed foster caregivers and 174 caregiver licenses were pending, and approximately 35 percent of foster caregivers were family members or close friends who voluntarily secured foster care licensure, and

*Whereas*, on May 10, 1988, at the initiative of the U.S. Children's Bureau, President Ronald Reagan signed Proclamation 5820 establishing Foster Care Month, which continues to be observed annually to direct the public's attention to the nation's system of foster care, and

*Whereas*, Proclamation 5820 acknowledged that "the family has the prime responsibility for nurturing children...[but] some parents are unable to provide a minimally acceptable level of care for their children, and temporary or permanent alternative placement is necessary...[and that] foster care must... [focus] on the well-being of the child," and

*Whereas*, the 2025 theme for National Foster Care Month is "Engaging Youth. Building Supports. Strengthening Opportunities." — a theme that "highlights the need to create a child welfare system that authentically engages and supports young people who are preparing to leave foster care," a current topic of great concern in the foster care community, *now therefore be it* 

#### **Resolved by the Senate and House of Representatives:**

That the General Assembly recognizes May 2025 as National Foster Care Month in Vermont, *and be it further* 

**Resolved:** That the Secretary of State be directed to send a copy of this resolution to the System of Care Unit Director at the Department for Children and Families' Family Services Division.

*Whereas*, the circus arts provide entertainment and excitement, both internationally and in Vermont, where there is a vibrant circus community, and they foster creativity, demand physical skill, and are engaging for all ages, and

*Whereas*, for the 15th consecutive year, the Federation Mondiale du Cirque, of which Princess Stéphanie of Monaco serves as honorary president, is designating the third Saturday in April as World Circus Day, which in 2025 will occur on April 19, and

*Whereas*, among the extensive Vermont schedule of area commemorative events celebrating World Circus Day are the New England Center for Circus Arts' preview of the ProTrack Circus Springboard Show in Brattleboro; Nimble Arts launching its LakeSide Studio circus and tree dancing workshops in Tinmouth; the Circus Minimus retreat in Lenox, Massachusetts, featuring participants ranging from seven to 77 years of age; Wunderle's Big Top Adventure's Circus Vacation Camp at the Southern Vermont Arts Center in Manchester; the Diamond Family Circus's annual circus art workshops for seniors and adults with disabilities in Island Pond; the fifth online Vermontbased Circus International Film Festival; Maia Castro-Santos's rehearsal at Burlington's Lines Vermont Dance Studio and Store for her aerial students scheduled to perform in the studio's spring showcase; and the Upper Valley Circus Collective's spring classes, and

*Whereas*, observing World Circus Day in Vermont is most fitting for a State where the circus arts play such prominent artistic and cultural roles, *now therefore be it*

*Whereas*, at the State championship held this year at Vergennes Union High School on February 15, 2025, each team was required to compete in two of the three categories, and each category was limited to a single round in which a team performed a routine consisting of three to 20 dancers, for a duration of two to two and a half minutes, with a recorded musical accompaniment, and a champion was designated for each of the three categories, and

*Whereas*, for the 10th consecutive year, the Cougars ranked supreme in the hip-hop category, and they celebrated the additional bonus of achieving first place overall in scoring, narrowly outdistancing second-place South Burlington 259–253, and

Whereas, coaches Rose Bedard, Lisa Russin, Addie Price, Ella Davis, and Edie Watson were superb guides for the dancing Cougars, now therefore be it

House concurrent resolution congratulating the Rice Memorial High School Green Knights boys' ice hockey team on winning a second consecutive Division I championship *Whereas*, endless superlatives are the only way to describe the Green Knights' 2024–2025 season on the ice as they surpassed their 2023–2024 Division I season in innumerable ways, and

*Whereas*, Rice was an offensive powerhouse this season, overwhelming their opponents on the scoreboard 136–17, and they remained undefeated, sporting an overall record of 23–0, and

*Whereas*, retaining that perfect win-loss record was briefly in doubt during the Division I championship game at the University of Vermont's Gutterson Fieldhouse, where the top-seeded Green Knights faced off against the No. 3 South Burlington Wolves, and

*Whereas*, the Wolves scored first at 2:35 into the first period, but Rice returned the favor merely 31 seconds later, and despite the Wolves tying the score at 2–all early in the third period, Rice focused intensely, securing a 4–2 victory and the 2025 Division I crown, and
