#### H.C.R. 141

Offered by Representatives Holcombe of Norwich and Masland of Thetford

House concurrent resolution in memory of U.S. Environmental Protection Agency (EPA) engineer Edward M. Hathaway

Whereas, Ed Hathaway graduated from the Xaverian Brothers High School in Westwood, Massachusetts, and Suffolk University in Boston, Massachusetts, as a business major, and

Whereas, business proved a temporary detour on Ed Hathaway's life path, as he discovered upon moving to the Southwest a deep love of nature, prompting him to return to school and earn a degree in environmental science from Northern Arizona University, and

Whereas, this second degree opened the door for a brilliant 36-year career at the EPA, initially as a manager in the Superfund Division, and

Whereas, Ed Hathaway's solid scientific knowledge was only one aspect of his superb public service, as he was an extraordinary facilitator who could bring conflicting parties, be they community groups, state, or other federal agencies, to viable solutions when addressing environmental problems, and

Whereas, the EPA valued Ed Hathaway's professional achievements, and he was repeatedly honored with agency awards, most recently "Mentor of the Year," and

Whereas, in Vermont, his enduring legacy was as the supervising EPA engineer for two Vermont Superfund cleanup projects: at the Ely Copper Mine in Vershire and the Elizabeth Mine in Strafford, the latter for which he enabled over \$100 million to be directed to this challenging project, even arranging the replacement of roads that heavy truck traffic had damaged, and

Whereas, this truly kind and highly respected official's EPA role was cut short due to his contracting pancreatic cancer, which he fought valiantly until his death on March 7, 2025 at 63 years of age, and his survivors include his wife, Ann-Marie Burke; his sons; and his parents, now therefore be it

House concurrent resolution honoring Steven D. Faccio of Strafford for his inspiring leadership as a conservation biologist

Whereas, Steve Faccio has dedicated his life, both professionally and personally, to the protection of the natural environment and its lands, waters, and creatures, and

Whereas, he earned bachelor's and master's degrees in biology, respectively, from Western Connecticut State University and Southern Connecticut State University, and

*Whereas*, upon completion of his academic studies, Steve Faccio wisely headed northward to Vermont, where he has resided to this day, and

Whereas, for 15 years (1992–2007), he worked as a conservation biologist at the Vermont Institute of Natural Science, where his topics of interest were often ornithologically focused and included peregrine falcon nesting sites, loon habitat, the presence of the brown-headed cowbird in the Champlain Valley, and examinations of avian breeding and migration, and he developed a large oeuvre of publications in peer-reviewed scientific journals, popular magazines, and commissioned reports, and

Whereas, in 1994, Steve Faccio joined the Vermont Endangered Species Committee's Reptile and Amphibian Scientific Advisory Group, of which he remains an active member, and

Whereas, in 2002, he was a founding member of the Strafford Conservation Commission; served as its secretary for 11 years; and, after a brief hiatus, rejoined and has served continuously since 2015, and

Whereas, in 2005, Steve Faccio was a co-winner of the Wilson Ornithological Society's Edwards Prize, and

Whereas, in 2007, he embarked on a new professional adventure, cofounding and serving as the senior conservation biologist at the Vermont

Center for Ecostudies, and a special accomplishment was creating the regularly consulted Vermont Vernal Pool Atlas, and

Whereas, after decades of an intellectually fulfilling and environmentally impactful career, Steve Faccio is concluding his role at the Vermont Center for Ecostudies but will no doubt remain involved in conservation-related projects, now therefore be it

House concurrent resolution honoring former Pawlet First Constable David Ricard Sr. for his outstanding municipal public service

Whereas, the municipal government employment of Dave Ricard for the Town of Pawlet started in 2003 when he was first elected as the town's first constable, and

Whereas, over the course of 22 years, he improved the professionalism of policing services in the Town of Pawlet, assisting local colleagues who followed his path and earned their law enforcement officer certifications, and

Whereas, although Dave Ricard's primary public service responsibility was working as Pawlet First Constable, which he executed professionally and proficiently, he also performed other municipal roles with the same degree of attention and excellence, including serving as the West Pawlet Volunteer Fire Chief; as a patrol officer in Fair Haven; and as the Wells highway foreman, keeping tabs on that community's town road conditions, and

Whereas, after over two decades of overseeing law enforcement activities in the Town of Pawlet, in 2025, Dave Ricard declined to seek reelection, concluding his exemplary career as the town's first constable, and his fellow citizens greatly appreciate his contribution to civic life in their community, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly honors former Pawlet First Constable David Ricard Sr. for his outstanding municipal public service, *and be it further*

#### H.C.R. 144

Offered by Representatives Morrissey of Bennington, Corcoran of Bennington, Greer of Bennington, and Nigro of Bennington

Offered by Senators Bongartz and Plunkett

House concurrent resolution commemorating the 250th anniversary of the U.S. Marine Corps

Whereas, on November 10, 1775, now observed as the founding date of the U.S. Marine Corps, the Second Continental Congress adopted a resolution directing the raising of two battalions of Marines, and John Adams nominated Major Samuel Nicholas to serve as the first Commandant of the Continental Marines, and

Whereas, Major Nicholas organized the recruitment of the initial battalion of Continental Marines at the Tun Tavern in Philadelphia, and the tavern's owner, Robert Mullan, became the first Marine recruiter, and

Whereas, after comporting themselves magnificently during the American War of Independence, the Continental Marines were disbanded in 1783, but on July 11, 1798, with the Quasi-War with France on the horizon, the U.S. Congress adopted "An Act for Establishing and Organizing a Marine Corps" that officially created the U.S. Marine Corps as part of the nation's military, and

Whereas, during the War of 1812, the U.S. Marine Corps played pivotal roles in the Champlain Valley, defending Plattsburg, and in the Battle of New Orleans, from which the service gained a coveted reputation for its superb marksmanship, and

Whereas, in 1834, the U.S. Marine Corps was placed under the administrative structure of the U.S. Navy but has always remained a distinctive service with both maritime and onshore roles, including protecting American diplomatic facilities worldwide, and

Whereas, in 1883, the U.S. Marine Corps adopted the motto "Semper Fidelis" (Always Faithful), expressing the loyalty of individual Marines to their fellow Marines, and they have distinguished themselves in battle ever since, and

Whereas, in 1884 Acts and Resolves No. 180, the General Assembly incorporated "The Trustees of the Soldiers' Home in Vermont" (today's Vermont Veterans' Home in Bennington), and its U.S. Marine Corps residents, who stay true to the spirit of Semper Fidelis and celebrate this 250th anniversary with great pride, as does the nation, which is marking the occasion with commemorative stamps and coinage, now therefore be it

House concurrent resolution celebrating the 35th anniversary of the installation of the first piece of art for the Art in State Buildings Program

Whereas, in 1988 Acts and Resolves No. 267, the General Assembly enacted "An act relating to art in public buildings" in recognition of the State's need to "encourage the work of Vermont artists; to enhance and preserve its cultural environment and heritage; and to provide artistic enrichment to its residents and visitors," and

Whereas, now known as the Art in State Buildings Program, the State's structures have been brightened, enlivened, and made more welcoming for employees and visitors alike due to the presence of varied creations, and

Whereas, since the first artwork was installed in a State building in 1990, hundreds of Vermont-crafted pieces have found wonderful homes at courthouses, institutions of higher education, office buildings, public safety facilities, the State House, and other Stated-owned venues throughout Vermont, and

*Whereas*, the created artworks, be they drawings, paintings, sculptures, or other mediums, enhance civic pride and portray the story of Vermonters and the State's culture, history, landscape, and values, and

Whereas, the employment of Vermont artists and craftspeople is a worthy investment in the creative economy, supports local talent, and provides an incentive for artistic Vermonters to pursue careers in the State, and

Whereas, these creative works often portray environmental and stewardship themes, reflecting Vermont's strong connection to its natural and working landscapes, and they contribute to a State art collection that affords a distinctive perspective on our cultural history, and

Whereas, the Art in State Buildings Program is a valued public investment that brings beauty to our lives and is a legacy for future generations to cherish and expand in new and exciting directions, now therefore be it

Offered by Senators Bongartz and Plunkett

House concurrent resolution commemorating the 60th anniversary of the Bennington Fire Department's management of the annual Bennington Battle Day Weekend Parade and festivities

Whereas, the Town of Bennington annually celebrates the August 16, 1777 American War for Independence victory of patriot forces, including members of the Green Mountain Rangers (many of whom were Green Mountain Boys), at the Battle of Bennington in which the Americans defeated a large contingent of British and other loyalist forces under the command of British General John Burgoyne, who had unsuccessfully sought to capture a Bennington supply depot, and

Whereas, this observance consists of festive events centered on a muchanticipated parade featuring floats, musicians, marchers representing local organizations, public safety vehicles, and Vermont dignitaries, and

Whereas, originally, this venerable marching extravaganza and the associated activities were the responsibility of an ad hoc committee of local

business owners and citizens, some of whom, including John Proud, were Bennington Fire Department members, and

Whereas, seeking a long-term management structure for the Bennington Battle Day Weekend commemorations, the ad hoc committee approached the Bennington Fire Chief, Chuck Sawyer, to inquire if the department would assume this role, and

Whereas, at the Bennington Fire Department's January 1965 meeting, the question was presented and the idea endorsed, with the 1965 celebration becoming the first under the department's purview, and

Whereas, the department's first Bennington Battle Day Weekend Committee consisted of Chief Sawyer (General Chairperson); Ornal Pierce Sr. (Treasurer); assistant chiefs Joseph Wasick, Edwin Mattison, and Mike Walker; and other department members serving on the committee, and

Whereas, to finance these events, the department hosts a series of fundraisers throughout the year, and among the other Bennington Battle Day Weekend celebrations are a car show, sporting competitions, a chicken barbeque dinner, and a Las Vegas night, and

Whereas, for 60 years, the Bennington Fire Department has served as the ideal guardian angel for this local summertime tradition, now therefore be it

## H.C.R. 147

Offered by Representatives Morrissey of Bennington, Corcoran of Bennington, Greer of Bennington, and Nigro of Bennington

Offered by Senators Bongartz and Plunkett

House concurrent resolution commemorating the 250th anniversary of the establishment of the U.S. Navy

Whereas, in 1884, the General Assembly adopted Act 180 incorporating "The Trustees of the Soldiers' Home in Vermont" and establishing the legal foundation for the contemporary Vermont Veterans' Home, providing a

dignified residence for all those who had served in our nation's military, including the Vermonters who bravely served in the U.S. Navy, and

Whereas, the origins of the U.S. Navy predate the nation's independence and can be traced to a 1775 action of the Rhode Island General Assembly, which directed its delegates to the Continental Congress in Philadelphia to request that "a fleet of sufficient force for the protection of these colonies" be formed to protect American ports and waters, and

Whereas, after deliberations, on October 13, 1775, considered the U.S. Navy's founding date, the Continental Congress created a naval advisory committee of which future president John Adams was a member, and

Whereas, accepting the Committee's recommendations that defensive and offensive naval capabilities be developed, the Continental Congress directed that Massachusetts supply George Washington, then stationed in that colony, with an armed schooner and a sloop for the purpose of seizing British supply vessels, and

*Whereas*, by the end of 1775, the Continental Congress had authorized the purchase of ships and created an organizational structure formalizing the Continental Navy, and

Whereas, after serving a vital role in the American War of Independence, the U.S. Navy was shuttered, but new maritime dangers such as the Barbary pirates emerged, prompting the U.S. Congress on January 2, 1794 to resolve to create "a naval force, adequate to the protection of the United States against the Algerine corsairs," and on March 27, 1794, Congress adopted an "Act to provide a Naval Armament," officially forming today's U.S. Navy, and

Whereas, the U.S. Navy veterans who reside at the Vermont Veterans' Home are observing this special anniversary with pride and memories of their years in naval uniform on land and sea, and the nation is marking the occasion with, among other recognitions, the issuance of commemorative U.S. postage stamps, now therefore be it

House concurrent resolution in memory of distinguished Vermont attorney Richard T. Cassidy of Burlington

Whereas, for 47 years (1978–2025), Richard Cassidy was a distinguished member of the Vermont Bar, and he epitomized the best attributes of an attorney, and his legacy is exemplified through a record of superb leadership at respected State and national professional legal organizations, and

Whereas, a native of Rutland, he graduated from Mount St. Joseph Academy, the University of Vermont, and Albany Law School before completing two successive Vermont Supreme Court clerkships, and he subsequently enjoyed a successful career as a private practitioner, and

Whereas, the Vermont Bar Association (VBA) and its justice access partner, the Vermont Bar Foundation (VBF), were each a beneficiary of his wise counsel, and

Whereas, as a VBA appointee to the VBF Board, Richard Cassidy was an ardent advocate for VBF's mission, and at VBA, he was serving as the outstanding president-elect, and

Whereas, at the American Bar Association (ABA), Richard Cassidy served on the Board of Governors, chaired its Standing Committee on the Delivery of Legal Services, and represented Vermont in the ABA House of Delegates, and

Whereas, in 1994, Governor Dean appointed Richard Cassidy to the Uniform Law Commission (ULC), a pivotal advisor to legislatures and state bar associations on a wide range of statutory topics, and he frequently testified before General Assembly committees on ULC-related legal matters and was honored to serve a term as ULC President, and

Whereas, Richard Cassidy, whose broad array of activities included acting as a special legislative advisor on an impeachment investigation, serving as counsel to the Burlington Police Officers' Association, working as a legal analyst for Channel 5 television news, and chairing the South Burlington School Board, died on April 21, 2025 at 71 years of age, and he is survived by Becky, his wife of 50 years, now therefore be it

Whereas, on March 18, 1850, the Bennington village trustees passed an ordinance establishing the Bennington Fire Department "to consist of such persons and officers, and such number of engine companies and hook and ladder companies as shall from time to time be ordered and directed by said village," and

Whereas, land was acquired and the funding secured for the construction of two firehouses, which became the headquarters for Spartan Engine Company #1 on Pleasant Street near North Street and Protection Engine Company #2 on East Main Street opposite Morgan Street, and

Whereas, over the decades, with the upgrading and modernization of equipment and departmental expansion in a growing community, the two original companies were transformed into today's four highly trained and prepared companies, and

Whereas, the W.H. Bradford Hook and Ladder Company #1 was established on October 28, 1866, and

Whereas, Stark Hose Company #1 is the direct descendant of Spartan Engine Company #1, which from 1871 until 1887 was known as the General Stark Steamer Company, and

*Whereas*, the H.W. Putnam Company #3 was organized on June 20, 1887, and

Whereas, the Eagle Hose Company #4 was formed on February 12, 1894, and all four companies are now located at the central fire station on River Street, and

Whereas, under the outstanding leadership of Chief Nathan Berres, the Bennington Fire Department is proud of the organization's many accomplishments as it celebrates 175 years of volunteer firefighting excellence and looks to the future, now therefore be it

House concurrent resolution congratulating Bennington Lodge No. 567 of the Benevolent and Protective Order of Elks on 125 years of community service and good fellowship

Whereas, Charles Algernon Sidney Vivian inspired the establishment of the Benevolent and Protective Order of Elks (the Elks), a momentous event that occurred in New York City on February 16, 1868, and

Whereas, the purpose of this fraternal organization is "[t]o promote and practice the four cardinal virtues of Charity, Justice, Brotherly Love and Fidelity; to promote the welfare and enhance the happiness of its members; to quicken the spirit of American Patriotism and cultivate good fellowship," and

Whereas, Elks District Deputy P.M. Meldon of Rutland formed Bennington Lodge No. 567 (the Lodge) on July 10, 1900, and John S. Brant served as the first Exalted Ruler of the Lodge until 1902, and

Whereas, originally located at the 300 block of Main Street, in 1912, the Lodge moved to the third floor of the Richie Building at 469 Main Street, and ultimately, in 1945, the Lodge purchased the historic Winslow Home on Washington Avenue, which today remains the Lodge's headquarters, and

Whereas, the Lodge performs the central charitable prong of the Elks' mission through involvement in activities supporting youth (Boy Scouts, Girl Scouts, Little League Baseball, the Hoop Shoot basketball competition, awarding scholarships totaling \$19,000.00 in 2024, sponsoring the Americanism Essay Contest, and promoting drug awareness programs); assisting veterans (constructing a fishing dock, conducting a fishing derby, hosting a Las Vegas Night, sponsoring Christmas events, and hosting dining and entertainment activities); participating in the Elks' State Project (operating Silver Towers Camp in Ripton for children and adults with special needs); and

offering direct community support (by providing Thanksgiving meals and spearheading foster family projects), and

Whereas, the 125th anniversary of the Lodge finds the organization thriving, boasting a growing membership of over 800 enthusiastic Elks, now therefore be it
