H.C.R. 155

Offered by Representatives Masland of Thetford and Holcombe of Norwich

House concurrent resolution honoring Melvin and Susan Coburn for their nearly half-century of superb proprietorship of Coburns' General Store in South Strafford and congratulating the Strafford Community Trust on a successful fundraising campaign to preserve this historic mercantile establishment

Whereas, since the 1880s, South Strafford has been the home of a beloved general store that, for nearly half a century, featured the dedicated proprietorship of Melvin and Susan Coburn, including 27 years when their daughter, Chrissy Jamieson, worked beside her parents for 12-hour days, and

Whereas, the Coburns operated a truly full-service general store, where not only grocery and other in-demand products were sold, but they also hosted a bank, a deer weighing station, a gas pump, a tiny laundromat, and the local U.S. Post Office, and the store also welcomed local nonprofit organizations' bake sales and maintained a lost and found drop-off service, and

Whereas, typical of their hometown relationships, the Coburns extended exceptional kindness to local youngsters, including the then-young and now-popular music star Noah Kahan, but although the Coburns extended a warm welcome to his fans who traveled to South Strafford, the couple faithfully protected the Kahan family's privacy, never revealing a home address, and

Whereas, after decades of ensuring their store was fully stocked and ready to serve customers from near and far, the Coburns desired to step back from their daily duties and sell to a member of the younger generation, and

Whereas, this objective proved challenging, and friends of Coburns' General Store, both in Strafford and nearby Upper Valley communities, spearheaded a successful \$1.8 million fundraising campaign to purchase the store under the rubric of the Strafford Community Trust, and

Whereas, this nonprofit model of general store ownership, which has proven successful in other Vermont communities, is now, with the guidance of

new management, ensuring the continuance and vitality of the store, *now therefore be it*

Resolved by the Senate and House of Representatives:

That the General Assembly honors Melvin and Susan Coburn for their nearly half-century of superb proprietorship of Coburns' General Store in South Strafford and congratulates the Strafford Community Trust on a successful fundraising campaign to preserve this historic mercantile establishment, *and be it further*

House concurrent resolution honoring Timothy McNamara for his outstanding public service in environmental and municipal law enforcement

Whereas, for over three decades of law-enforcement-related employment, Tim McNamara's peers recognized the consistently high caliber of their colleague's professionalism, and

Whereas, Tim McNamara began his tenure at the Agency of Natural Resources (ANR) in 1992 as a temporary underground storage tank inspector in the Department of Environmental Conservation, and in 1995, he accepted a permanent position, resulting in his promotion to assistant hazardous materials specialist, and

Whereas, frequently, the violations Tim McNamara investigated were referred to an ANR environmental enforcement officer (EEO), and he developed a strong interest in a law-enforcement-focused career, and

Whereas, in 1997, Tim McNamara pursued his passion and joined the EEO's ranks, completing the requisite training for the performance of his new assignments, and

Whereas, soon after becoming an EEO, Tim McNamara played a major role in an enforcement proceeding following a fatal hazardous waste explosion that culminated in felony convictions, and

Whereas, in the years that followed, Tim McNamara brought his expertise and skill to investigations centered on the illegal disposal of solid and hazardous waste for profit, the illegal burning of materials, the unpermitted discharges of pollutants into State waters, and the submission of falsified records to State authorities, and

Whereas, his proficiency as an EEO attracted the notice of municipal law enforcement officials, and in 2006, Tim McNamara embarked, initially with trepidation but ultimately with great success, on a parallel part-time second career serving as a local police officer in the towns of Weathersfield (2005–2006 and 2012–2022) and Springfield (2006–2018), and

Whereas, in 2015, the Vermont Criminal Justice Training Council (VCJTC) issued him a Level 2C law enforcement certification, and he also earned VCJTC's authorization to investigate State criminal environmental statutes, and

Whereas, after 33 years, in 2025, Tim McNamara concluded his exemplary ANR investigatory career, *now therefore be it*

Resolved by the Senate and House of Representatives:

That the General Assembly honors Timothy McNamara for his outstanding public service in environmental and municipal law enforcement, *and be it further*

Whereas, as the Division III title holders for the past five seasons, the Panthers were well-suited to extend their victory streak in the championship boys' track and field competition, and

Whereas, at the 2025 decisive meet held at the D.G. Weaver Athletic Complex in Burlington, Thetford Academy athletes scored first in the 100-meter, 400-meter, 800-meter, and 1,500-meter dashes; the 4x100 and 4x800 relays; and the long jump, triple jump, discus, and javelin events, and

Whereas, an exciting coda to the 2025 season was Thetford Academy's largest ever presence at the New England Interscholastic Outdoor Track and Field Championship, where the Panthers set three new Vermont State records, and for the first time earned two championship medals in the long jump and 200-meter dash, and

Whereas, the outstanding Panthers roster featured Hunter Clay, Connor Gaine, Uly Junker-Boyce, Miguel Kutter-Walker, Luke Miller, Liam Murphy, Hardy Payson, Oliver Ransom, Evan Rich, Bryce Rikert, Brady Sloop, Ramona Spellman, David Stangner, Matthew Vivian, Isaac Yukica, Wendell Durham, Daniel Mann, Elijah Renner, Emmett Terry, David Thaxton, Henry Trage, Oliver Emery, Tanner Hardy, Paul Kidd, Jesse Martin, Benjamin Nalette, Kit Payson, Sebastian Perdrizet, Jacob Phelps, Connor Sloop, Jay Hill, David Mitchell, Eli Murphy, and Stone Riegler, and

Whereas, co-head coaches Joel Breakstone and Emily Silver; assistant coaches Cole Chapman, Max Higgins, Charlie Buttrey, Charlize Brown, and Vanessa Riegler; and Team Manager Twyla Weinstein were all thrilled with the Panthers' stupendous success in 2025, *now therefore be it*

Whereas, World War II was personally significant in her life, as that is when she met her future husband, Maurice (Bill) Cooper, then serving in the U.S. Navy; they are the parents of two children, her daughter Deanna surviving, and subsequent generations include three grandchildren and five great-grandchildren, and

Whereas, in later years, she served her community as a poll worker on Election Day and as a volunteer for Red Cross activities, becoming locally famous for providing her special sandwiches, and

Whereas, Shirley Cooper was an active parishioner at her local church, sang in the choir and served as president of the congregation's women's group, and

Whereas, she was an avid skier until 70 years of age and continued her decades-long passion of knitting mittens to donate to local children until just recently, and

Whereas, on November 4, 2025, Shirley Cooper, who believes in the importance of remaining active, became the second Young family sibling to celebrate the joyous occasion of a 100th birthday, an event the Town of Springfield officially commemorated, *now therefore be it*
