House concurrent resolution honoring Mary Houghton of Brattleboro as an extraordinary advocate for sustainable and affordable housing

Whereas, for nearly 40 years, Mary Houghton has envisioned, initiated, and promoted affordable housing in Vermont's communities, and

Whereas, her affordable housing passion can be traced back to 1987, when she began a 20-year tenure as the director of finance at the still-experimental and fledgling Burlington Community Land Trust (BCLT), with its mission to facilitate permanently affordable housing for both renting and ownership through community ownership of the underlying land, and

Whereas, Mary Houghton's leadership at BCLT has been characterized as "foundational to the organization's early growth and enduring success," and "transforming it into one of the most respected community land trusts in the country," and in 2002, the Ford Foundation awarded the organization and its leaders, Houghton and her co-director, Brenda Torpy, the Leadership for a Changing World award, and

Whereas, her standard schedule of being the first to arrive, last to leave, and frequently working weekends, exemplified her dedication and passion for the mission of the BCLT, and resulted in her designation as a co-director, and

Whereas, a critical outcome of her work was the successful merger of BCLT and the Lake Champlain Housing Development Corporation into the larger and greater-resourced Champlain Housing Trust, and

Whereas, Mary Houghton brought her affordable housing expertise to southern Vermont, where for nine years she served as both the finance director and deputy director of the Brattleboro Housing Authority, and

Whereas, more recently, as a volunteer, she has served on the boards of the Windham & Windsor Housing Trust, Brattleboro's Tri-Park Cooperative Housing Corporation, and the Vermont State Housing Authority, and

Whereas, in 2019, the Vermont Housing and Conservation Board presented Mary Houghton with its George Nutting Community Catalyst Award, and

Whereas, aside from her exemplary affordable housing efforts, Mary Houghton has served on the board of the Public Safety Project, a municipal community improvement effort in the Old North End of Burlington, and, since 2019, on the Legislative Apportionment Board, *now therefore be it*

Resolved by the Senate and House of Representatives:

That the General Assembly honors Mary Houghton of Brattleboro as an extraordinary advocate for sustainable and affordable housing, *and be it further*

House concurrent resolution congratulating the St. Albans Town Fire Department on 50 years of remarkable community service

Whereas, in 1975, St. Albans Town decided that the community's fire protection needs necessitated the creation of a separate volunteer fire department, and, as a parting gesture, St. Albans City gave the new organization \$60,000.00 to meet initial expenses, and

Whereas, the St. Albans Town Fire Department recognized the need to disburse large quantities of water in an expedited manner and, under the insightful leadership of its first fire chief, Roy C. Parah Sr. (for whom the firehouse is named), purchased a Maxim water pumper, capable of releasing 1,500 gallons of water per minute, and it also "repurposed a Chevy truck to [deliver water] to hard-to-reach houses and converted two [additional] trucks...into tankers," and

Whereas, initially, firefighting vehicles were painted “OSHA yellow” on the theory that red fire trucks were insufficiently visible, and

Whereas, although the St. Albans City Fire Department considered refraining from assisting colleagues in St. Albans Town, this rivalry ended as the city’s firefighters soon appreciated their neighbors’ support, and

Whereas, the cooperative relationship between the two departments has markedly improved as Matt Mulheron now proudly serves as fire chief for both municipalities, and

Whereas, the once ragtag, and now much-respected, St. Albans Town Fire Department proudly boasts a highly trained roster of firefighters and modern equipment, and

Whereas, in August 2025, current and former St. Albans firefighters gathered to celebrate this historic milestone in the department’s history, *now therefore be it*

Resolved by the Senate and House of Representatives:

That the General Assembly congratulates the St. Albans Town Fire Department on 50 years of remarkable community service, *and be it further*

Whereas, as a University of New Hampshire (UNH) student, Michy Lemay majored in outdoor education and walked on to the extremely competitive ski team, and following her graduation from UNH, she earned a master’s degree at the former Johnson State College, and

Whereas, her career has included employment as a mindfulness instructor at Mt. Mansfield Academy, and she is the co-owner and operator of Rugged Adventures Summer Camp in Stowe, which offers youngsters exciting athletic and nature-centered outdoor summer activities, and

Whereas, Michy Lemay has faced serious health challenges: first, a series of orthopedic setbacks, including five knee surgeries and 18 shoulder dislocations; and then in 2021, she received a breast cancer diagnosis, and

Whereas, she completed a vigorous cancer care regimen of surgery, chemotherapy, and radiation, and has participated in a hormone-free vaccine trial at Massachusetts General Hospital in Boston, and

Whereas, in response to these life-altering events, Michy Lemay has battled back, embarking on an extraordinary mindfulness journey as an alternative way of healing and finding personal peace, and

Whereas, on New Year's Day 2024, Michy Lemay commenced her most ambitious mindfulness odyssey: namely, a one-year, four-season mission to ascend one million feet up Mount Mansfield (the Mansfield Million) primarily on skis (skinning), but also via nonmotorized bicycling and hiking, a project she completed triumphantly on schedule, surpassing her million-feet goal, and

Whereas, another mindfulness foray was her leadership of the Lamoille Area Cancer Network's breast cancer awareness hike, and she has continued to lead similar fundraising initiatives, and

Whereas, Michy Lemay has not only blazed a dedicated path towards a healthier life regardless of enormous personal obstacles but has also served as an inspiring role model for the Stowe community, *now therefore be it*

Resolved by the Senate and House of Representatives:

Whereas, Girl Scout Troop 60336 of Milton, which is affiliated with the Girl Scouts of the Green and White Mountains, annually applies the proceeds of its Girl Scout Cookie Program sales toward a worthy community project that makes a real difference in the town and demonstrates these girl scouts' leadership, teamwork, and commitment to helping others, and

Whereas, a critical component of this project is a set of six raised garden beds designed to support gardeners with disabilities or physical challenges, including persons who are wheelchair users, and

Whereas, registered Girl Scout Juniors who are enrolled in fourth or fifth grade and complete a Junior Journey, such as Troop 60336's community garden project, are eligible for the Bronze Award, the highest honor for this age category of Girl Scouts, and

Whereas, Troop 60336 members Cora-Lyn Fletcher, Josephine Herman, Alice Longo, Harper Gaboriault, Jillian Thompson, Arya Frank, and Faith Owen are deservedly proud recipients of the Girl Scout Bronze Award, in honor of their dedicated effort to develop the rain barrel service at the Milton Community Garden, and Brownie Vivian Fletcher, although not an award- eligible recipient, deserves special recognition for her participation in this worthy endeavor, and

Whereas, Troop 60336's co-leaders Victoria Herman, Jamie-Lyn Fletcher, and Willow Longo were essential for the success of this innovative initiative that will broaden the accessibility of the Milton Community Garden, *now therefore be it*

House concurrent resolution recognizing the unique role of certified registered nurse anesthetists in the Vermont health care system

Whereas, nurses have provided anesthesia to patients for over 150 years, and

Whereas, certified registered nurse anesthetists (CRNAs), also known as nurse anesthetists, were originally designated in 1956, and they are advanced practice registered nurses who are among the nation's most trusted health care professionals, and

Whereas, nationally, nearly 74,000 CRNAs practice in every setting in which anesthesia is delivered, including traditional hospital surgical suites; obstetrical delivery rooms; ambulatory surgical centers; and at the offices of dentists, podiatrists, ophthalmologists, and pain management specialists, and

Whereas, in Pub. L. 99-509 § 9320, Congress extended Medicare coverage to CRNA services, and

Whereas, CRNAs are primary anesthesia providers in rural and underserved communities and for U.S. military personnel, and

Whereas, based on their formal education, field training, board certification, and State licensure, these health care professionals are qualified to make independent judgements regarding a broad scope of anesthesia care, and

Whereas, CRNAs are trusted anesthesia experts, caring for patients safely and compassionately, delivering specialized, cost-effective care to all patients—from newborns to seniors—for every type of procedure in all kinds of facilities, and

Whereas, in addition to anesthesia care, CRNAs are qualified to address the unique health care challenges of some of our sickest patients, including veterans, *now therefore be it*

Resolved by the Senate and House of Representatives:

That the General Assembly recognizes the unique role of certified registered nurse anesthetists in the Vermont health care system, *and be it further*
