Whereas, seldom does a softball team, even one seeded first in playoff competition, tally the stratospheric number of runs that the Golden Horde amassed in Castleton during the 2025 Division IV championship game against the third-seeded Leland & Gray Rebels, and

Whereas, the Golden Horde's early 2-0 lead was temporarily sidelined when the Rebels scored four runs in the fourth inning, but the West Rutlanders proved resilient as they crossed home plate an impressive seven times in the fifth inning and an even more remarkable nine times in the sixth to conclude the game with an unusually powerful 19-4 victory, and

Whereas, the 2025 softball title marked West Rutland High School's class of 2025's sixth athletic crown, truly an enviable achievement, and

Whereas, the fantastic Golden Horde Division IV championship softball players were Isabella Coombs, Peyton Guay, Kennah Wright-Chapman, Aubrey Beaulieu, Camryn Williams, Sohyr Perry, Izzy Griffith, Hayley Raiche, Emily Hopp, Karen Firpo, Bradee Traverse, Olivia Pratt, Sadie McGee, Brianna Gallipo, Rylee Hawkins, Sofia Coombs, Emma Lee, and Emma Haley, and

Whereas, Head Coach Laurie Serrani, assistant coaches Carl Serrani and Mikayla Taylor, student manager Gabby Davis, and athletic trainer Zach Royer were all thrilled with West Rutland's perseverance and amazing success, *now therefore be it*

House concurrent resolution congratulating Twin Valley High School Athletic Director extraordinaire and 500 game-winning boys' soccer coach Buddy Hayford

Whereas, typically, high school graduation concludes students' daily association with their alma mater, but for Buddy Hayford, Twin Valley class of 1975, a different path ensued, and

Whereas, after earning his bachelor's degree at the former Lyndon State College, Buddy Hayford returned home to Twin Valley to commence a legendary career as a physical education instructor, multisport coach, and now, in his 39th academic year, the longest-serving high school athletic director in Vermont, and

Whereas, as a girls' basketball coach, Buddy Hayford compiled an enviable 34-season 437–283 record that included two state titles and four second-place season records, and he has previously coached softball, baseball, and tennis, and in 2026 he will coach track and field for an 11th season, and

Whereas, on September 9, 2025, Buddy Hayford, who, for over 43 years of coaching Wildcats boys' soccer, guided over 350 players on the pitch and clinched 10 divisional titles, summited a new career peak, becoming the first Vermont high school soccer coach, and only the fourth in New England, to clinch a 500th victory, as the Wildcats overwhelmed Green Mountain Union High School 10–1 in a contest that truly reflected this momentous occasion and increased his career boys' soccer coaching record to 500–163–27, and

Whereas, at a postgame ceremony featuring firetrucks, police cars, and banners, current and former coaching colleagues and players exuberantly congratulated Buddy Hayford on this historic milestone, and

Whereas, in recognition of Buddy Hayford's superb teaching and coaching leadership, which he considers as synonymous, Twin Valley has named the school's athletic field in his honor, and the Vermont Principals' Association, the Vermont Basketball Coaches Association, and Lyndon State College have elected him to their respective organizations' halls of fame, *now therefore be it*

House concurrent resolution in memory of former Senator William H. Carris of Wells

Whereas, although born across the Connecticut River in Hanover, New Hampshire, Bill Carris was a proud fifth-generation Vermonter, and

Whereas, as a youth, his enthusiasm for daring winter athletic competitions inspired him to train and succeed as a Junior Olympic ski jumper, and

Whereas, Bill Carris graduated from Rutland High School and the former Castleton State College, where he met his future wife, Barbara Tracy, and then served in the U.S. Army as a financial specialist stationed in Germany, and

Whereas, on returning home to Vermont, he entered his family's business, Carris Reels, a manufacturer of reels for wire and cable packaging, and in 1980 he assumed leadership of the company, transforming this small enterprise into an international industry leader, and

Whereas, in 1995, Bill and Barbara Carris implemented an ESOP (employee stock ownership plan) at Carris Reels, converting the company's ownership into a structure that directly benefitted the staff and became the centerpiece of the corporation's operational philosophy, and

Whereas, beyond his business career, Bill Carris was a passionate philanthropist who was focused on the betterment of his Rutland County community, and

Whereas, in 2006, Bill Carris decided to serve his fellow citizens in the public sector, and the voters of Rutland County elected him to the Vermont Senate for the first of three consecutive terms, where his business knowledge was relied upon during his service on the Committees on Economic Development, Housing, and General Affairs and on Finance, and among his other committee assignments were Institutions, Joint Rules, Judicial Rules, Legislative Information Technology, and Senate Rules, on which he served as vice chair, and

Whereas, this admired Rutland County leader died on October 22, 2025, at 81 years of age, and his survivors include his wife, Barbara; children; and grandchildren, *now therefore be it*

Whereas, the opening set was an exciting and closely played affair, necessitating exceeding the typical 25-point finish mark before the Hornets secured a 26–24 victory, while Essex's overwhelming mastery on the court earned the team a 25–11 second-set win, and although the Comets recovered their offensive stamina in the third set, the Hornets still emerged on top 25–21, for an overall 3–0 game victory, their fifth consecutive undefeated season and a championship title, and the school's 86th consecutive win, and

Whereas, the 2025 Hornets (17–0), who celebrated another triumphant season, were Riley Austin, Anna Hotaling, Rheya Gregory, Reese Gregory, Lucy Walker-Borch, Hannah Knickerbocker, Eleanor Hutton, Riley Hammond, Emma Orlow, Abigail Desilets, Mia Eklof, and Lia Wolinsky, and

Whereas, Head Coach Jennifer Liguori and assistant coaches Hope Lagemann and Phil Reynolds provided insightful guidance all season, *now therefore be it*

Whereas, in a tightly played first set, Essex emerged on top 25–22, although the Cougars rebounded in the second set 25–18, guaranteeing at least a fourth set of play, and

Whereas, in the third set, the reenergized Hornets proceeded to defeat the Cougars convincingly 25–15, and despite a final Cougar surge, Essex prevailed 25–22 in the fourth set, clinching a 3–1 game victory and the long-awaited first State crown, and

Whereas, cohead coaches Dylan Lamere and Gary Randall proved great strategists for the team, *now therefore be it*

House concurrent resolution designating February 5, 2026, as Outdoor Recreation Day at the State House

Whereas, Vermont is proud of its unparalleled and diverse natural landscape and communities tied to outdoor recreation that are world-class tourism destinations, and

Whereas, our State's outdoor recreational assets consist of more than 11,500 miles of public access trails, including 217 miles of recreational rail trails; 135,000 acres of wildlife management areas; 239,000 acres of State forests and parks; 99 picnic/day-use areas; 196 fishing access points; and 20 alpine and 30 cross-country ski areas, and

Whereas, ninety-three percent of Vermonters annually participate in outdoor recreation, and in 2012 Acts and Resolves No. 77, the General Assembly designated skiing and snowboarding as the State's official winter sports, and

Whereas, it is important that Vermont welcomes everyone to enjoy outdoor recreational pursuits, and outdoor recreational venues embrace the intrinsic community values of inclusion and representation, and

Whereas, outdoor recreation creates business opportunities, attracts new residents, and offers workforce pathways that incentivize young Vermonters to remain in the State, and

Whereas, according to the U.S. Bureau of Economic Analysis, in fiscal year 2023, businesses in all 14 counties involved in outdoor recreation generated \$2.1 billion in economic impact, and the industry employed over 16,000 persons, comprising just over five percent of the Vermont workforce, and

Whereas, Move Forward Together Vermont, Vermont's Statewide Comprehensive Outdoor Recreation Plan, establishes a vision to foster healthy and vibrant communities through outdoor recreation, and

Whereas, Vermont Outdoor Recreation Day is an occasion to celebrate the importance of outdoor recreation to Vermont's landscape, economy, quality of life, and the mental and physical well-being of Vermonters and visitors, *now therefore be it*

Resolved by the Senate and House of Representatives:

That the General Assembly designates February 5, 2026, as Vermont Outdoor Recreation Day at the State House, *and be it further*

Resolved: That the Secretary of State be directed to send a copy of this resolution to the Secretary of Commerce and Community Development; the Secretary of Natural Resources; the Commissioner of Forests, Parks and Recreation; and the Commissioner of Tourism and Marketing.

Whereas, Vermont's park and recreation programs are an integral part of our State and local communities, and

Whereas, their presence in a community promotes an active lifestyle, offers environmental protection, and serves as an economic resource, and

Whereas, park and recreation programs support the effectiveness of therapeutic recreational services for persons with disabilities, and

Whereas, in 1985, the National Recreation and Park Association established July as Park and Recreation Month, and, in 2009, the U.S. House of Representatives adopted H.R. 288, a resolution "Recognizing the importance of park and recreation facilities and expressing support for the designation of the month of July as 'National Park and Recreation Month,'" *now therefore be it*

Resolved by the Senate and House of Representatives:

That the General Assembly recognizes July 2026 as Park and Recreation Month in Vermont and designates July 17, 2026, as Vermont Park and Recreation Professionals Day, *and be it further*

Resolved: That the Secretary of State be directed to send a copy of this resolution to the Vermont Recreation and Parks Association.

H.C.R. 184

Offered by Representative Pritchard of Pawlet

House concurrent resolution celebrating the restoration of a wild turkey population in Vermont

Whereas, in the rural countryside in Pawlet, Vermont, on February 28, 1969, wildlife biologist Bill Drake of the Vermont Fish & Game Department undertook a historic and visionary act, releasing wild turkeys back into their native habitat and setting in motion the successful restoration of the species statewide, and

Whereas, by the late 19th century, wild turkeys had been eliminated in Vermont due to widespread forest clearing and unregulated subsistence harvesting, leaving generations of Vermonters without the sight or sound of this iconic bird, and

Whereas, the wild turkey restoration effort was made possible through funding from federal excise taxes on firearms and ammunition under the Pittman-Robertson Wildlife Restoration Act, supplemented by state hunting license revenues, demonstrating the enduring value of conservation partnerships, and

Whereas, Bill Drake traveled to Steuben and Allegany Counties in New York to trap and transport wild turkeys for reintroduction into Vermont, resulting in the release of 17 birds—five toms and twelve hens—between February 28 and March 31, 1969, at two sites in Pawlet, and

Whereas, subsequent releases in Hubbardton and Rockingham further strengthened the restoration effort, and these birds became the ancestors of the wild turkeys that now inhabit every region of Vermont, and

Whereas, the success of this program was confirmed in 1973 with the establishment of Vermont's first regulated wild turkey hunt in southern Vermont, during which 579 permits were issued for a twelve-day season, and

Whereas, today, wild turkeys are once again a natural and thriving part of Vermont's landscape, as emblematic of the state's forested hillsides and sugar maples, providing ecological benefits, recreational opportunities, and sustenance for Vermonters, and

Whereas, the restoration of the wild turkey would not have been possible without the cooperation and stewardship of farmers and landowners throughout Pawlet and southern Vermont, whose full-hearted participation ensured the program's lasting success, and

Whereas, this gallant endeavor is now memorialized with a commemorative marker located in the Town of Pawlet, *now therefore be it*

Resolved by the Senate and House of Representatives:

That the General Assembly celebrates the restoration of a wild turkey population in Vermont, *and be it further*

Resolved: That the Secretary of State be directed to send a copy of this resolution to the Pawlett Historical Society.
