House concurrent resolution in memory of Bennington Town Manager Stuart Alan Hurd

*Whereas*, during his over half-century of innovative municipal public service in the Town of Bennington, Stuart Hurd adeptly applied the hands-on problem-solving skills that he had studied as a civil engineering student at Worcester Polytechnic Institute, and

*Whereas*, in 1973, while visiting a friend in Vermont, the Connecticut native read a job announcement from the Town of Bennington seeking the community's first zoning administrator, and his hiring benefitted the future of Bennington in ways never imagined, and

*Whereas*, having proven an effective zoning administrator, the Bennington Selectboard subsequently chose Stuart Hurd to serve as assistant town manager and, ultimately, in 1992, named him town manager, launching a historic tenure in this role that lasted for nearly 33 years, only 18 months short of the State's longevity record for a town manager, and

*Whereas*, Stuart Hurd was known for his unparalleled dedication to the community and for his calm demeanor, and

*Whereas*, in 2008, the Vermont League of Cities and Towns honored him with its prestigious Vermont Municipal Service Award, and

*Whereas*, Stuart Hurd's community leadership included roles on the former Bennington School District Board and with local nonprofit organizations, and

*Whereas*, outside his professional life, Stuart Hurd embraced the arts, including as an amateur watercolorist who created Christmas cards; enthusiastically played in Bennington's men's basketball and softball leagues; enjoyed international travel; and spent quality time with his family, and

*Whereas*, Stuart Hurd died at 77 years of age on August 30, 2025, following a four-year battle against cancer, and his survivors include his spouse, D. Justine Scanlon; and in his honor, the Town of Bennington flew the municipality's flags at half-mast for five days, representing each of his five decades of exemplary municipal public employment, *now therefore be it*

House concurrent resolution in memory of North Bennington educator, coach, volunteer firefighter, and religious leader Robert P. Nolan

*Whereas*, Bob Nolan graduated from North Bennington High School, attended the University of Vermont, earned a bachelor's degree in education from the former Castleton State College, and served in the U.S. Army, and

*Whereas*, for three decades, he was a respected sixth-grade teacher at North Bennington Elementary School, but his involvement with local youth extended beyond the classroom to many athletic fields, drawing on his experience as a college sportsman, and

*Whereas*, at North Bennington High School, Bob Nolan coached basketball, cross-country, and track, and aside from school sports, he coached PONY league baseball, assisted with American Legion Baseball, and organized church youth group basketball competitions, and

*Whereas*, perhaps Bob Nolan's most impactful civic role in North Bennington was his 70-year volunteer membership in the North Bennington Fire Department, including 40 years as the organization's dedicated president, overseeing administrative matters, dousing many a blaze, and attending to other emergencies, and

*Whereas*, his leadership roles at the North Bennington Congregational Church included trustee, deacon, moderator, and occasionally serving as the congregation's lay minister, and

*Whereas*, later in life, Bob Nolan developed a second career as a house painter, and

*Whereas*, he loved to hunt and fish, was actively involved as both a volunteer and manager in the preservation and supervision of Lake Paran as a community resource, and was a member of both the Loyal Order of Moose and the American Legion, and

*Whereas*, Bob Nolan, a cherished citizen of North Bennington, and a man with a great sense of humor who truly made the village a better place to live, died at 93 years of age on October 11, 2025, and his survivors include his wife of 72 years, Florence; his children; grandchildren; great-grandchildren; and great-great grandchild, *now therefore be it*

*Whereas*, the military and civilian careers of Gregory Knight represent the best attributes of public service and patriotism, and his 43 years in uniform commenced in 1983 with a six-year U.S. Coast Guard enlistment, and

*Whereas*, upon leaving the U.S. Coast Guard, Gregory Knight served for four years as a Burlington police officer and then seven years as the Chief Liquor Investigator at the former Department of Liquor Control, and

*Whereas*, concurrently, for seven years, he was an enlisted member of the Vermont Air National Guard, working as a security forces specialist, drawing on his law enforcement expertise, and

*Whereas*, in 1997, the trajectory of his military service assumed a new path; he was a commissioned graduate of Officer Candidate School, for three years he served as a Vermont Army National Guard officer, and in 2000, he began full-time Active Guard Reserve duty, and

*Whereas*, starting in June 2005, Gregory Knight completed a one-year deployment to Ramadi, Iraq, as a battle captain for Task Force Saber, and

*Whereas*, since 2001, Gregory Knight advanced educationally, earning several academic degrees, including a master's degree from the U.S. Naval War College in Newport, Rhode Island, and he assumed increasingly important roles, reaching the rank of U.S. Army Major General, and he received many military honors, including a Bronze Star Medal, and

*Whereas*, in 2019, recognizing U.S. Army Major General Gregory Knight's superb qualifications, the General Assembly elected him as Vermont Adjutant and Inspector General, the State's highest ranking military officer, and

*Whereas*, Adjutant and Inspector General Gregory Knight's outstanding seven-year tenure featured the 2021 welcoming of Austria to the State Partnership Program, and he can reflect on his military service with great pride, *now therefore be it*

*Whereas*, a selection of the highlights of the Y's 175-year odyssey include conducting the first night school and English as a Second Language (ESL) classes, inventing basketball, offering the first group swimming lessons, serving as the birthplace of Father's Day, receiving the Nobel Peace Prize in 1946 for the achievement of its National War Work Council, serving as America's leading nonprofit provider of child care and afterschool programs, and offering important community support services during the pandemic, and

*Whereas*, nationwide, 2,600 Ys, located in every state and territory, receive support from more than 300,000 staff and 350,000 volunteers, and they annually serve 6.5 million children and 11 million adults, and

*Whereas*, in Vermont, the YMCA of Greater Burlington and the Meeting Waters YMCA (established in 1895) serve 15,000 Vermonters through the diligent efforts of 600 staff and 80 volunteers, and

*Whereas*, during this anniversary year, Ys across the country will celebrate with special commemorative events, *now therefore be it*

*Whereas*, adventurous, attentive, engaging, and welcoming all describe the amazing Nathan Suter, whose life was sadly abbreviated, and

*Whereas*, born in the Panama Canal Zone, Nathan Suter grew up in Poughkeepsie, NY, developing his prowess as a long-distance runner, and

*Whereas*, at Haverford College, he captained the cross-country track and field team and earned a fine arts degree in photography, and he subsequently graduated with a master's degree from San Francisco Art Institute, and

*Whereas*, in 2002 in San Francisco, he cofounded Root Division, which offers subsidized studios to artists in exchange for teaching or curating art exhibits, and

*Whereas*, several years after his 2001 marriage to Vermonter, and now Montpelier Union Elementary School teacher, Morgan Lloyd, the couple moved to the Green Mountain State, where they raised their children, Amani and Asa, and in Stowe, Nathan Suter served for a decade as executive director of what is now known as the Current, an art center, and

*Whereas*, his curatorship was bold and daring, and gave the Current a reputation for artistic innovation and excellence, and included nurturing and expanding the educational program to serve more than 500 students, and

*Whereas*, in 2016, Nathan Suter decided to venture into a new career as an organizational management consultant, establishing his own firm, which he creatively named BUILD, and

*Whereas*, a passion for community engagement and social activism led to long-term board service at Migrant Justice and the Peace & Justice Center, and he played a pivotal role on the Montpelier Commission for Recovery and Resilience, which was formed after the devastating 2023 flood, and

*Whereas*, his contribution to the youth of Montpelier as a respected and popular track and field coach, first at Main Street Middle School, and more recently at Montpelier High School, helped rejuvenate a small program into a highly popular school activity, and

*Whereas*, the sudden death of Nathan Suter at 52 years of age on May 13, 2025, while running, saddened and shocked his wife, children, and the Montpelier community, *now therefore be it*

[and also] ... faces significant challenges with alcohol consumption and abuse,” a fact that the State’s high rates of binge drinking and alcohol abuse document, and

*Whereas*, according to the U.S. Substance Abuse and Mental Health Services Administration, 10.3 percent of Vermont youth (12–17 years of age) reported illicit drug use during the prior month, and Vermont ranks 48th among the states in this category, and

*Whereas*, the Vermont Association for Mental Health and Addiction Recovery (VAMHAR), a statewide nonprofit organization established in 1939, “embrace[s] the full spectrum of the human experience—with compassion and acceptance...” and works to strengthen collaboration across agencies, providers, employers, and communities in its effort to ameliorate substance abuse, and

*Whereas*, peer-led recovery centers and residences across the State have coalesced as Recovery Partners of Vermont, and this multimember organization serves on the front line of supporting individuals in their journeys from active addiction to lives in recovery, and

*Whereas*, both these organizations, in coordination with State agencies, community partners, employers, and Vermonters with lived experiences, are intensifying their collaboration to break down silos and build coordinated, community-rooted pathways to recovery, and these partnerships greatly benefit the well-being of all Vermonters, and

*Whereas*, on February 11, 2026, Vermonters involved in the recovery process gathered at the State House to celebrate progress and educate legislators concerning these initiatives, and a broader public knowledge of these efforts is vitally important, *now therefore be it*

***Resolved by the Senate and House of Representatives:***

That the General Assembly designates February 2026 as Recovery Awareness Month in Vermont, *and be it further*

***Resolved:*** That the Secretary of State be directed to send a copy of this resolution to VAMHAR and Recovery Partners of Vermont.
