### H.C.R. 239

Offered by All Members of the House

House concurrent resolution congratulating the winning teams at the 18th annual Jr Iron Chef VT culinary extravaganza

*Whereas*, Jr Iron Chef VT, convened most recently on March 14, 2026, at the Champlain Valley Exposition, provides an ideal opportunity to promote the agricultural, economic, educational, and nutritional benefits of Vermont's Farm to School initiative, while the aspiring chefs learn the importance of collaboration and explore a potential career option, and

*Whereas*, since 2008, over 5,000 secondary school students cooking on more than 1,000 teams have competed, and, in 2026, 55 teams consisting of 253 students and representing 37 schools or organizations participated, and

*Whereas*, each team, competing in either a middle school or high school cohort, vied for three honors: Lively Local, recognizing the team that best highlighted Vermont foods; Mise en Place, showcasing the team that exhibited exemplary teamwork, order, and professionalism; and Crowd Pleaser, bestowing credit on the team that best incorporated color, texture, and taste, and the award recipients, including their school name, team name, and culinary creations, in 2026 were as follows:

**Lively Local:** Mary Hogan School, Gourmet Hawks, Vermont country risotto with maple cream and black currant compote; First Branch Middle School, Deviled Chefs, curry-flavored fettucine; and Mt. Mansfield Union High School, MMU Wild Pestonians, pesto fettuccine with portobello mushrooms, caramelized onions, and lemon ricotta;

**Mise en Place:** Mt. Abraham Unified School District Expanded Learning Program, Bald Eagles, three-cheese ravioli with oven-roasted tomato sauce; Derby Elementary School, Sweet Heats, BLT tamales with pickle pesto and sweet heat sauce; and Lake Region Union High School, Roger's Raccoons, "Raccoons Gone Curry-ous"; and

**Crowd Pleaser:** Albert D. Lawton Intermediate School, ADL PMO casserole with hot honey; Winooski Middle School, Wild Chives, "Cafeteria

Gone Wild Corn Dogs”; and Champlain Valley Union High School, the Llinis, sweet potato tortellini with miso butter sauce, *now therefore be it*

House concurrent resolution congratulating Stephen R. Bissette on his designation as the sixth Vermont Cartoonist Laureate

*Whereas*, in a nationally unique collaboration between the Center for Cartoon Studies in White River Junction and the Vermont Arts Council, the Vermont Cartoonist Laureate program advances the recognition of comics as a distinctive and powerful artistic medium, spanning graphic novels, journalism, children’s literature, and other forms of storytelling, and

*Whereas*, the graphic artists previously so honored were James Kochalka, Ed Koren, Alison Bechdel, Rick Veitch, and, most recently, Tillie Walden, and

*Whereas*, the newly designated sixth Vermont Cartoonist Laureate is Stephen R. Bissette of Windsor, a Waterbury native and a 1973 graduate of Harwood Union High School (and a 2025 inductee into the school’s hall of fame), and, professionally, he is a proud alumnus of the Joe Kubert School of Cartoon and Graphic Art’s first graduating class, an internationally recognized and honored cartoonist and publisher, a dedicated artists’ advocate who was a signatory of the 1988 Creator’s Bill of Rights, and a founding faculty member of the Center for Cartoon Studies, and

*Whereas*, in 1976, prior to enrolling at the Kubert School, Stephen R. Bissette began his comics publishing career with *Abyss*, and his reputation as a leading comic book artist and groundbreaking contributor to the medium’s horror genre were confirmed when he served as the cocreator and an artist (with Alan Moore and John Totleben) of *Saga of the Swamp Thing*, a comic series that introduced the enduring character of John Constantine, and

*Whereas*, his career contributions to comic book creation and publication have ranged from the dinosaur epic *Tyrant*, the adaptation of Steven Spielberg’s film *1941* as a graphic novel, *Teenage Mutant Ninja Turtle*

projects, and as the cocreator and coeditor (again, in collaboration with John Totleben) of the influential *Taboo* anthology, and he introduced an important outlet for independent comic book publishing and a home for boundary-pushing creators, and

*Whereas*, Stephen R. Bissette, whose graphic artistry has extended to many unique applications, is the winner of top professional honors, including multiple Jack Kirby Comics Industry Awards, the Inkpot Award, and the Eisner Award, all outstanding credentials for this career recognition, *now therefore be it*

House concurrent resolution congratulating University of Vermont Distinguished Professor and Vermont Climatologist Dr. Lesley-Ann Dupigny-Giroux on winning the Mani L. Bhaumik Award for Public Engagement with Science

*Whereas*, one of the truly remarkable faculty members of the University of Vermont (UVM) is Distinguished Professor of Geography and Geosciences and Vermont State Climatologist Dr. Lesley-Ann Dupigny-Giroux, and

*Whereas*, a graduate of the University of Toronto, she holds graduate degrees from McGill University in Montreal, including a doctorate in climatology and geographic information systems, and her research interests encompass “hydroclimatic natural hazards and climate literacy, climate services, [and] geospatial climate and land-surface processes,” and

*Whereas*, Dr. Dupigny-Giroux is a leading expert on “floods, droughts and severe weather and the ways in which these affect the landscape and peoples of Vermont [and the northeastern United States],” and

*Whereas*, her teaching portfolio examines climatology, physical geography, and remote sensing, and beyond the UVM campus, she has worked extensively

with K–12 teachers and students, incorporating satellite usage into pre-college climatology curriculums, and

*Whereas*, she is a fellow of the American Meteorological Society, currently serves on three National Academy of Sciences panels, and is a past president of the American Association of State Climatologists; as a researcher and applied climatologist, Professor Dupigny-Giroux has contributed to all five national climate assessments, including serving as the lead author for the northeast chapter of the rendition, and has held leadership positions on Vermont and federal climate-associated initiatives, and

*Whereas*, recently, the American Association for the Advancement of Science bestowed on her one of its premiere tributes, the Mani L. Bhaumik Award for Public Engagement with Science, recognizing the “demonstrate[d] excellence ... [of her] contribution to public engagement with science,” and her extraordinary career as an admired scholar and public official uniquely qualified her for this distinct honor, *now therefore be it*

House concurrent resolution congratulating the 2026 Mount Anthony Union High School Patriots on winning the Division I boys’ Nordic skiing championship

*Whereas*, Nordic skiing competition tests skiers’ agility and speed as they race across the snow-covered course, and, annually, the best high school Nordic skiers engage in individual and team competition at the State championship meet, and

*Whereas*, in 2026, the first day's freestyle races were held at the Rikert Outdoor Center in Ripton and the competition concluded with the classic races at the Craftsbury Outdoor Center, and

*Whereas*, in a clean sweep of their Division I competitors, the Patriots boys won all four races: the classic, in which three Mount Anthony skiers finished among the top eight; the classic relay; the freestyle; and the freestyle relay, and

*Whereas*, this unusual accomplishment enabled the Patriots to limit their point tally to 87 (in Nordic skiing, the better the performance, the lower the score) and easily top second-place Champlain Valley Union High School, which scored 150 points, and

*Whereas*, this talented Patriots Nordic skiing contingent consisted of Carson Andrick, Eli McEnaney, Henry Morrison, Liam Mulligan, Hunter Favreau, Abeh Woods, Max Cutsumpas, Orion Breese, Colin Gulley, Quentin Phillips, and Edgar Ostler, and

*Whereas*, this grand skiing adventure would not have been possible without the expert guidance of Head Coach Rob Short and Assistant Coach Gabe Niles, *now therefore be it*

*Whereas*, for the second consecutive year, the Slaters emerged triumphant on championship day with a 60–47 roll-off victory, and cheering supporters escorted the team from Route 4 back to Fair Haven Union High School, and

*Whereas*, the great 2026 Slater bowlers were Yuki Adams-Silva, Amber Lynn Haley, Reagan Stamp, Eli Donaldson, George Stamp, In Shik Adams-Silva, Michael Towle, Dylan Bania, Aiden Goyette, Nathan Bessette, Madison Stamp, Wyatt Delance, and Kaemon Adams-Silva, and

*Whereas*, Head Coach Joe Donaldson and Assistant Coach Ron Carrara were outstanding team mentors, *now therefore be it*

House concurrent resolution recognizing the week of April 11–17, 2026, as Black Maternal Health Week in Vermont

*Whereas*, according to a research compendium that KFF, an independent health research organization, issued in December 2025, there are stark racial disparities in the nation’s maternal and infant care health outcomes that are highly unfavorable for Black Americans, and

*Whereas*, for example, the National Center for Chronic Disease Prevention and Health Promotion’s Division of Reproductive Health reported that, in 2023, the pregnancy-related mortality rate per 100,000 births for Black

American women was 49.4, while for white American women it stood at a far-lower 14.9, and

*Whereas*, also in 2023, the Center for Disease Control and Prevention’s National Center for Health Statistics recorded 10.9 Black American infant deaths per 1,000 live births, and the comparable figure for White American infants was 4.5, and

*Whereas*, the Black Mamas Matter Alliance (BMMA) is “an [a]lliance of perinatal, maternal, and reproductive health Black and women-led organizations and multidisciplinary professionals ... [that seeks] to build consensus and articulate priorities ... from those doing work within ... [the] communities [of Black American women],” and

*Whereas*, among the organization’s goals are to “cultivate innovative research methods ... to improve Black maternal health ... introduce and enhance holistic and comprehensive approaches to Black mamas’ care ... [and] redirect and reframe the conversation on Black maternal health and amplify the voices of Black mamas,” and

*Whereas*, annually, BMMA designates Black Maternal Health Week, which, in 2026, is from April 11 to 17, and this year the week’s mission is “to center the voices, leadership, and lived experiences of Black mothers while advancing community-led systems change rooted in healing, trust, and collaboration,” and

*Whereas*, coinciding with this mission is the theme, “Rooted in Justice & Joy: 10 Years of Building the Black Maternal Health Movement,” both honoring “a decade of groundbreaking work that has transformed the landscape of Black Maternal Health in the U.S,” and “acknowledging the persistent challenges that demand continued innovation and action,” *now therefore be it*

***Resolved by the Senate and House of Representatives:***

That the General Assembly recognizes the week of April 11–17, 2026, as Black Maternal Health Week in Vermont, *and be it further*

*Whereas*, tourism and hospitality are two of the largest industries in Vermont, creating 31,780 jobs, and

*Whereas*, tourism and hospitality are vital to the sustainability of rural and urban communities alike, across all 14 counties, and

*Whereas*, meaningful representation and inclusion are essential to ensure Vermont is welcoming to individuals from all backgrounds so that they can experience the joy of visiting the State, and

*Whereas*, industry leaders who prioritize community values in their work and promote destination stewardship benefit Vermonters and the State's economy, *now therefore be it*

*Whereas*, in Vermont, there are 13 Child Advocacy Centers (CACs) focusing on the challenges and solutions to the continuing prevalence of child abuse in our State, and

*Whereas*, these important organizations provide critical support and representational services to children whose needs can be acute and who rely on the centers to assist in transforming their lives, which may be harsh, into a potentially more promising future, and

*Whereas*, a CAC provides "forensic interviews, a safe meeting space, victim advocacy, and coordinated care to children that report sexual and physical abuse," and the 13 CACs operate collectively as the Vermont Children's Alliance (VCA), and

*Whereas*, the vision of the VCA is "to empower Vermont's CACs to provide equal and reliable access to support, treatment, justice, and healing for every child," and

*Whereas*, more specifically, the mission of the VCA is to "foster the growth of the CAC movement by providing statewide support and resources, promoting awareness of child abuse and its impact on our communities," and

*Whereas*, today, April 10, 2026, representatives of the VCA and its member CACs are visiting the State House to educate legislators on the importance of addressing the continuing problems associated with the abuse of our youngest Vermonters, *now therefore be it*

***Resolved by the Senate and House of Representatives:***

That the General Assembly designates April 10, 2026, as Vermont Children's Alliance Day at the State House, *and be it further*
