Remarks Journalized

On motion of **Rep. Birong of Vergennes**, the following remarks by **Rep. Black of Essex** were ordered printed in the Journal:

“Madam Speaker:

I’m sorry. Bear with me, please. I always say that I’m just a soccer mom from Essex. I didn’t come from the world of advocacy and the things and people that I’ve been exposed to in my life frankly, I’ve been a little sheltered. Now I’m in this weird little world that we all belong to, and you meet people along the way. You are also exposed to new people and new experiences, and then, every once in a while, you meet someone, and they end up like your soul sister. For a little soccer mom from Essex, one of the people that I have met in this weird little world, ended up being one of my best friends. She would find this very funny because we joked about it all the time. I want to recognize the passing of someone that we all may have seen around the State House a lot, working in advocacy throughout the State of Vermont. I asked someone to give me a synopsis of her c.v. because, frankly, my best times with her were spent over beer. She was a retired zoning administrator, a selectboard member for the Town of Bakersfield, and Commissioner for the Vermont Commission on Women. She was a cabinet member of Emerge Vermont, and a fierce advocate for the LGBTQIA Alliance. Two days ago, we lost Brenda Churchill, and I wanted to recognize her. We lost someone truly great in this State. She was a friend to me, and a friend to so many in this Chamber. So, have a beer this weekend in memory of Brenda. She’d like that. Thank you.”
