House concurrent resolution congratulating the 2024 University of Vermont Catamounts on winning their school's first NCAA Division I men's soccer championship (College Cup)

Whereas, the saga of the 2024 University of Vermont (UVM) men's soccer squad, affectionately known as the "Cardiac Cats" in honor of their late game-winning goals, exceeds the allure of a Grimm Brothers' fairy tale, and

Whereas, although they were the 2024 America East men's soccer champions, unseeded UVM astounded the pundits as the Catamounts reached the coveted semifinal round, winning this penultimate soccer challenge against the third-seeded University of Denver in a thrilling 4–3 overtime triumph, and

Whereas, in the championship game, played at the WakeMed Soccer Park in Cary, North Carolina, and bound for legendary status, UVM faced 13th-ranked Marshall University; and despite Marshall scoring first at the 67-minute mark, UVM rebounded with a goal in the 81st minute, forcing the game into a climactic overtime period, when the Cardiac Cats (16–2–6) clinched the NCAA title with a decisive goal less than five minutes into the extra time frame, and

Reported in favor of its passage when amended by striking out all after the enacting clause and inserting in lieu thereof the following:

Sec. 1. 13 V.S.A. § 1455 is amended to read:

§ 1455. HATE-MOTIVATED CRIMES

(a) A person who commits, causes to be committed, or attempts to commit any crime and whose conduct is motivated, in whole or in part, by ~~the victim's~~ another person's or a group of persons' actual or perceived membership in a protected category shall be subject to the following penalties:

(1) If the maximum penalty for the underlying crime is one year or less, the penalty for a violation of this section shall be imprisonment for not more than two years or a fine of not more than \$2,000.00, or both.

(2) If the maximum penalty for the underlying crime is more than one year but less than five years, the penalty for a violation of this section shall be imprisonment for not more than five years or a fine of not more than \$10,000.00, or both.

(3) If the maximum penalty for the underlying crime is five years or more, the penalty for the underlying crime shall apply; however, the court shall consider the motivation of the defendant as a factor in sentencing.

(b) ~~The victim's~~ A person's or a group of persons' actual or perceived membership in a protected category or categories need not be the predominant reason or the sole reason for the defendant's conduct.

(c) As used in this section, "protected category" includes race, color, religion, national origin, sex, ancestry, age, service in the U.S. Armed Forces or the National Guard, disability as defined by 21 V.S.A. § 495d(5), sexual orientation, gender identity, and perceived membership in any such group.

Sec. 2. EFFECTIVE DATE

This act shall take effect on July 1, 2025.

The Committee on Government Operations and Military Affairs considered the request of Bruce Busa for the House to judge the election and qualification of its member in House District Bennington-1. The Committee affirms the certified election results and finds that Representative Jonathan Cooper of Pownal was duly elected and is qualified to represent House District Bennington-1 as a member of the House of Representatives.

Thereupon, **Rep. Birong of Vergennes** moved to accept the report.

Pending the question, Shall the House accept the report of the Committee on Government Operations and Military Affairs on the House District Bennington-1 Contested Election?, **Rep. Higley of Lowell** demanded the Yeas and Nays, which demand was sustained by the Constitutional number. The Clerk proceeded to call the roll and the question, Shall the House accept the report of the Committee on Government Operations and Military Affairs on the House District Bennington-1 Contested Election?, was decided in the affirmative. Rep. Coffin of Cavendish provided the following vote explanation:

“Madam Speaker:

If this vote is truly about the disenfranchisement of the voters in Bennington-5, then we need to revote Bennington-5. As we found out that 14 voters in that district had the wrong ballots. We cannot ignore those voters if we believe that others have been disenfranchised. On the weight of this and the voices of my constituents as expressed to me, I must vote to revote.”

Rep. Houghton of Essex Junction provided the following vote explanation:

“Madam Speaker:

I voted yes to support the hard work of the committee in a very hard situation, and their commitment to continue their work so this situation doesn’t happen again. Thank you.”

Rep. Maquire of Rutland City provided the following vote explanation:

“Madam Speaker:

I voted no because I am deeply concerned that if this situation does occur again, it has a precedent that has been set by our response and decision today.”

Rep. Morrissey of Bennington provided the following vote explanation:

“Madam Speaker:

I vote ‘No’ this morning on the House District Bennington-1 Contested Election Special Report because there needs to be a fair and legal process put in place for Vermont’s voters to feel that their vote counted. My vote does not reflect my preference of one candidate over the other, for I have respect for both candidates. Nor does it have anything to do with which political party either of the candidates belongs to. I would be voting the same way if the shoe

was on the other foot today. My vote today reflects the need for a process that upholds the integrity of our democracy and the premise that a voter's vote truly does count.”

Rep. Olson of Starksboro provided the following vote explanation:

“Madam Speaker:

I’m voting ‘Yes.’ I rely on the 9-1-1 vote of the committee members who heard and considered all of the testimony.”

Remarks Journalized

On motion of **Rep. Hango of Berkshire**, the following remarks by **Rep. Birong of Vergennes** were ordered printed in the Journal:

“Madam Speaker:

Over the past four weeks, the House Committee on Government Operations and Military Affairs considered history, legal precedent, and practice during a review and judgment of the Bennington-1 election.

Based on the testimony of the House Clerk, Legislative Counsel, the Attorney General, and the Secretary of State, we determined that the House has the sole authority to judge the qualifications of its members. No court or other branch of our State government has the authority to make this determination.

As we evaluated the decisions made by prior chambers, we found procedural guidance on how to resolve disputed elections and recounts but discovered no identical match to the facts of the Bennington-1 election. We considered past contested legislative elections, in particular elections that took place in 1983 and 1973, as they held the most similarities to this case. In the absence of a clear path to follow, the Committee was left to consider the will of the voters, the integrity of the House, and the authority and limitations set forth by the Vermont Constitution.

Ultimately, the Committee focused on two possible paths: the House could choose to affirm the certified election of the currently seated Representative, or the House could choose to structure a revote. Based on all available research, the House had never previously ordered a revote or special election in response to a request to judge the election and qualification of a member.”

As the Committee deliberated, it was apparent that a revote would not be a satisfactory remedy for this contested election. A revote could not recreate the time and context of the initial election. Accordingly, the Committee determined that the best course of action was to affirm the certified election of Representative Jonathan Cooper.

Madam Speaker, the Committee on Government Operations and Military Affairs considered the request of Bruce Busa for the House to judge the election and qualification of its member in House District Bennington-1. The Committee affirms the certified election results and finds that Representative Jonathan Cooper of Pownal was duly elected and is qualified to represent House District Bennington-1 as a member of the House of Representatives.”
