House concurrent resolution in memory of the Venerable J. Stannard Baker of Shelburne

*Whereas*, Stan Baker, whose forebears were Green Mountain Boys and whose names are reflected in the towns Bakersfield and Stannard, wrote his own page of Vermont history, and

*Whereas*, a Swarthmore College graduate, Stan Baker was a co-founder of and teacher at the Otter Creek School, a registered play therapist, a licensed mental health counselor, and a mental health clinical director in Addison and Chittenden Counties, and

*Whereas*, in the 1990s, he and his life partner, Peter Harrigan, Professor of Fine Arts: Theater at St. Michael's College, desired to marry, but as a same-gender couple this was legally impossible, and

*Whereas*, in partnership with two other LGBTQ+ couples, they sued for the right to marry, and in 1999, the Vermont Supreme Court, in the landmark decision, *Baker v. State*, 170 Vt. 194, established marriage equality under the Vermont Constitution, and the holding lead to Act 91 of 2000 establishing civil unions, and ultimately, Act 3 of 2009 authorizing civil marriage, and

*Whereas*, in 2009, Stan Baker, a strong justice advocate, was ordained as a deacon in the Episcopal Church, and his local church leadership included service as a chaplain at Fletcher Allen Health Care (now the University of Vermont Medical Center), a deacon of the Cathedral Church of St. Paul in Burlington, and archdeacon of the Episcopal Diocese of Vermont, and nationally, he served on panels examining marriage as a five-time clergy deputy to the House of Delegates; as chair of 2024 House of Deputies General Convention Legislative Committee on Prayer Book, Liturgy, and Music; and also in 2024, was elected to the Executive Council of the Episcopal Church, and

*Whereas*, in June 2025, Stan Baker died at 79 years of age, and his survivors include his husband, Peter Harrigan, and numerous family members and admiring friends, *now therefore be it*

***Resolved by the Senate and House of Representatives:***

That the General Assembly extends its sincere condolences to the family and friends of the Venerable J. Stannard Baker of Shelburne, *and be it further*

***Resolved:*** That the Secretary of State be directed to send a copy of this resolution to members of the family of Stan Baker and to the Episcopal Diocese of Vermont.

Sec. 48. 9 V.S.A. § 5202 is amended to read:

§ 5202. EXEMPT TRANSACTIONS

The following transactions are exempt from the requirements of sections ~~5301 through 5306~~ 5301–5306 and 5504 of this chapter:

\* \* \*

(14)(A) A sale or an offer to sell securities by or on behalf of an issuer, if the transaction is part of a single issue in which:

(~~A~~)(i) not more than ~~25~~ 10 purchasers are present in this State during any 12 consecutive months, other than those designated in subdivision (13) of this section;

(~~B~~)(ii) a general solicitation or general advertising is not made in connection with the offer to sell or the sale of the securities;

(~~C~~)(iii) a commission or other remuneration is not paid or given, directly or indirectly, to a person other than a broker-dealer registered under this chapter or an agent registered under this chapter for soliciting a prospective purchaser in this State; and

(~~D~~)(iv) the issuer reasonably believes that all the purchasers in this State, other than those designated in subdivision (13) of this section, are purchasing for investment.

(B) The exemption specified in this subdivision (14) shall not apply to a federal covered security that is otherwise subject to a notice filing requirement under section 5302 of this title.

(A) Vermont CARES: ~~\$140,000~~ \$165,000;

(B) AIDS Project of Southern Vermont: ~~\$100,000~~ \$115,000; and

(C) HIV/HCV Resource Center: ~~\$55,000~~ \$60,000.

**Rep. Cina of Burlington** provided the following vote explanation:

“Madam Speaker:

I vote yes on this budget adjustment due to the many beneficial or harmless modifications included within it. But I do so with great objection to the Governor’s decision to waste taxpayer money by obligating the State to leases

on private property when there is plenty of public property that could have been used and when remote work could have continued to support the efficient provision of government services.”
