House concurrent resolution congratulating the YMCA on its 175th anniversary and extending best wishes for the organization's future endeavors

*Whereas*, on December 29, 1851, Thomas Valentine Sullivan established the first YMCA (the Y) in the United States at the Old South Church in Boston, Massachusetts, mirroring the Y movement in England with a mission "to build healthy spirit, mind and body for all," and

*Whereas*, in 1866, the first Y in Vermont opened in Burlington, and

*Whereas*, since 1851, the Y has been dedicated "to meet[ing] evolving needs of American communities, strengthening society by bringing people together, fostering relationships and creating a sense of belonging," and

*Whereas*, the Y "serves people of all ages, backgrounds, and abilities, creating spaces where all people feel welcome," and

*Whereas*, the many historic milestones of the Y's last 175 years are of both organizational and national significance, and

*Whereas*, a selection of the highlights of the Y's 175-year odyssey include conducting the first night school and English as a Second Language (ESL) classes, inventing basketball, offering the first group swimming lessons, serving as the birthplace of Father's Day, receiving the Nobel Peace Prize in 1946 for the achievement of its National War Work Council, serving as America's leading nonprofit provider of child care and afterschool programs, and offering important community support services during the pandemic, and

*Whereas*, nationwide, 2,600 Ys, located in every state and territory, receive support from more than 300,000 staff and 350,000 volunteers, and they annually serve 6.5 million children and 11 million adults, and

*Whereas*, in Vermont, the YMCA of Greater Burlington and the Meeting Waters YMCA (established in 1895) serve 15,000 Vermonters through the diligent efforts of 600 staff and 80 volunteers, and

*Whereas*, during this anniversary year, Ys across the country will celebrate with special commemorative events, *now therefore be it*

***Resolved by the Senate and House of Representatives:***

That the General Assembly congratulates the YMCA on its 175th anniversary and extends best wishes for the organization's future endeavors, *and be it further*

***Resolved:*** That the Secretary of State be directed to send a copy of this resolution to the YMCA of Greater Burlington and the Meeting Waters YMCA.

**Committee Relieved of Consideration and Bill Committed to  
Other Committee**

**H. 817**

**Rep. Conlon of Cornwall** moved that the Committee on Education be relieved of House bill, entitled

An act relating to mental health support and substance use disorder prevention in schools

And that the bill be committed to the Committee on Health Care, which was agreed to.

**Bill Amended; Third Reading; Bill Passed****H. 898**

House bill, entitled

An act relating to copper-based to fiber-based telecommunications network transitions and consumer protections

Was taken up and, pending third reading of the bill, **Rep. Donahue of Northfield** moved to amend the bill in Sec. 1, 30 V.S.A. § 227f (concerning required disclosures related to network transitions), in subdivision (d)(6), after the word "Rights" by adding the following: ", or how to obtain a hard copy of Rule 7.600 by U.S. mail"

Which was agreed to. Thereupon, the bill was read the third time and passed.
