The Senate was called to order by the President.

## Message from the House No. 34

A message was received from the House of Representatives by Ms. Courtney Reckord, its Second Assistant Clerk, as follows:

## Bill Amended; Bill Passed

S. 127.

Senate bill entitled:

An act relating to housing and housing development.

Was taken up.

Thereupon, pending third reading of the bill, Senators Cummings, Beck, Brock, Chittenden, Gulick, Hardy and Mattos moved to amend the bill as follows:

<u>First</u>: In Sec. 16, 24 V.S.A. chapter 53, subchapter 7, in section 1906, in subdivision (6), by striking out the word "<u>affordable</u>"

<u>Second</u>: In Sec. 16, 24 V.S.A. chapter 53, subchapter 7, in section 1906, in subdivision (10)(A), by striking out "<u>commercial and industrial facilities</u>,"

<u>Third</u>: In Sec. 16, 24 V.S.A. chapter 53, subchapter 7, in section 1906, by striking out subdivision (1) in its entirety and by renumbering the remaining subdivisions to be numerically correct

<u>Fourth</u>: In Sec. 16, 24 V.S.A. chapter 53, subchapter 7, by striking out section 1907 in its entirety and inserting in lieu thereof a new section 1907 to read as follows:

## § 1907. PURPOSE

The purpose of housing infrastructure tax increment financing is to provide revenues for improvements and related costs to encourage the development of primary residences for households of low or moderate income.

<u>Fifth</u>: In Sec. 16, 24 V.S.A. chapter 53, subchapter 7, in section 1910, by striking out subsection (b) in its entirety and inserting in lieu thereof a new subsection (b) to read as follows:

- (b) Review. The Vermont Economic Progress Council may approve only applications that:
- (1) meet the process requirements, the project criterion, and any of the location criteria of this section; and
  - (2) are submitted on or before December 31, 2035.

<u>Sixth</u>: In Sec. 16, 24 V.S.A. chapter 53, subchapter 7, in section 1910, in subsection (d), following "<u>the projected housing development includes</u>", by striking out the word "affordable"

<u>Seventh</u>: In Sec. 16, 24 V.S.A. chapter 53, subchapter 7, in section 1910d, in subsection (b), by inserting a new subdivision (5) to read as follows:

(5) the number and types of housing units for which a permit is being pursued under 10 V.S.A. chapter 151 (State land use and development plans) and, for each applicable housing development, the current stage of the permitting process;

and by renumbering the remaining subdivisions to be numerically correct

<u>Eighth</u>: In Sec. 16, 24 V.S.A. chapter 53, subchapter 7, in section 1910d, by adding a new subsection to be subsection (c) to read as follows:

(c) On or before January 15, 2035, the Vermont Economic Progress Council shall submit a report to the Senate Committees on Economic Development, Housing and General Affairs and on Finance and the House Committees on Commerce and Economic Development and on Ways and Means evaluating the success of the Community and Housing Infrastructure Program in achieving its purpose, as stated in section 1907 of this chapter, including by identifying the amount and kinds of housing produced through the Program and by determining whether housing development pursued through the Program meets the project criterion and location criteria of section 1910 of this chapter.

Which was agreed to.

Thereupon, the bill was read the third time and passed.

#### **Bill Passed in Concurrence**
