Message from the House No. 41

I am directed to inform the Senate that:

The House has considered a bill originating in the Senate of the following title:

S. 30. An act relating to updating and reorganizing the health insurance statutes in 8 V.S.A. chapter 107.

And has passed the same in concurrence with proposal of amendment in the adoption of which the concurrence of the Senate is requested.
