**Rules Suspended; Resolution Amended; Third Reading Ordered; Rules
Suspended; Resolution Adopted**

S.R. 21.

Appearing on the Calendar for notice, on motion of Senator Baruth, the rules were suspended and Senate Resolution entitled:

Senate resolution relating to U.S. Immigration and Customs Enforcement's Operation Metro Surge.

Was taken up for immediate consideration.

Senator Baruth, for the Committee on Judiciary, reported recommending that the resolution be amended as follows:

First: By striking out the second Resolved clause and inserting in lieu thereof the following:

Resolved: That the Senate of the State of Vermont, based on initial and substantial evidence, unequivocally condemns the extrajudicial killings of Renée Good and Alex Pretti as grave violations of human dignity, civil liberties, and the constitutional protections owed to all persons, *and be it further*

Second: By striking out the fourth Resolved clause and inserting in lieu thereof the following:

Resolved: That the Senate of the State of Vermont further declares that the lawful exercise of these constitutional rights—peacefully, responsibly, and within the bounds of the law—can never justify empowering federal agents to act as judge, jury, and executioner, nor employing lethal forces outside established legal process and accountability, *and be it further*

And that when so amended the resolution ought to be adopted.

Thereupon, the resolution was read the second time by title only pursuant to Rule 43, and the recommendations of amendment were agreed to, on a roll call, Yeas 25, Nays 4.

Senator Ram Hinsdale having demanded the yeas and nays, they were taken and are as follows:

*Senator Benson explained his vote as follows:

“Mr. President,

“The resolution as presented may be fine. However, I believe it is premature and that we should wait until the investigation is completed and the facts known before adoption of the resolution.”

*Senator Norris explained his vote as follows:

“Mr. President,

“I am voting no because this resolution declares “extrajudicial killing” before investigations or courts have established the facts. The Legislature should not act as judge and jury in place of due process.”

*Senator Williams explained his vote as follows:

“I take concerns about public safety and civil liberties seriously. But this resolution does not advance accountability in a lawful or constructive way.

“The Vermont Legislature Does not have authority to direct, condemn, or interfere with federal law enforcement operations. Doing so blurs constitutional lines. invites litigation, and weakens-not strengthens-the rule of law.

“Resolutions should reflect our values without misrepresenting our legal authority. When we use them to imply powers we do not have, or to pressure outcomes outside state jurisdiction, we risk misleading the public and politicizing matters better addressed through lawful oversight, the courts, or Congress.

“For those reasons, I cannot support this resolution as written and will vote no.”

Thereupon, on motion of Senator Baruth, the rules were suspended and the resolution was placed on all remaining stages of its adoption.

Thereupon, the resolution was read the third time and adopted.
