

FY26 Special Investigations Units Budget

- FY26 Gov Recommend: \$2,291,219
 - 2.7% Increase – GF (no other funds support SIU)
 - 12 SIU Program Grants: \$1,343,507 for program support; \$793,000 for law enforcement support
 - FY26: Transitioned SIU Grants Program Administrator from contract to permanent position, no budget impact to FY26 or foreseeable outyears
- BUDGET and STAFFING PRESSURES:
 - Greater transparency and accountability needed in grants award and spending, in both Program Support and Law Enforcement grant funds.
 - Concerns about staffing for law enforcement support – agencies not able to provide dedicated staff, or enough hours, to fully support programs, due to their own staffing problems. More support to law enforcement agencies is a goal in FY26.
