- State Veterans Homes are facilities that provide nursing home, domiciliary or adult day care. *They are owned, operated and managed by State governments.*

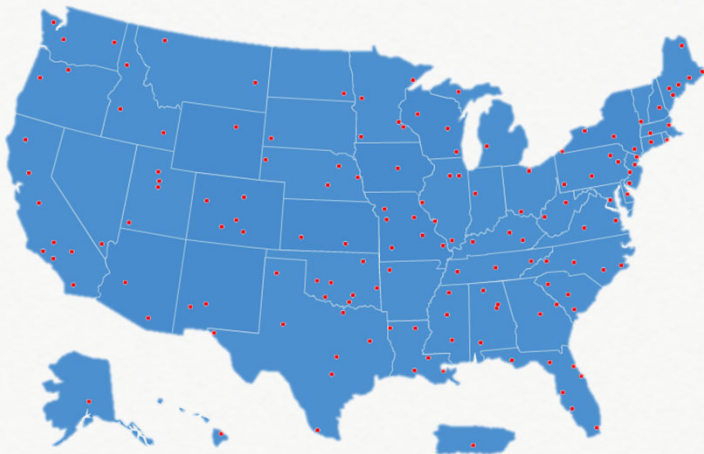

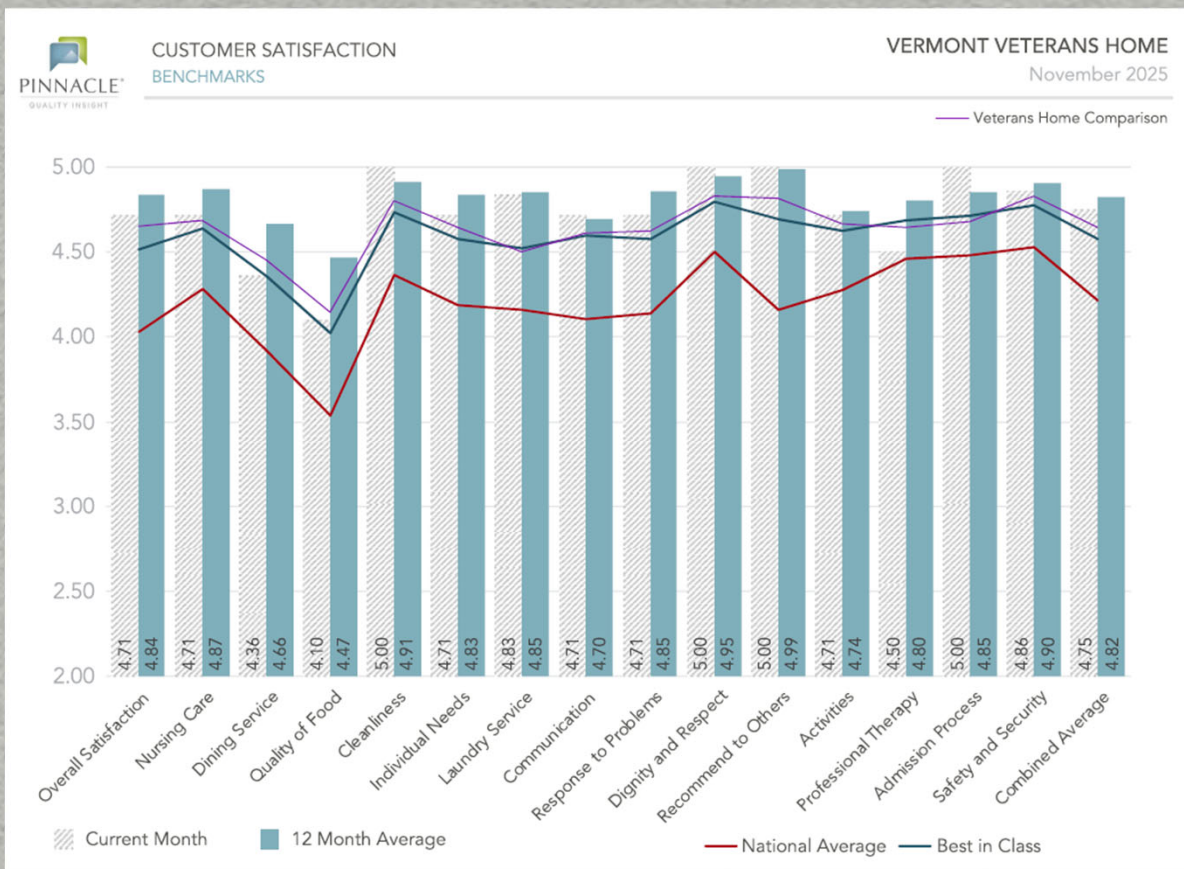

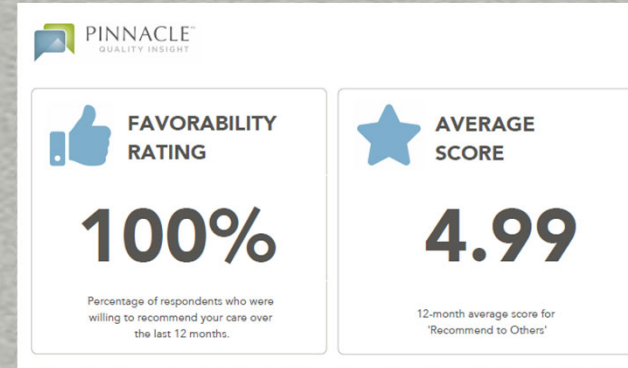

FY 2027 Budget

The increase from FY26 to FY27 is \$598,624 or 1.9% is related to a reduction in Agency Staff Expense, which we will be returning for a Budget Adjustment Request in January 2027. That amount is estimated currently at \$2,200,000.

Salary and Benefit expense is budgeted for an increase of \$2,359,775 due to the reduction in open positions (64 to 48 for \$992,953); Market Factor Adjustments to Clinical and Non-Clinical areas (\$621,047); Salary increase of \$538,023 and Benefit increases of \$220,874.

Vermont Veterans' Home Salary & Benefits Budget History

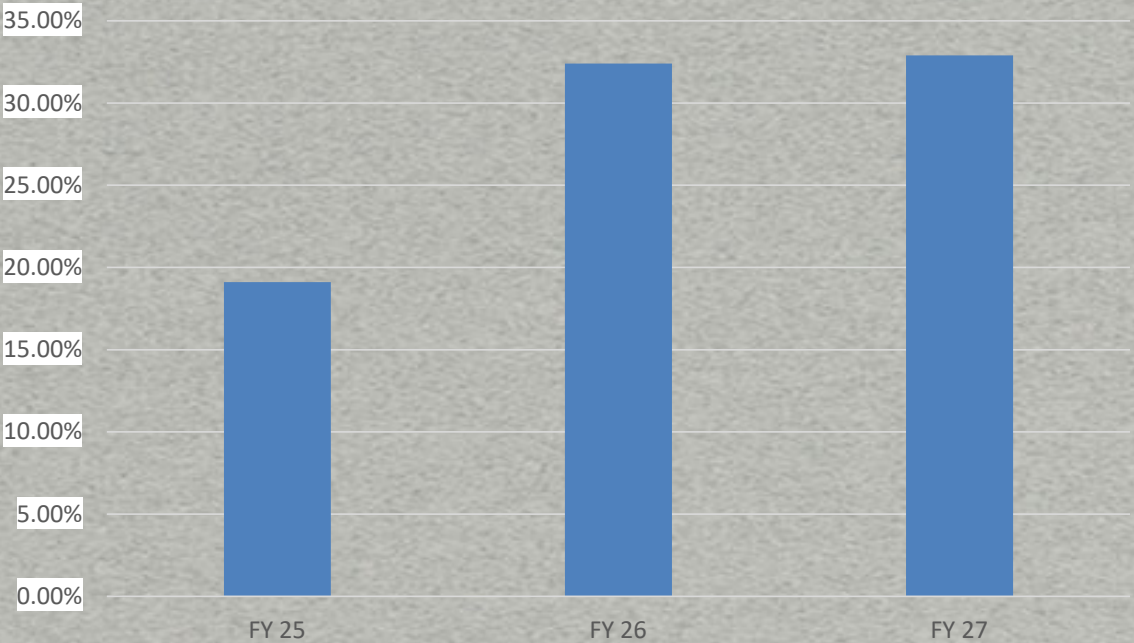

VA Reimbursement

Provided for Veterans only

- Remainder of the cost of their nursing home stay is covered by Medicare, Medicaid, Private Pay or Long-Term Care Insurance

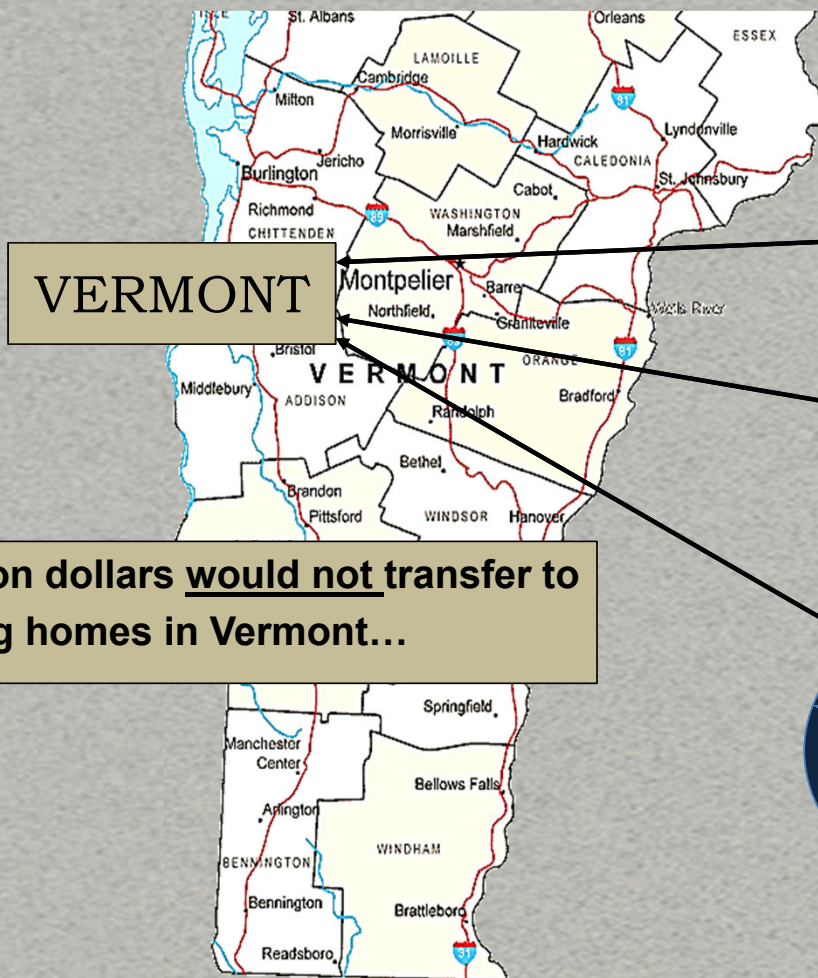

FY 2027 Challenges



- **Meeting The Home's Financial Goals**
 - Decreased census - currently 30 beds are offline due to staffing challenges and the cost of agency/traveling nursing staff
- **Labor Costs**
 - No control over salary and benefit increases and now included in the Pay Act.
 - Staffing –we currently 58 open positions – 44 clinical and 14 non-clinical (Dietary & Housekeeping)
- **Veteran Care Perception**
 - Outside groups/individuals providing false information on the cost of care and potential cost saving measures for the home.
 - People believe that the care here is free and the State or the VA picks up all our costs



STAFFING CHALLENGES

As of January 8, 2026 we have the following open clinical positions:

- ❖ RN 9 Average hourly rate \$46.25 (\$79.55 w/ benefits)
- ❖ LPN 5 Average hourly rate \$30.26 (\$52.05 w/benefits)
- ❖ LNA 30 Average hourly rate \$24.72 (\$42.52 w/benefits)

Current Agency Staff Numbers as of January 8, 2025:

- ❖ LPN 17 Current average hourly rate \$77.78
- ❖ LNA 15 Current average hourly rate \$61.82

Expense Challenges:

- Agency Staffing
 - Average annual cost for an LNA is over \$128,000 vs. \$88,442 for State employee
 - VVH spent \$5,205,000 in FY25 for clinical agency staff for 34.4 FTEs (\$151,308 average)
- Recruitment of Clinical Staff
 - RNs
 - LPNs
 - LNAs
- Pass Through Expenses
 - Vermont Agencies expenses increasing greater than Finance & Management's guidelines and VVH has to absorb the expense increases
- Medicaid 1115 Waiver
 - Medicaid 1115 Waiver terminates on December 31, 2027 (FY2028), unless renewed.
 - If not renewed, VVH will be subject to the Medicare Upper Payment Limit and no longer receive settlement monies
 - Will result in a much higher request for General Fund monies

Budget Challenges



Initiatives to Reduce Expenses

- **Continuous Spending Review**
 - Ensuring costs are in line with daily census
 - Eliminated Podiatrist and brought service inhouse
 - Reviewing other services with Human Resources to transition inhouse
- LNA Class
 - Graduated 5 students in January 2025 (2 hired)
 - Graduated 3 students in September 2025 (2 hired as temps)
 - Current class of 8 graduates January 29, 2026
- Continual monitoring of Veterans needed 24/7 one-to-one supervision.
 - Continue to succeed in this area, have one Veteran who has one-on-one supervision in the evenings only.
