**Background:**

As part of the Fleet Management Services (FMS) program, the Department of Buildings and General Services (BGS) conducts a review of the mileage reimbursement records of all departments at the end of each fiscal year to identify high mileage drivers. The following is a summary of the review for fiscal year 2025:

Number of employees Reimbursed for Mileage at the Full Rate	3,039
Total Miles Reimbursed at the Full Rate	3,938,710
Total Cost to STATE	\$ 2,688,570.38
Number of Employees Reimbursed more than 10,760 miles at Full Rate (High Mileage Users)	55
Total Miles Reimbursed by these employees	858,951
Average Miles Driven Per Employee	15,617
Total Cost to State	\$ 581,839.62
Average Reimbursement Per Employee	\$ 10,578.90

Following this review, departments are contacted to inform them of their high mileage drivers, and to advise them of potential savings which may be available by shifting employees with high mileage reimbursements to an FMS) leased vehicle.

**Mileage Breakeven Point:**

The annual mileage breakeven point – the point at which it becomes more cost effective to utilize a leased FMS vehicle versus reimbursing an employee for driving their private vehicle at the full mileage reimbursement rate - is 10,760 miles. For traveling greater than 10,760 miles annually, driving a FMS vehicle saves the State money. It should be noted that the cost analysis is based on using the most economical compact hybrid electric sedan available through State contract and current fuel prices.
