19	§ 1571. STATEWIDE CAREER AND TECHNICAL EDUCATION
20	SCHOOL DISTRICT

1	The provision of career and technical education (CTE) in the State shall be
2	provided through a single, statewide career and technical education school
3	district, subject to the provisions of this subchapter.
4	<u>§ 1572. SERVICE REGIONS</u>
5	The statewide CTE school district is divided into the following 15 service
6	regions:
7	(1) The Burlington Technical Center and Center for Technology, Essex,
8	region is formed of the following member supervisory unions and supervisory

6	(B) Windham Northeast Supervisory Union (Bellows Falls Union
7	High School District, Rockingham School District, Athens Grafton School

10	(C) Windham Southeast Supervisory Union (Vernon Town School
11	District and Windham Southeast School District): Vernon, Brattleboro,

17	<u>§ 1573. CTE SCHOOL BOARD MEMBERSHIP</u>
18	(a) Members. The board of the statewide CTE school district shall be
19	composed of 15 voting members concurrently serving as members of the
20	member supervisory union boards, appointed by the superintendents of each
21	service region. The superintendent of the statewide school district shall be a

1	nonvoting member of the board. The board may, at its discretion, appoint
2	other nonvoting members to the board, including students.
3	(b) Term. Appointed members shall serve a term of two years or until the
4	member's successor is appointed and has taken the oath of office.
5	(c) Quorum. A majority of the members of the board shall constitute a
6	quorum. The concurrence of a majority of members present at a statewide
7	CTE school district board meeting shall be necessary and sufficient for board
8	action; provided, however, the concurrence of more than a majority shall be
9	necessary if required by law or board bylaws.
10	(d) Board chair and board clerk. At the board meeting next following each
11	annual district meeting, the statewide CTE school district board shall elect one
12	of its number to serve as the chair of the board and one other of its number to
13	serve as the clerk of the board.
14	(e) Minutes. The board clerk shall prepare minutes of the proceedings of
15	the statewide CTE school district board, unless the board votes to delegate
16	those duties to another individual. The board clerk shall transmit the minutes
17	and all other documents constituting the record of board proceedings to the
18	clerk of the statewide CTE, who shall be responsible for maintaining a
19	permanent record of board proceedings. In the board clerk's absence, another
20	member of the school board shall assume the duties of the clerk.
21	(f) Stipend. The board clerk may be paid upon order of the board.

1	<u>§ 1574. DUTIES AND AUTHORITY OF STATEWIDE CTE SCHOOL</u>
2	BOARD
3	The school board of the statewide CTE school district authorized under this
4	subchapter, in addition to other duties and authority specifically assigned by
5	law, shall have the following duties and authority:
6	(1) To determine the statewide educational policies for career technical
7	centers. Policies shall be of general application to all centers and shall be in
8	writing, codified, and made available to the public. Board policies shall be
9	adopted at regular or special meetings. The board shall give public notice of
10	its intent to adopt a board policy, stating the substance of the proposed policy,
11	at least 10 days prior to its adoption. The board may also approve or
12	disapprove rules and regulations proposed by the superintendent for the
13	conduct and management of the centers.
14	(2) To take any action required for the sound administration of the
15	district. The Secretary of Education, with the advice of the Attorney General,
16	upon application by the board, shall decide whether any action contemplated or
17	taken under this subdivision is required for the sound administration of the
18	district and is consistent with law. The Secretary's decision shall be final.
19	(3) To have the possession, care, control, and management of the
20	property of the district, subject to the provisions of any agreement between the

1	former board of a center or member school district that previously operated a
2	CTE center and the statewide CTE school district.
3	(4) To keep the center buildings and grounds in good repair, suitably
4	equipped, insured, and in safe and sanitary condition at all times. The centers
5	shall regulate or prohibit firearms or other dangerous or deadly weapons on
6	school premises. The board's policies in this regard shall be, at minimum,
7	consistent with section 1166 of this title and 13 V.S.A. § 4004, relating to a
8	student who brings a firearm to or possesses a firearm at school.
9	(5) To lease or purchase real and personal property, and to sell, relocate,
10	or discontinue use of real and personal property, subject to the terms and
11	conditions of applicable State law.
12	(6) To establish and maintain a system for receipt, deposit,
13	disbursement, accounting, control, and reporting procedures that meets the
14	criteria established by the State Board pursuant to subdivision 164(15) of this
15	title and that ensures all payments are lawful and in accordance with the budget
16	adopted pursuant to terms approved by the State Board. The Board may
17	authorize a subcommittee, the superintendent, or a designated employee of the
18	Board to examine claims against the district for center expenses and draw
19	orders for such as shall be allowed by it payable to the party entitled to the
20	payment. Such orders shall state definitely the purpose for which they are
21	drawn and shall serve as full authority to the treasurer to make such payments.

1	It shall be lawful for the board to submit to its treasurer a certified copy of
2	those portions of the board minutes, properly signed by the clerk and chair, or
3	a majority of the board, showing to whom, and for what purpose, each
4	payment is to be made by the treasurer, and the certified copy shall serve as
5	full authority to the treasurer to make the approved payments.
6	(7) To establish, with the advice and consent of the Auditor of Accounts
7	and the Secretary of Education, a system of accounts for the proper control and
8	reporting of center finances and for stating the annual financial condition of the
9	centers.
10	(8) To sue and be sued.
11	(9) To execute contracts on behalf of centers, including contracts
12	providing for binding arbitration, by its chair or any person designated whose
13	appointment is recorded in the minutes of the board.
14	(10) To employ persons to carry out the work of the centers and dismiss
15	any employee when necessary. The board shall consider the recommendation
16	of the superintendent and center directors before employing or dismissing any
17	person.
18	(11) To provide, at the expense of the centers, subject to the approval of
19	the superintendent and directors all learning materials, equipment, and
20	supplies.

1	(12) To employ a public accountant every year to audit the financial
2	statements of the statewide CTE school district.
3	(13) To establish policies and procedures designed to avoid the
4	appearance of board member conflict of interest.
5	(14) To borrow money by issuance of bonds or notes, not in excess of
6	anticipated revenue for the school year.
7	(15) To apply for grants and to accept and expend grants and gifts.
8	(16) To present informational materials, at the expense of the centers, to
9	the electorate on any matter to be voted; provided, however, that the materials
10	shall be limited to those that are reasonably designed to inform, educate, and
11	explain to the electorate the board's position on the matter.
12	<u>§ 1575. VOTER CHECKLIST</u>
13	The voter checklist for the statewide CTE school district and records of
14	proceedings shall be made and maintained in the same manner as those
15	functions are carried out in a union school district under chapter 11 of this title.
16	The checklist shall control for purposes of determining voter eligibility in the
17	statewide CTE school district.
18	<u>§ 1576. STATEWIDE CTE SCHOOL DISTRICT BUDGET</u>
19	(a) The board of the statewide CTE school district shall at each annual
20	meeting present an estimate of the expenses for the ensuing year, and the
21	district shall appropriate that sum that it deems necessary for the expenses,

1	together with the amount required to pay any balance left unpaid from the
2	preceding year, expressing the sum in dollars in its vote. If a budget for the
3	operation of the district is not approved, a subsequent meeting or meetings
4	shall be warned.
5	(b) If a budget has not been approved on or before June 30 of any year, the
6	school board may borrow funds pursuant to the authority granted under section
7	566 of this title.
8	(c) Following adoption of a budget, the board shall calculate each service
9	region's share pursuant to section 1577 of this title. Upon receipt of the notice
10	of the amount, the share shall become a legal obligation of the school districts
11	within each service region without need for further vote of the school district
12	electorate and shall be included in each school district's education spending
13	amount.
14	<u>§ 1577. INCURRING DEBT</u>
15	(a) If authorized by a majority of the qualified voters voting on the question
16	in accordance with this section, the statewide CTE school district may incur
17	indebtedness for improvements or the acquisition of capital assets for the
18	purposes for which the district is established as provided in this chapter.
19	(b) Each town school district, incorporated school district, unified union
20	school district, and city school district within the statewide CTE school district
21	shall vote on a decision to incur indebtedness for improvements as provided by

1	24 V.S.A. chapter 53, subchapter 1. The vote shall be determined by
2	Australian ballot or voting machine on the same day and during the same hours
3	at each regular polling place in each town school district, incorporated school
4	district, unified union school district, and city school district. Absentee voting
5	in accordance with 17 V.S.A. chapter 51, subchapter 6 shall be permitted. The
6	Board of Civil Authority of each town shall be responsible for determining the
7	eligibility of persons to vote, the supervision of the election, and the
8	transportation of ballots in its district to a central point designated by the
9	statewide CTE school district. The ballots shall be commingled. Counting of
10	ballots by representatives of the Boards of Civil Authority of the towns in the
11	service region shall be supervised by the statewide CTE school district clerk or
12	the clerk's designee.
13	(c) Obligations incurred under 24 V.S.A. chapter 53, subchapter 1 shall be
14	the joint and several obligations of the statewide CTE school district and of
15	each of the town school districts, incorporated school districts, the member
16	towns of unified union school districts, and city school districts within the
17	service region. Any joint or several liability incurred by a town school district,
18	incorporated school district, the member towns of a unified union school
19	district, or city school district within the service region under the provisions of
20	this subchapter shall not be considered in determining its debt limit for its own
21	separate purposes.

1	<u>§ 1579. CAREER TECHNICAL COURSES IN OTHER SCHOOLS</u>
2	Subject to any direction as to courses, teachers, or equipment that the State
3	Board may prescribe by rule, high schools may include within their courses of
4	study pretechnical or career technical courses, or both. Before establishing
5	such a program, a high school shall consult with the statewide CTE school
6	district.
7	<u>§ 1580. CREDITS AND GRADES EARNED</u>
8	(a) Grades earned in a course offered within a CTE program approved by
9	the Agency shall not be altered by any public school or approved or recognized
10	independent school in Vermont and shall be applied by the school toward any
11	State graduation requirements in accordance with rules adopted by the Agency.
12	Any Agency rules regarding earning of credits shall allow flexibility with
13	respect to the integration of CTE education and other academic courses.
14	(b) The credits earned for a career technical education program approved
15	by the Agency shall be honored by any public or independent school within
16	Vermont. If necessary to enable a student to participate in career technical
17	education and graduate with the student's class, the credits earned shall be
18	applied toward any school district or independent school graduation
19	requirements exceeding the minimum number of credits required by the State
20	Board. The school board of the high school from which the student wishes to
21	graduate shall make a determination as to whether the credits shall be applied

1	toward graduation requirements. A decision of a school board may be
2	appealed to the Secretary, who shall construe this section to favor participation
3	in career technical education.
4	(c) For any student attending the Vermont Academy for Science and
5	Technology pursuant to subsection 4011(e) of this title, the credits and grades
6	earned shall, upon request of the student or the student's parent or guardian, be
7	applied toward graduation requirements at the Vermont high school that the
8	student attended prior to enrolling in the Academy.
9	§ 1581. COMPREHENSIVE HIGH SCHOOLS
10	(a) In the sections referenced in this section, when applied to an
11	independent comprehensive high school, the term "school board" or "school
12	district" means "the school's board of trustees."
13	(b) A comprehensive high school shall charge and receive tuition pursuant
14	to section 824 of this title. A comprehensive high school shall be a career
15	technical center for the purposes of receiving funding for grants per full-time
16	equivalent student under section 1561 of this title, for tryout classes under
17	section 1562 of this title, and for reporting requirements under section 1568 of
18	this title. Funds received under this section shall be used for support of career
19	technical education programs within the comprehensive high school.
20	(c) Two or more comprehensive high schools for which the Agency has
21	designated a service region shall be a career technical center for the purposes

1	of accountability to the Agency under subchapter 2 of this chapter and
2	receiving State financial assistance under subchapter 5 of this chapter,
3	excluding the general State support grant under subsection 1561(b) of this title.
4	The statewide career and technical education school board shall determine how
5	funds received under subchapter 5 shall be distributed. A comprehensive high
6	school aggrieved by a decision of the statewide career and technical education
7	school board may appeal to the Secretary who, after opportunity for hearing,
8	may affirm or modify the decision.
9	* * * Transition to Statewide CTE School District * * *
10	Sec. 3. NEW BOARD MEMBER ELECTIONS
11	(a) Board member appointments. New board members shall be appointed
12	by the superintendents of each service region in accordance with 16 V.S.A.
13	<u>§ 1573(a) on or before XXXX.</u>
14	(b) Staggered terms. The appointed members from the Central Vermont
15	Career Center region, the Green Mountain Technology and Career Center
16	region, the Lyndon Institute and St. Johnsbury Academy Applied Technology
