1	TO THE HOUSE OF REPRESENTATIVES:
2	The Committee on Commerce and Economic Development to which was
3	referred Senate Bill No. 69 entitled "An act relating to an age-appropriate
4	design code" respectfully reports that it has considered the same and
5	recommends that the House propose to the Senate that the bill be amended by
6	striking out all after the enacting clause and inserting in lieu thereof the
7	following:
8	Sec. 1. 9 V.S.A. chapter 62, subchapter 6 is added to read:
9	Subchapter 6. Vermont Age-Appropriate Design Code Act
10	§ 2449a. DEFINITIONS
11	As used in this subchapter:
12	(1)(A) "Affiliate" means a legal entity that shares common branding
13	with another legal entity or controls, is controlled by, or is under common
14	control with another legal entity.
15	(B) As used in subdivision (A) of this subdivision (1), "control" or
16	"controlled" means:
17	(i) ownership of, or the power to vote, more than 50 percent of the
18	outstanding shares of any class of voting security of a company;
19	(ii) control in any manner over the election of a majority of the
20	directors or of individuals exercising similar functions; or

1	(iii) the power to exercise controlling influence over the
2	management of a company.
3	(2) "Age assurance" encompasses a range of methods used to determine,
4	estimate, or communicate the age or an age range of an online user.
5	(3) "Age range" means either an interval with an upper and lower age
6	limit or a label indicating age above or below a specific age.
7	(4) "Algorithmic recommendation system" means a system that uses an
8	algorithm to select, filter, and arrange media on a covered business's website
9	for the purpose of selecting, recommending, or prioritizing media for a user.
10	(5)(A) "Biometric data" means data generated from the technological
11	processing of an individual's unique biological, physical, or physiological
12	characteristics that allow or confirm the unique identification of the consumer,
13	including:
14	(i) iris or retina scans;
15	(ii) fingerprints;
16	(iii) facial or hand mapping, geometry, or templates;
17	(iv) vein patterns;
18	(v) voice prints or vocal biomarkers; and
19	(vi) gait or personally identifying physical movement or patterns.
20	(B) "Biometric data" does not include:
21	(i) a digital or physical photograph;

1	(ii) an audio or video recording; or
2	(iii) any data generated from a digital or physical photograph, or
3	an audio or video recording, unless such data is generated to identify a specific
4	individual.
5	(6) "Business associate" has the same meaning as in the Health
6	Insurance Portability and Accountability Act of 1996, Pub. L. No. 104-191
7	(HIPAA).
8	(7) "Collect" means buying, renting, gathering, obtaining, receiving, or
9	accessing any personal data by any means. This includes receiving data from
10	the consumer, either actively or passively, or by observing the consumer's
11	behavior.
12	(8) "Compulsive use" means the repetitive use of a covered business's
13	service that materially disrupts one or more major life activities of a minor,
14	including sleeping, eating, learning, reading, concentrating, communicating, or
15	working.
16	(9)(A) "Consumer" means an individual who is a resident of the State.
17	(B) "Consumer" does not include an individual acting in a
18	commercial or employment context or as an employee, owner, director, officer,
19	or contractor of a company, partnership, sole proprietorship, nonprofit, or
20	government agency whose communications or transactions with the covered

1	business occur solely within the context of that individual's role with the
2	company, partnership, sole proprietorship, nonprofit, or government agency.
3	(10) "Covered business" means a sole proprietorship, partnership,
4	limited liability company, corporation, association, other legal entity, or an
5	affiliate thereof:
6	(A) that conducts business in this State;
7	(B) that generates a majority of its annual revenue from online
8	services;
9	(C) whose online products, services, or features are reasonably likely
10	to be accessed by a minor;
11	(D) that collects consumers' personal data or has consumers'
12	personal data collected on its behalf by a processor; and
13	(E) that alone or jointly with others determines the purposes and
14	means of the processing of consumers personal data.
15	(11) "Covered entity" has the same meaning as in HIPAA.
16	(12) "Covered minor" is a consumer who a covered business actually
17	knows is a minor or labels as a minor pursuant to age assurance methods in
18	rules adopted by the Attorney General.
19	(13) "Default" means a preselected option adopted by the covered
20	business for the online service, product, or feature.

1	(14) "De-identified data" means data that does not identify and cannot
2	reasonably be used to infer information about, or otherwise be linked to, an
3	identified or identifiable individual, or a device linked to the individual, if the
4	covered business that possesses the data:
5	(A)(i) takes reasonable measures to ensure that the data cannot be
6	used to reidentify an identified or identifiable individual or be associated with
7	an individual or device that identifies or is linked or reasonably linkable to an
8	individual or household; and
9	(ii) for purposes of this subdivision (A), "reasonable measures"
10	includes the de-identification requirements set forth under 45 C.F.R. § 164.514
11	(other requirements relating to uses and disclosures of protected health
12	information);
13	(B) publicly commits to process the data only in a de-identified
14	fashion and not attempt to reidentify the data; and
15	(C) contractually obligates any recipients of the data to comply with
16	all provisions of this subchapter.
17	(15) "Derived data" means data that is created by the derivation of
18	information, data, assumptions, correlations, inferences, predictions, or
19	conclusions from facts, evidence, or another source of information or data
20	about a minor or a minor's device.

1	(16) "Genetic data" means any data, regardless of its format, that results
2	from the analysis of a biological sample of an individual, or from another
3	source enabling equivalent information to be obtained, and concerns genetic
4	material, including deoxyribonucleic acids (DNA), ribonucleic acids (RNA),
5	genes, chromosomes, alleles, genomes, alterations or modifications to DNA or
6	RNA, single nucleotide polymorphisms (SNPs), epigenetic markers,
7	uninterpreted data that results from analysis of the biological sample or other
8	source, and any information extrapolated, derived, or inferred therefrom.
9	(17) "Identified or identifiable individual" means an individual who can
10	be readily identified, directly or indirectly, including by reference to an
11	identifier such as a name, an identification number, specific geolocation data,
12	or an online identifier.
13	(18) "Known adult" is a consumer who a covered business actually
14	knows is an adult or labels as an adult pursuant to age assurance methods in
15	rules adopted by the Attorney General.
16	(19) "Minor" means an individual under 18 years of age.
17	(20) "Online service, product, or feature" means a digital product that is
18	accessible to the public via the internet, including a website or application, and
19	does not mean any of the following:
20	(A) telecommunications service, as defined in 47 U.S.C. § 153;

1	(B) a broadband internet access service as defined in 47 C.F.R.
2	<u>§ 54.400; or</u>
3	(C) the sale, delivery, or use of a physical product.
4	(21)(A) "Personal data" means any information, including derived data
5	and unique identifiers, that is linked or reasonably linkable, alone or in
6	combination with other information, to an identified or identifiable individual
7	or to a device that identifies, is linked to, or is reasonably linkable to one or
8	more identified or identifiable individuals in a household.
9	(B) Personal data does not include de-identified data or publicly
10	available information.
11	(22) "Process" or "processing" means any operation or set of operations
12	performed, whether by manual or automated means, on personal data or on sets
13	of personal data, such as the collection, use, storage, disclosure, analysis,
14	deletion, modification, or otherwise handling of personal data.
15	(23) "Processor" means a person who processes personal data on behalf
16	<u>of:</u>
17	(A) a covered business;
18	(B) another processor; or
19	(C) a federal, state, tribal, or local government entity.
20	(24) "Profiling" means any form of automated processing performed on
21	personal data to evaluate, analyze, or predict personal aspects, including an

1	individual's economic situation, health, personal preferences, interests,
2	reliability, behavior, location, movements, or identifying characteristics.
3	(25)(A) "Publicly available information" means information that:
4	(i) is made available through federal, state, or local government
5	records or to the general public from widely distributed media; or
6	(ii) a covered business has a reasonable basis to believe that the
7	consumer has lawfully made available to the general public.
8	(B) "Publicly available information" does not include:
9	(i) biometric data collected by a business about a consumer
10	without the consumer's knowledge;
11	(ii) information that is collated and combined to create a consumer
12	profile that is made available to a user of a publicly available website either in
13	exchange for payment or free of charge;
14	(iii) information that is made available for sale;
15	(iv) an inference that is generated from the information described
16	in subdivision (ii) or (iii) of this subdivision (25)(B);
17	(v) any obscene visual depiction, as defined in 18 U.S.C. § 1460;
18	(vi) personal data that is created through the combination of
19	personal data with publicly available information;
20	(vii) genetic data, unless otherwise made publicly available by the
21	consumer to whom the information pertains;

1	(viii) information provided by a consumer on a website or online
2	service made available to all members of the public, for free or for a fee, where
3	the consumer has maintained a reasonable expectation of privacy in the
4	information, such as by restricting the information to a specific audience; or
5	(ix) intimate images, authentic or computer-generated, known to
6	be nonconsensual.
7	(26) "Reasonably likely to be accessed" means an online service,
8	product, or feature that is reasonably likely to be accessed by a covered minor
9	based on any of the following indicators:
10	(A) the online service, product, or feature is directed to children, as
11	defined by the Children's Online Privacy Protection Act, 15 U.S.C. §§ 6501–
12	6506 and the Federal Trade Commission rules implementing that Act;
13	(B) the online service, product, or feature is determined, based on
14	competent and reliable evidence regarding audience composition, to be
15	routinely accessed by an audience that is composed of at least two percent
16	minors two through 17 years of age;
17	(C) the audience of the online service, product, or feature is
18	determined, based on internal company research, to be composed of at least
19	two percent minors two through 17 years of age; or
20	(D) the covered business knew or should have known that at least
21	two percent of the audience of the online service, product, or feature includes

1	minors two through 17 years of age, provided that, in making this assessment,
2	the business shall not collect or process any personal data that is not reasonably
3	necessary to provide an online service, product, or feature with which a minor
4	is actively and knowingly engaged.
5	(27)(A) "Social media platform" means a public or semipublic internet-
6	based service or application that is primarily intended to connect and allow a
7	user to socially interact within such service or application and enables a user
8	<u>to:</u>
9	(i) construct a public or semipublic profile for the purposes of
10	signing into and using such service or application;
11	(ii) populate a public list of other users with whom the user shares
12	a social connection within such service or application; or
13	(iii) create or post content that is viewable by other users,
14	including content on message boards and in chat rooms, and that presents the
15	user with content generated by other users.
16	(B) "Social media platform" does not mean a public or semipublic
17	internet-based service or application that:
18	(i) exclusively provides email or direct messaging services; or
19	(ii) is used by and under the direction of an educational entity,
20	including a learning management system or a student engagement program.

1	(28) "Third party" means a natural or legal person, public authority,
2	agency, or body other than the covered minor or the covered business.
3	§ 2449b. EXCLUSIONS
4	This subchapter does not apply to:
5	(1) a federal, state, tribal, or local government entity in the ordinary
6	course of its operation;
7	(2) protected health information that a covered entity or business
8	associate processes in accordance with, or documents that a covered entity or
9	business associate creates for the purpose of complying with, HIPAA;
10	(3) information used only for public health activities and purposes
11	described in 45 C.F.R. § 164.512;
12	(4) information that identifies a consumer in connection with:
13	(A) activities that are subject to the Federal Policy for the Protection
14	of Human Subjects as set forth in 45 C.F.R. Part 46;
15	(B) research on human subjects undertaken in accordance with good
16	clinical practice guidelines issued by the International Council for
17	Harmonisation of Technical Requirements for Pharmaceuticals for Human
18	<u>Use;</u>
19	(C) activities that are subject to the protections provided in 21 C.F.R.
20	Part 50 and 21 C.F.R. Part 56; or

1	(D) research conducted in accordance with the requirements set forth
2	in subdivisions (A)–(C) of this subdivision (4) or otherwise in accordance with
3	State or federal law;
4	(5) an entity whose primary purpose is journalism as defined in
5	12 V.S.A. § 1615(a)(2) and that has a majority of its workforce consisting of
6	individuals engaging in journalism; and
7	(6) a financial institution subject to Title V of the Gramm-Leach-Bliley
8	Act, Pub. L. No. 106-102, and regulations adopted to implement that act.
9	§ 2449c. MINIMUM DUTY OF CARE
10	(a) A covered business that processes a covered minor's data in any
11	capacity owes a minimum duty of care to the covered minor.
12	(b) As used in this subchapter, "a minimum duty of care" means the use of
13	the personal data of a covered minor and the design of an online service,
14	product, or feature will not result in:
15	(1) reasonably foreseeable emotional distress as defined in 13 V.S.A.
16	§ 1061(2) to a covered minor;
17	(2) reasonably foreseeable compulsive use of the online service,
18	product, or feature by a covered minor; or
19	(3) discrimination against a covered minor based upon race, ethnicity,
20	sex, disability, sexual orientation, gender identity, gender expression, religion,
21	or national origin.

1	(c) The content of the media viewed by a covered minor shall not establish
2	emotional distress, compulsive use, or discrimination, as those terms are used
3	in subsection (b) of this section.
4	(d) Nothing in this section shall be construed to require a covered business
5	to prevent or preclude a covered minor from accessing or viewing any piece of
6	media or category of media.
7	§ 2449d. REQUIRED DEFAULT PRIVACY SETTINGS AND TOOLS
8	(a) Default privacy settings.
9	(1) A covered business shall configure all default privacy settings
10	provided to a covered minor through the online service, product, or feature to
11	the highest level of privacy, including the following default settings:
12	(A) not displaying the existence of the covered minor's account on a
13	social media platform to any known adult user unless the covered minor has
14	expressly and unambiguously allowed a specific known adult user to view their
15	account or has expressly and unambiguously chosen to make their account's
16	existence public;
17	(B) not displaying media created or posted by the covered minor on
18	a social media platform to any known adult user unless the covered minor has
19	expressly and unambiguously allowed a specific known adult user to view their
20	media or has expressly and unambiguously chosen to make their media
21	publicly available;

1	(C) not permitting any known adult users to like, comment on, or
2	otherwise provide feedback on the covered minor's media on a social media
3	platform unless the covered minor has expressly and unambiguously allowed a
4	specific known adult user to do so;
5	(D) not permitting direct messaging on a social media platform
6	between the covered minor and any known adult user unless the covered minor
7	has expressly and unambiguously decided to allow direct messaging with a
8	specific known adult user;
9	(E) not displaying the covered minor's location to other users, unless
10	the covered minor expressly and unambiguously shares their location with a
11	specific user;
12	(F) not displaying the users connected to the covered minor on a
13	social media platform unless the covered minor expressly and unambiguously
14	chooses to share the information with a specific user;
15	(G) disabling search engine indexing of the covered minor's account
16	profile; and
17	(H) not sending push notifications to the covered minors.
18	(2) A covered business shall not:
19	(A) provide a covered minor with a single setting that makes all of
20	the default privacy settings less protective at once; or

1	(B) request or prompt a covered minor to make their privacy settings
2	less protective, unless the change is strictly necessary for the covered minor to
3	access a service or feature they have expressly and unambiguously requested.
4	(b) Timely deletion of account. A covered business shall:
5	(1) provide a prominent, accessible, and responsive tool to allow a
6	covered minor to request the covered minor's account on a social media
7	platform be unpublished or deleted; and
8	(2) honor that request not later than 15 days after a covered business
9	receives the request.
10	§ 2449e. TRANSPARENCY
11	(a) A covered business shall prominently and clearly provide on their
12	website or mobile application:
13	(1) the covered business' privacy information, terms of service, policies,
14	and community standards;
15	(2) the purpose of each algorithmic recommendation system in use by
16	the covered business;
17	(3) inputs used by the algorithmic recommendation system and how
18	each input:
19	(A) is measured or determined;
20	(B) uses the personal data of covered minors;
21	(C) influences the recommendation issued by the system; and

1	(D) is weighed relative to the other inputs reported in this subdivision
2	(3); and
3	(4) descriptions, for every feature of the service that uses the personal
4	data of covered minors, of:
5	(A) the purpose of the service feature;
6	(B) the personal data collected by the service feature;
7	(C) the personal data used by the service feature;
8	(D) how the personal data is used by the service feature;
9	(E) any personal data transferred to or shared with a processor or
10	third party by the service feature, the identity of the processor or third party,
11	and the purpose of the transfer or sharing; and
12	(F) how long the personal data is retained.
13	§ 2449f. PROHIBITED DATA AND DESIGN PRACTICES
14	(a) Data privacy. A covered business shall not:
15	(1) collect, sell, share, or retain any personal data of a covered minor
16	that is not necessary to provide an online service, product, or feature with
17	which the covered minor is actively and knowingly engaged;
18	(2) use previously collected personal data of a covered minor for any
19	purpose other than a purpose for which the personal data was collected, unless
20	necessary to comply with any obligation under this chapter;

1	(3) permit any individual, including a parent or guardian of a covered
2	minor, to monitor the online activity of a covered minor or to track the location
3	of the covered minor without providing a conspicuous signal to the covered
4	minor when the covered minor is being monitored or tracked;
5	(4) use the personal data of a covered minor to select, recommend, or
6	prioritize media for the covered minor, unless the personal data is:
7	(A) the covered minor's express and unambiguous request to receive:
8	(i) media from a specific account, feed, or user, or to receive more
9	or less media from that account, feed, or user;
10	(ii) a specific category of media, such as "cat videos" or "breaking
11	news," or to see more or less of that category of media; or
12	(iii) more or less media with similar characteristics as the media
13	they are currently viewing;
14	(B) user-selected privacy or accessibility settings; or
15	(C) a search query, provided the search query is only used to select
16	and prioritize media in response to the search; or
17	(5) send push notifications to a covered minor between 12:00 midnight
18	and 6:00 a.m.
19	(b) Rulemaking. The Attorney General shall, on or before January 1, 2027,
20	adopt rules pursuant to this subchapter that prohibits data processing or design
21	practices of a covered business that, in the opinion of the Attorney General,

1	lead to compulsive use or subvert or impair user autonomy, decision making,
2	or choice during the use of an online service, product, or feature of the covered
3	business. The Attorney General shall, at least once every two years, review
4	and update these rules as necessary to keep pace with emerging technology.
5	§ 2449g. AGE ASSURANCE PRIVACY
6	(a) Privacy protections for age assurance data. During the process of
7	conducting age assurance, covered businesses and processors shall:
8	(1) only collect personal data of a user that is strictly necessary for age
9	assurance;
10	(2) immediately upon determining whether a user is a covered minor,
11	delete any personal data collected of that user for age assurance, except the
12	determination of the user's age range;
13	(3) not use any personal data of a user collected for age assurance for
14	any other purpose;
15	(4) not combine personal data of a user collected for age assurance,
16	except the determination of the user's age range, with any other personal data
17	of the user;
18	(5) not disclose personal data of a user collected for age assurance to a
19	third party that is not a processor; and
20	(6) implement a review process to allow users to appeal their age
21	determination.

1	(b) Rulemaking.
2	(1) Subject to subdivision (2) of this subsection, the Attorney General
3	shall, on or before January 1, 2027, adopt rules identifying commercially
4	reasonable and technically feasible methods for covered businesses and
5	processors to determine if a user is a covered minor, describing appropriate
6	review processes for users appealing their age designations, and providing any
7	additional privacy protections for age assurance data. The Attorney General
8	shall periodically review and update these rules as necessary to keep pace with
9	emerging technology.
10	(2) In adopting these rules, the Attorney General shall:
11	(A) prioritize user privacy and accessibility over the accuracy of age
12	assurance methods; and
13	(B) consider:
14	(i) the size, financial resources, and technical capabilities of
15	covered businesses and processors;
16	(ii) the costs and effectiveness of available age assurance methods;
17	(iii) the impact of age assurance methods on users' safety, utility,
18	and experience;
19	(iv) whether and to what extent transparency measures would
20	increase consumer trust in an age assurance method; and
21	(v) the efficacy of requiring covered businesses and processors to:

1	(I) use previously collected data to determine user age;
2	(II) adopt interoperable age assurance methods; and
3	(III) provide users with multiple options for age assurance.
4	§ 2449h. ENFORCEMENT
5	(a) A covered business or processor that violates this subchapter or rules
6	adopted pursuant to this subchapter commits an unfair and deceptive act in
7	commerce in violation of section 2453 of this title.
8	(b) The Attorney General shall have the same authority under this
9	subchapter to make rules, conduct civil investigations, bring civil actions,
10	and enter into assurances of discontinuance as provided under chapter 63 of
11	this title.
12	§ 2449i. LIMITATIONS
13	Nothing in this subchapter shall be interpreted or construed to:
14	(1) impose liability in a manner that is inconsistent with 47 U.S.C.
15	<u>§ 230; or</u>
16	(2) prevent or preclude any covered minor from deliberately or
17	independently searching for, or specifically requesting, any media.
18	§ 2449j. RIGHTS AND FREEDOMS OF COVERED MINORS
19	It is the intent of the General Assembly that nothing in this subchapter may
20	be construed to infringe on the existing rights and freedoms of covered minors
21	or be construed to discriminate against the covered minors based on race,

1	ethnicity, sex, disability, sexual orientation, gender identity, gender express	ion,
2	religion, or national origin.	
3	Sec. 2. EFFECTIVE DATES	
4	This act shall take effect on January 1, 2027, except that 9 V.S.A. §	
5	2449f(b) and 9 V.S.A. § 2449g(b) shall each take effect on July 1, 2025.
