

## **State Funding Proposal**

Common Good Vermont 1/31/2025

## **Appropriation Request:**

Common Good Vermont seeks a \$226,470 annual grant from the Vermont general fund. Funds will be invested to provide capacity to nonprofits that have grants and/or contracts through the State of Vermont. These organizations are leading Vermont forward by providing a range of essential and beneficial services including those dedicated to arts, environment, community building, affordable housing and homelessness, youth services, libraries, mental health, childcare, hunger, and others.

Common Good's program will fill a gap in grant and contract support for the sector and create efficiencies for both nonprofits and the State.

Common Good Vermont will provide with State funding:

- Annual training on grant compliance, reporting, and financial management.
- Annual statewide nonprofit conference, including representatives from the Administration and the Legislature, on best practices for partnering with State government.
- Bi-annual <u>survey & report on Vermont nonprofit wages & benefits</u> to support nonprofit employers with recruitment and retention.
- Technical assistance and/or training on fiscal sponsorship, as well as nonprofit mergers and dissolutions, in partnership with the office of the Secretary of State.
- One-on-one coaching for nonprofits on financial management and other organizational health concerns.
- Scholarships to Common Good Vermont educational programming to increase equitable access to learning for employees.

Common Good Vermont has a long track record of providing nonprofits with access to missioncritical resources tailored to the unique needs of the sector. This includes multi-month certificate & cohort programs on nonprofit management and development best practices, workforce development & education reports, technical assistance, information & resource sharing, job and board position posting sites, sector advocacy & issue convening, and sector data. These services are highly valued by the nonprofit community and delivered by a team of three staff members without any public support.

With funding from the State of Vermont, Common Good Vermont will expand our offerings to support emerging sector needs, grow equitable access to programming, and, in partnership with the State, increase the impact of public investments.
