Dear Legislators:

In the first year of this biennium, I presented a two-year capital budget totaling just under \$127 million. Of the capital spending in that proposal, about 87% was supported by bonding, and 13% by interest-free appropriations from the Cash Fund. In this second year, I'm presenting a capital budget adjustment totaling just over \$33 million, of which just 30% is bond-funded, and 70% supported by the Cash Fund.

This reversal illustrates a point I've been making for the last four years—that as we continue to right-size our general obligation borrowing considering our other significant liabilities, we can no longer rely solely on debt to fund our capital needs. Instead, whenever possible, we should fund capital projects up front and save taxpayers the millions of dollars in interest costs that can be incurred over the life of a bond. Fortunately, the statutory Cash Fund transfer is a mechanism to do just that—but for it to work, we have to follow through and fully fund it.

For a number of years, our annual debt service payments have exceeded the amount we're borrowing, which is a dangerous financial strategy. In light of our new capital funding reality, it's more important than ever that we prioritize needs over wants. This capital budget adjustment proposal focuses on maintaining existing critical assets, following through on projects already underway and honoring prior commitments. It funds projects that span the state, and which help to promote public safety, economic development, and environmental quality.

I look forward to working with you on these proposals during this session.

Sec. 8. 24 V.S.A. § 4752 is amended to read:

§ 4752. Definitions

As used in this chapter:

(12) “Disadvantaged municipality” means a municipality or the served area of a municipality that:

(A) has a median household income below the State average median household income as determined by the Secretary and that, after construction of the proposed water supply improvements, will have an annual household user cost greater than one percent of the median household income as determined by the Secretary; or

(B) has a median household income equal to or greater than the State average median household income as determined by the Secretary and that, after construction of the proposed

water supply improvements, will have an annual household user cost greater than 2.5 percent of the median household income as determined by the Secretary; or

(C) meets the criteria as otherwise defined by the Secretary in a duly-adopted Drinking Water State Revolving Loan Fund Intended Use Plan, which may include consideration of household income, user rates, or other socioeconomic indicators, following opportunity for public notice and comment on said criteria; or

(D) serves a majority of users that reside in a nonprofit and resident owned manufactured housing communities registered with the Department of Commerce and Community Development pursuant to 10 V.S.A. § 6254.

Sec. 9. 10 V.S.A. § 1628 is amended to read:

§ 1628. Priorities.

(a) The Department shall make grant awards under this chapter to eligible municipal water pollution abatement and control projects on the basis of need as determined according to a system of priorities adopted by rule by the Department and to the extent appropriate funds are available. The system of priorities shall require consideration of criteria, including:

(b) Notwithstanding any other provision of law, the demonstration requirements of Subchapter 300 of Chapter 2 - Vermont Municipal Pollution Control Priority System Rule shall be met when the municipality making application for funding under this Section certifies that the project shall include service to for new housing units or wastewater capacity shall be reserved for new housing units.
