Working together

- Statutes and Rules set out responsibilities
- DOC and the judicial system intersect in numerous ways every day
- During business hours and "after-hours"
- Both the courts and DOC are open for business 24/7/365



DOC having "custody" of persons (presentence)

- Detention arising from arrests for new charges
- Detention arising from arrests on warrants

After Hours detention

- DOC follows bail/HWOB order
- Persons can be bailed out at the facility
- Holds person until they attend hearing
- Hearing may be remote or in person
- Transports for in person done by sheriff



Remote arraignments

- DOC facilitates remote arraignments (Note: often sheriff transport teams assist at SSCF)
- Facilitation includes contact with legal counsel
- Facilitation does NOT include DOC providing paperwork/having documents signed

Remote arraignments

- DOC facilitates remote arraignment
- Facilitation includes contact with legal counsel
- Facilitation does NOT include DOC providing paperwork/having documents signed
- •DOC releases person if ordered by the court under conditions of release



Post Arraignment

- DOC provides reports for home detention consideration when ordered
- DOC provides supervision under home detention if ordered by court
- DOC provides presentence investigations
- DOC appears at court for sentencing

Post Arraignment

- •DOC is available as a resource to court and parties to provide recommendations or information (i.e. treatment programs, sentence structure, suitability of proposed residences, conditions of supervision etc...)
- •In some counties DOC as a matter of practice has a representative at court for proceedings to serve as a resource



Sentence

- DOC supervises sentenced persons in the community on probation
- •DOC has custody of sentenced persons serving "to serve" sentences in a facility and on furlough
- DOC responsible for programming and treatment decisions

Probationers

- DOC responsible for filing violations of probation with court
- DOC may arrest probationer
- DOC appears at hearings relating to VOP and its disposition



Detained individuals

•DOC facilitates remote proceedings (for certain case types) for the court

Day to Day interactions

- Daily emails from DOC to criminal divisions advising who has been incarcerated and needs to be seen in lodging block as a result of bail, extradition, or arrest warrant
- Court sends Conditions of release, information about whether a lodged defendant is released after arraignment back to DOC



Day to Day interactions

- Court emails DOC through their alias email group to set up Webex hearing for criminal cases and TPR hearings only
- For all other hearing types, court calls DOC on attorney line using provided PIN number and requests defendant be brought to phone to participate in hearing

Day to Day interactions

- DOC sends monthly list of all defendants held on bail
- DOC takes bail payments afterhours and sends receipt and check from their bail account to the court
- Court notifies DOC and provides release order if bail is posted during court hours



Day to Day interactions

- DOC notified of all prisoner cases that are filed, enters appearance if appropriate
- DOC often helps prisoners with forms and legal resources for prisoner cases
- Litigants in some case types (case manager, RFA, some civil) ask the court to participate in hearings by phone often through their case worker

Day to Day interactions

- DOC communicates to courts if interest of justice hearing needs to be set in some cases
- All sentencing paperwork sent electronically to DOC and Probation if probation is ordered
- DOC attends criminal bench bar meetings
- Court sends paperwork to DOC for sentences and other case related information



Day to Day interactions

- Chief Superior Judge (CSJ)and TCO chief meet regularly with DOC representatives along with SA and Def Gen representatives
- CSJ meets with Commissioner and other DOC representatives to discuss issues and solutions to issues which may arise

Day to Day interactions

- DOC provides daily population count reports to Chief Superior Judge and other stakeholders
- DOC provides Judiciary with data and reports when requested
- DOC assists with new judge orientation session and facilitates facility tours for new judges
