
## **State Afterschool Grant FY24**

- •Designed in alignment with state 21C competition
- •Allowed funding for new programs and expanded programs
- •Established three competitive priorities:
  - 1. Utilizing partnerships
  - 2. Serving historically underserved communities
  - 3. Improving access for students from historically marginalized groups
- •Single application stream for Program and Center

# Act 78 – First Award Cohort



- •17 awards to 16 unique entities
  - 9 Schools and 7 Community-Based Orgs
- •\$3.7 Million committed for three-year awards
- •Sites located in 11 counties
- •73 named partner organizations across all awards
- •New or expanded services for ~4,000 young Vermonters



# **Capacity Building & Design Changes**

Two additional classified employees were hired at AOE


- One to support additional grant monitoring and oversight
- One to support additional data collection and analysis

For second competition round, changes were made to the grant design


- Program and Center tracks were split into separate applications
- Program award cap was increased to \$75k
- Program award start was pushed up to January to support immediate implementation
- Center award duration was increased to five years



# Act 78 – Second Award Cohort



- •26 awards to 21 unique entities
  - 14 Schools and 7 Community-Based Orgs
- •\$13 Million committed for three- and five-year awards
- •\$1.7 Million dedicated to bringing first cohort awardees into spec with new competition standards
- •Sites located in 11 counties
- 147 named partner organizations across all awards
- New or expanded services for ~7,000 young Vermonters





# **Plans for the Next Six Months**

### Two additional classified employees will be hired at AOE

- One to support regulatory compliance for Community-Based Organizations
- One to support monitoring and oversight of new grant programs

### **Technical Support Grant**

- Identifying potential providers in afterschool deserts and building networks
- Supporting enhanced community of practice
- Improving professional training opportunities to afterschool providers

### **Program and Center Track Grants**

• Continued expansion into underserved areas

### **Regional Provider Grant**

- Build a network of entities with specialized content expertise
- Facilitate connections between content experts and multiple service delivery sites
- Enhancing quality and variety of afterschool programming
