5	(a) In order to carry out Vermont's policy that all Vermont children will be afforded
6	educational opportunities that are substantially equal in quality, each Vermont public

10	(9) The school complies with average class size minimum standards; provided
11	however, that because class size minimums apply to content areas, an individual class
12	may be smaller than the minimum average. As used in this subdivision, "content area"
13	means a group of courses within a specific licensing endorsement area.
14	(A) Class size standards.
15	(i) The average class size minimum for kindergarten classes in all content
16	areas shall be 12 students.
17	(ii) The average class size minimum for grades one through four in all
18	content areas shall be 15 students.
19	(iii) The average class size minimum for grades five through eight in all
20	content areas shall be 18 students.
21	(iv) The average class size minimum for grades nine through 12 in all
22	content areas shall be 20 students.

1	(v) Multiage classrooms for grades kindergarten through eight shall be
2	limited to two grade levels per classroom.
3	(vi) Classes providing career technical education, special education,
4	academic support, flexible pathways, services to English learners, and driver's education
5	shall be excluded from the class size minimum requirements in this subdivision.
6	(B) Waivers. If a school board determines that it operates a school that is
7	unable to comply with the class size minimum standards due to geographic isolation, the
8	school board may ask the State Board of Education to grant it waiver from this
9	subdivision (9). The State Board shall define what qualifies as geographic isolation in its
10	rules adopted pursuant to subdivision (a)(3) of this section. The State Board's decision
11	shall be final.
12	(C) State Board action. If the Secretary determines that a school is not meeting
13	the class size minimum standards set forth in this subdivision (9) over the course of two
14	consecutive school years, the Secretary shall recommend to the State Board one or more
15	of the actions listed in subsection (b) of this section, regardless of whether the school is
16	meeting all other education quality standards. The State Board shall then follow the
17	procedure of subsection (c) of this section.
18	(b) Annually, the Secretary shall determine whether students in each Vermont public
19	school are provided educational opportunities substantially equal to those provided in
20	other public schools. If the Secretary determines that a school is not meeting the
21	education quality standards listed in subsection (a) of this section or that the school is
22	making insufficient progress in improving student performance in relation to the
23	standards for student performance set forth in subdivision 164(9) of this title, he or she

FAILURE TO COMPLY WITH EDUCATION QUALITY STANDARDS; 20 STATE BOARD ACTION 21 Notwithstanding 16 V.S.A. § 165(b)(4) and (5) and any other provision of law to the 22 contrary, the State Board shall be prohibited from ordering school district consolidation 23 or school consolidation if a school fails to comply with class size minimum education
